

ALAMEDA CREEK WATERSHED PUBLIC ART PROJECT QUALIFICATION AND SELECTION PANEL ONE SUMMARY

QUALIFICATION PANEL MEETING DATE:

January 29, 2013

PROCESS:

Round One:

The Panel reviewed a total of 214 submissions from artists that responded to the Alameda Creek Watershed Public Art Project Request for Qualifications (posted December 2, 2013 – February 25, 2014). "Yes/No" majority votes based on three criteria of Artistic Excellence, Appropriate to Project Goals, and Professional Experience yielded 28 artists to move to Round Two.

Round Two:

The Panel reviewed the submissions of the 28 artists and voted "Yes/No" based on three criteria of Artistic Excellence, Appropriate to Project Goals and Professional Experience.

RESULTS:

Round two voting yielded 17 artists to present to the Alameda Creek Watershed Public Art Selection Panel.

PROCESS:

Arts Commission staff presented the qualifications of 17 artists selected by the Qualification Panel. The Artist Selection Panel scored each artist on the following criteria (1= low score):

- Artistic Excellence (1-10)
- Appropriate to Project Goals (1-10)

Round One voting yielded nine semi-finalists. The Panel discussed the qualifications of the semi-finalists and ranked each in order of preference from one to nine (1=high score). Round Two voting yielded three finalists and one alternate to recommend to the Arts Commission to make proposals for the art opportunity.

RESULTS:

The following artists received the four highest ranks:

Adam Kuby	30
