PROCESS

On January 23, 2013, the panel reviewed the submissions of 221 artists that responded to the San Francisco International Airport Sculpture Opportunity Request for Qualifications (posted October 18, 2013 – January 13, 2014).

Round One "Yes/No" majority votes based on the criteria of Artistic Excellence and Appropriate to Project Goals yielded 22 artists to advance to Round Two. The panel discussed the 19 artists and felt that 4 were viable candidates for the Selection Panel to consider:

Linda Flemming Brian Goggin Gay Outlaw Ursula von Rydingsvard

Because the shortlist included a limited number of artists, the panel decided to reissue the RFQ to allow additional artists to apply. The RFQ was reopened from February 11 – 25, 2014.

On February 26, 2014 the panel reconvened and reviewed an additional 35 artists' submissions. "Yes/No" majority votes based on the criteria of Artistic Excellence and Appropriate to Project Goals yielded 10 artists to advance to a short list to be considered by the Selection Panel:

PROCESS

The panel evaluated the work of 14 artists selected by the Qualification Panel using the following criteria and numeric scoring system (1=low score):

- Artistic Excellence (1-10)
- Appropriate to Site (1-10)

RESULTS

The following two artists received the highest scores:

Ursula von Rydingsvard	58
Yayoi Kusama	53
Rachel Feinstein	45

The panel recommended a new sculpture commission by Ursula von Rydingsvard for SFO Terminal 3. Should she be unable to complete a new commission, the panel recommended Rachel Feinstein as an alternate. Additionally, they recommended the purchase of Yayoi Kusama's artwork *High Heels for Going to Heaven* for SFO Terminal 1.
