Mr. Lessig,

My colleague Jennifer Crane forwarded me your email below.

Your assertion that alcove featuring a "portrait of your brother" is a stand-alone mural is incorrect. *Animal Force and Machine Force* is the title for the 10 ft. by 36 ft. mural that spans the length of the main wall that faces visitors as they enter the tower. As you can see from the attached image, the artist integrated the alcove into the larger mural design. It was common practice among the WPA muralists (and we see examples in other projects) to integrate architectural elements into their overall scheme. Here, Ray Boynton paints the alcove as a rocky niche just off of a stream and near a field being prepared for seed. A laborer stands next to the niche with a shovel removing the rocks. The Daughters of the American Revolution bronze plaque in the niche was placed before the mural painting commenced, and the artist composed his work around it.

We plan to share the information above as part of our presentation at Wednesday's meeting.
