# San Francisco International Airport Administrative Building Complex



### BACKGROUND Project Overview:

SFO's Consolidated Administration Campus Master Plan includes 2 administration office buildings, 2 structured parking garages, connections to the Air Train Station and a new landscaped central green and landscaped entry area. The campus will provide for approximately 575 airport staff. Access to the site by the general public will be very limited as the complex primarily services Airport internal operations. The project is planned to be constructed in two phases.

#### **ART OPPORTUNITIES**

The primary art locations for the Administration Complex are as follows:

- a. The central green area between the two administration buildings
- b. The lobby and other major public spaces of Administration Buildings
- c. The gateway plaza at the intersection of McDonnell Rd. and West Field Road

Other potential locations include:

- a. The central green campus walk
- b. The campus parking structure façade (South)
- c. Glass façade of Air train walkways and/or Admin Bldg. 2

The art plan will be refined as design on the complex progresses.

#### **PROJECT GOAL**
