- 2) Your display did not allow for a proper pedestrian passageway (Ord. 41-83, Section 2405(c)16). By law, your display must allow an 8-foot pedestrian passageway.)



3) Selling items not of your own creation: commercially manufactured silver pendants on ear-wire. (Please see attached Inspector's Report).

## INSPECTOR' S LOGBOOK TUESDAY, JANUARY 30, 2014 3:20 – 3:35 p.m. Market Street at Drumm Street

3:20 p.m., Market Street at Drumm Street: Intermittent sun; cold. Acting on a complaint received by the Controller's Whistleblower unit, I went to this location to see whether street artist Daniel Hennessey had been set up in an illegal location yesterday as depicted in photos we had received.

I found his display (he was not present) in the location depicted in the photos. His certificate card was on display as well as his silver jewelry. Ironically, the display was in one of the 8 locations (rimming the BART railing) I had obtained for the artists by Board of Supervisors resolution many years ago; however, because the City had installed newsracks in the locations, I had approved their relocation, at the request of the artists, to an area eastward, near Spear Street, and that is the area which has been used by the artists in recent years.

While Mr. Hennessey's table display was in the former location of the 8 legal spaces, his table was in violation of the regulation which mandates that an artist's display allow an 8-foot pedestrian passageway; his display allowed only 7 feet by virtue of the temporary barrier which had been placed across from his display by the Water Department's sewer replacement project.

I left my business card and a note attached to the duct tape he had on his table. My note told him to not set up there anymore because of his inability to comply with the passageway regulation and to sell in the area of Market Street between Spear and Steuart streets.

In my investigation of his displayed silver jewelry I found 14 pairs of earrings he did not make: commercially manufactured silver pendants on ear-wire.

<u>Conclusion</u>: A written warning is in order for his violating (1) the 8-foot pedestrian passageway regulation; and (2) selling items not of his own creation.

Footnote to this request: merely 20 feet away from Hennessey's display was a 10-foot table display of commercially manufactured jewelry, wallets, and crochet hats and scarves being sold by an unlicensed male vendor.
