The Director of Public Works held a Public Hearing on Monday, June 23, 2014 commencing at 5:30 PM at City Hall, Room 416, 1 Dr. Carlton B. Goodlett Place, San Francisco, CA 94102. The hearing was to consider Order No. 182,680 to consider the removal with replacement of one (1) DPW maintained street tree adjacent to 5525 Diamond Heights Blvd.

Findings:

- DPW Urban Forestry staff initiated the removal of one (1) DPW maintained New Zealand Christmas tree (*Metrosideros excelsus*) after reviewing the tree and site conditions and after reviewing the maintenance history of the tree.
- Urban Forestry staff testified that the tree is located near the front entrance to the property owner's house and that it did take the Department several years to address sidewalk damage that had been caused by the roots of the tree. The tree has good overall vigor with fair structure, but the main trunk of the tree has a pronounced lean that blocks the pathway to the entrance of the house and public right-of-way. Urban Forestry staff testified that the public safety concern is that someone might bump their head, not that the tree itself might experience a root failure.
- The property owner testified at the hearing that she has called DPW staff directly and placed requests into the 3-1-1 call center for sidewalk repair and tree canopy pruning requests over the years. The property owner is concerned that when the tree roots damage the sidewalk again, what will happen if the repairs take a long time to be made again -- that the tree is located at the front entrance to her home.
- A total of two written letters protesting against the removal were received, including a letter on behalf of the Diamond Heights Community Association Board and one letter included an arborist report also against the removal of the tree.
- At the hearing the President of the Diamond Heights Community Association testified against the removal of the tree and pointed out that the sidewalk repairs have been made and one of the reasons for the removal was erroneous that the sidewalk repairs will not destabilize the tree.

My name is Lily Louie and I am an 80 year-old widow. In the past two years I have suffered from a major stroke and a hip fracture. I also have hypertension and I am afraid worrying about the tree in front of my house, may cause me to have another stroke.

I have repaired my sidewalk many times because the roots of my tree and my neighbor's tree erupted through the sidewalk. The city said it was our responsibility to repair the damage caused by the trees.

The last time it needed repairing, I protested and the city finally repaired it after two years. The sidewalk was a major hazard to pedestrians and my neighbor was afraid he was going to be sued.

In addition to this tree having very evasive roots which could also cause damage to the pipes under the sidewalk, I am afraid, in my condition that I cannot keep up with cleaning up the leaves that this tree deposits. I would suffer a serious fall trying to sweep them up. Plus the tree is getting so tall that the leaves are getting into the gutter.

Also, the tree is leaning so much in one direction, and the wind is so strong on Diamond Heights Boulevard, it could cause it to fall over.

In the past four years, two such cases have been reported. One in Laguna Honda killing a person. The other one was on Brotherhood Way near Lake Merced where a woman was killed by a perfectly healthy tree falling on her car as she was driving. The weather was perfectly normal.

I have been having bad luck because the tree is leaning in the direction of my front door.

the median in the middle of the boulevard which probably cost more money than the tree. The replanting took 5 days and over 5 workers to complete. These new plants didn't grow so they had to redo the whole project. In addition, the original plants had been growing quite well which meant that the project had been not been necessary.

I had tried to get this tree removed before and won my case. One of my neighbors protested and threatened me saying he would make sure I get fined if I cut down the tree without permission and filed a formal protest. Even though he is the nephew of the way unsuccessful in getting the other neighbors to back him up. I think this is the first time anyone has ever protested the removal of a tree in Diamond Heights.

Lastly, I frequently ride a paratransit bus which picks me up right in front of my home. The leaning of this tree could cause damage to the bus which is taller than the average car.

A few months ago a large branch fell from my neighbors tree due to high winds in the area. Luckily it was at night and no one was hurt. The exact same thing happened to a tree across the street.

Respondent's Brief

Urban Forestry staff had received calls form the property owner of 5525 Diamond Heights Blvd. regarding the sidewalk damage caused by the roots of the DPW-maintained New Zealand Christmas tree (*Metrosideros excelsus*) adjacent to her property. The sidewalk repairs were completed in early 2013.

However, the proeprty owner was still concerned about the condition of the tree and if the roots of the tree damaged the sidewalk again, she was concerned that it would take Public Works a long time to repair the sidewalk. The tree is located near the pathway to the entrance of her home.

The tree has a lean over the sidewalk, parallel with the direction of the curb, not into the primary pedestrian through-zone. The property owner expressed concern that someone could hit their head when entering or exiting a car or when walking near the car to pass between the street and sidewalk. The property owner was also concerned that the lean of the tree could mean that the tree was unsafe and might fall over.

Urban Forestry staff assessing the tree and site conditions were sympathetic to the property owner's concerns because it had taken the Department a couple of years to make the sidewalk repairs. While the lean of the tree was not a public safety issue and the sidewalk repairs had been made, staff also felt that having a lean to the tree, directly opposite the entrance to the home, could present some potential safety issues with people walking by the tree between the sidewalk and the street. The current width of the pedestrian throughzone is 36".



Urban Forestry staff initiated the removal of the tree and posted the required 30-day removal notices on the tree and nearby utility poles from April 9, 2014 through May 8, 2014.

Two written letters protesting the removal of the tree were received and the proposed removal was heard at the departmental Tree Hearing on June 23, 2014.

Public Works Order No. 182887 denies the removal of the tree. While Urban Forestry staff are understandably sympathetic to the concerns of the property owner, the tree is not in danger of falling and the sidewalk repairs have been made.

A copy of the supplemental arborist report that was provided by the neighbor confirms our assessment that although the tree has a slight lean, this lean occurred years ago when the tree was young and does not pose a public safety concern.

If the roots of the tree cause damage to the sidewalk again, the property owner has our commitment to make the repairs in a time sensitive manner. Public Works now has a sidewalk repair program called the Accelerated Sidewalk Abatement Program, or A.S.A.P., which allows us to refer high priority sidewalk repairs to a private contractor for immediate repair.

The Department asks that the Board of Appeals uphold Order No. 182887, which denies the request by Urban Forestry staff to remove the

This letter is regarding the New Zealand Christmas tree located in a sidewalk tree basin at 5525 Diamond Heights Blvd. The tree is currently posted with a 30 day tree removal notice. According to the notice, the Bureau of Urban Forestry staff has determined that the tree requires root pruning that would destabilize the tree and that it possesses a lean. This letter will assess the health and safety of the tree and provide a response to both of the items listed on the notice.

The tree is 25-30 feet tall with a trunk diameter at breast height (DBH) of approximately 9 inches. The tree does not possess any indications of decay or weakness in the trunk. The canopy demonstrates healthy new growth. Due to the tree's history as a city-maintained street tree, it has no low structural or scaffold branches that would obstruct the roadway. There are 2-3 pendulous branches that overhang the roadway, but they can be corrected through maintenance pruning.

The tree is leaning uphill to a degree, but the tree has corrected the lean and is growing upright. The lean was likely caused by some kind of event in the tree's history, at least 10 years ago based on the amount of upright growth since then. The lean does not cause the tree to enter the roadway nor the driveway. Over time, it will not worsen or become a future obstruction because of the direction of the lean. By itself, a lean does not indicate instability, particularly a slight lean such as this one and the fact that the canopy has balanced out very well since whatever event caused it to lean. If the lean were coupled with decay or a grossly unbalanced canopy, it could become a concern, but neither of those factors exists in conjunction with the lean.

With regard to the potential root pruning, there is no indication that sidewalk repair is needed because of the recent (approximately 1 year ago) sidewalk repair and accompanying root pruning. Since then, the tree has maintained and put on new growth. The past root pruning's impact on the tree was negligible and with no future root pruning on the horizon, it's unclear why that would be a factor in a tree removal permit. Normally, the tree inspectors will require a very clear demonstration of what roots would be removed (either because of large surface roots or by removing concrete to show the roots to be pruned) to make a case for destabilizing a tree by root pruning. In this case, there are no roots to be pruned at all.

Considering the only slight lean of the tree that is not blocking a driveway and not blocking a roadway and considering the lack of any concrete repair and accompanying root pruning, this tree is not a candidate for removal. While a large enough truck could knock the tree over and while a branch may snap off in a windstorm, those are possibilities that could be applied to any tree in the city and do not justify classifying the tree as one qualified for a tree removal permit.

Re: Appeal #14-157, letter in support of retaining tree at 5525 Diamond Heights Blvd.

My name is Paul Matalucci, and I'm a 22-year resident of San Francisco and a 10-year resident of Diamond Heights. I serve as a volunteer steward for the Diamond Heights Blvd. median from Duncan St. to Berkeley Way. Together with neighbors and local businesses, I launched a community effort called The Diamond Heights Blvd. Median Project, which has cultivated a foundation of support both within and adjacent to Diamond Heights.

I'm moved today to join a group of concerned residents and express my desire to prevent the needless removal of a tree along Diamond Heights Blvd. that's directly connected to our median project. The tree is one of an attractive line of mature New Zealand Christmas Trees (*Metrosideros excelsa*) that run parallel to the median islands included in our project.

To complete Phase I of our project, which fronts Ms. Louie's address, neighbors removed root-bound *agapanthus* and weeds, amended and mulched the soil, and installed new drought-tolerant plants with gopher-proof root cages. The effort required more than 200 volunteer hours over three weekends.

Working closely with DPW, the SF Parks Alliance, and Friends of the Urban Forest, we are developing a landscaping plan for the median islands that envisions the neighborhood's appearance for several decades to come.

Tree selection is a vital part of our plan. The current Monterey Pines were chosen by the original city planners because they're fast-growing, and windbreaks were urgently needed. The downside, however, is that Monterey Pines have a short life expectancy. Planted when Diamond Heights was developed in the 60s, many will soon to perish and require removal.

For that reason, it's of utmost urgency that we retain the established trees that are currently healthy, including the New Zealand Christmas Tree that Ms. Louie wishes to cut down. CalPoly's Urban Forest Ecosystems Institute states the life expectancy of *Metrosideros excelsa* to be "50 to 150 years."*

I'm proud of my neighborhood and the teamwork of our volunteers. I would be extremely disappointed to see our boulevard lose the aesthetic appeal of a uniform row of mature trees, which are enjoyed by visitors and residents alike.

The DHCA Board filed an appeal when the Bureau of Urban Forestry recommended removal of the tree. Our 25 page brief helped convince the BUF to reverse its decision to remove the tree so that the appeals hearing was not necessary. Attachments to this letter include an arborist report on the health of the tree, photos of the tree and support letters from neighbors written for the prior brief who appreciate seeing this lovely tree that adds to the attractive appearance of our neighborhood.

A summary of reasons to retain the tree are:

- The appellant's fear that the tree will fall is unfounded. Both DPW and an arborist have found the tree to be healthy. DPW pruned the tree roots and replaced the sidewalk approximately a year ago so that any root damage to the sidewalk is unlikely for a long time. The concerns about leaves and that the tree may be bad luck does not warrant removing a healthy tree.
- Replacing the tree with a 24" box size replacement tree would disrupt the beauty of the current row of mature trees.
- With limited funds to care for City trees, it does not seem appropriate for DPW to spend tax payers' funds on removing a healthy tree.

Thank you for consideration of the materials presented to you and the Board of Appeals. We urge you to vote for saving a healthy, beautiful tree.

This letter is regarding the New Zealand Christmas the located in a sidewalk tree basin at 5525 Diamond Heights Blvd. The tree is currently posted with a 30 day tree randowal police. According to the notice, the Bureau of Urban Forestry staff has determined that the tree requires rook pruning that would destabling the tree and that it possesses a lean. This letter will assess the health and safety of the tree and provide a response to both of the items listed on the notice.

The tree is 25-30 feet fall with a trank diameter at breast height (DBH) of approximately 9 inches. The tree does not possess any indications of decay or weakness in the trunk. The canopy demonstrates hearthy new growth. Due to the tree's history as a city-maintained struct Irea, it has no low structural or scatfold granches that would obstruct the roadway. There are 2-3 pendulous branches that overhang the roadway, but they can be corrected through maintained pruning

The tree is learning uptill to a degree, but the tree has corrected the lean and is growing upright. The lean was Fixely caused by some kind of event in the tree's history, at least 10 years ago based on the amount of upright. The lean was Fixely caused does not cause the free to enter the roadway nor the driveway. Over time, it will not worsen or become a huture obstruction because of the direction of the team. By itself, a 'can does not indicate instability, particularly a sight lean such as this one and the fact that the canopy hes belanced out very well since whatever event caused is to san. If the isen were coupled with decay or a grossly unbelanced canopy, it could become a concern, but neither of those factors exists in conjunction with the lean.

With regard to the potential root pruning, there is no indication that sidewalk repair is needed because of the recent (approximately 1 year ago) sidewalk repair and accompanying root oruging. Since then, the free has maintained and put or new growth. The past root pruning's impact on the tree was negligible and with no future root pruning on the horizon, it's unclear why that would be a factor to a tree removal permit. Normally, the tree unspectors will require a very orear demonstration of what roots would be removed (ether because of large surface roots or by removing concrete to show the roots to be pruned) to make a case for destabilizing a tree by root pruning. In this case, there are no roots to be pruned at an.

Considering the only slight lean of the tree that is not blocking a driveway and not blocking a roadway and considering the lack of any concrete repair and accompanying root pruning, this tree is not a candidate for removal. While a large enough truck could knock the tree over and while a branch may anap off in a windstorm, those are possibilities that could be applied to any tree in the city and do not justify classifying the tree as one qualified for a tree removal permit.

Background

The Diamond Heights Community Association Board filed Appeal #14-137 to request that the Board overturn DPW's decision to cut down the New England Christmas tree, a City owned and maintained tree, in the sidewalk in front of 5525 Diamond Heights Blvd. The home owner who lives at this address has called the Bureau of Urban Forestry DPW many times to request that the tree be removed because she is afraid the tree will fall on her since it leans. A notice to remove the tree was posted and a hearing held on June 23. Betsy Eddy, President of the DHCA spoke in support of saving the tree at the hearing. After the hearing, DPW issued a decision that the tree will be cut down because the tree leans and someone might bump his or her head on it. To people who have visited the tree, it seems unlikely that anyone would hit his or her head on the tree. The DHCA Board is protesting the removal of a healthy, beautiful tree.

The DHCA Board has supported the removal of trees found to be diseased and of danger to the public as certified by licensed arborists. According to the DPW hearing decision report, "the tree has good overall vigor with fair structure."

Justifications to Retain the Tree

- In DPW Order No: 182754, DPW Urban Forestry staff indicated that "the tree has good overall vigor with fair structure." The DHCA protests the removal of a healthy tree. Nicholas Crawford, ISA Board Certified Master Arborist from the Davey Tree Expert Company hired by a neighbor, stated in a lengthy and thorough report dated April 18, 2014 that the tree "is not a candidate for removal," has put on new growth since the roots were pruned, and "the tree has corrected the lean and is growing upright."
- The public notice attached to the tree states that a reason for removal is, "Root pruning required to fix sidewalk will destabilize tree." Tree roots were pruned a year ago and new sidewalk was placed around the base of the tree by DPW. The certified arborist, Nicholas Crawford, indicated in his report that there is no indication that root pruning is needed. Mr. Crawford stated that "in this case, there are no roots to be pruned at all" visible above ground. Please see the Davey Tree Report in the brief exhibits.

- The reason indicated by DPW for removal was that "the main trunk of the tree has a pronounced lean that blocks the pathway to the entrance of the house and the public right-of-way." "Urban Forestry staff testified that the public safety concern is that someone might bump their head, not that the tree itself might experience a root failure." The tree does not lean over the path of travel for people walking on the sidewalk. Nor does the tree block the pathway to the entrance to the house any more than any other tree planted near a front door. The lean of the tree is uphill parallel with the street where people would not generally walk. A person stepping from the street toward the lean of the tree would be unlikely to hit his or her head. Please see photos of the tree.
- Replacing the tree with a 24" box size replacement tree of 8 15 feet would disrupt the beauty of the current row of mature trees that are approximately 30 feet tall.
- Removing a healthy tree and its roots and purchasing and planting a replacement tree is an unnecessary expense for tax payers.
- Many sidewalk trees on Diamond Height Blvd and in the City lean. In the block of Diamond Heights Blvd. from Gold Mine Drive to Diamond Street, 8 of the 10 trees on the West side of the street lean.
- The reasons that the owner of the home at 5525 Diamond Heights Blvd wants the tree removed do not constitute justification to remove a healthy tree. The owner of the home has lived at the address for 43 years. A tree has been present in the sidewalk for most of those years. The current tree


is at least 22 years old. It was replaced by the City when a car hit the tree approximately 22 years ago.


The owner of the home called the DHCA to learn why the Association wants to save the tree. An amicable phone conversation took place on August 6, 2014 between the owner of the home and Betsy Eddy, President of the DHCA. The owner indicated that she called DPW many times to request that the tree be removed for the following reasons:

- The home owner is afraid the wind will cause the tree to fall on her.
- The home owner wants a less invasive tree that will not disrupt the sidewalk with root growth.
- The home owner says she cannot sweep the leaves from the front of her home nor can she remove the leaves in the home gutters.

The owner's fear that the tree will fall on her is unfounded. Both DPW and an arborist have found the tree to be healthy. DPW pruned the tree roots and replaced the sidewalk approximately a year ago so that any root damage to the sidewalk is unlikely for a long time. The concern about leaves does not warrant removing the tree. The DPW's decision to remove the tree includes the replacement of the tree with a tree of the same species. The owner will still have leaves that fall from the new tree.

This tree is the second in a row of six beautiful New Zealand Christmas trees along our street. And, its within a couple of feet of my property line. It does (can slightly, but (have had it's good health and stability certified in writing (attached) by Duvy the Tree Experts. And, I am sure the City's agronomists would have concurred with this had they been able to spond the time to more fully check out this tree's condition among the many others in their care.

All these trees (I'd guess some are 40 years ald) were originally selected, planted, and (occasionally) trimmed and watered by the City. However, after these many years, their stabilizing spread root structure, growing just beneath the sidewalk, did uplift some walkway sections dangerously. As a result, the City finally primed all the offending roots and replaced the damaged sidewalk sections all along the street.

But, the City condemned only one of the six trees - that at 5525. If believe this came about as a consequence of my neighbor's several requests to get her badly heaved sidewalk, blocking the entrance to her home, repaired. And, the person that issued the removal order #14-137 is unaware that it should be revoked since the conditions prompting it have since been corrected or are of no import.

The "Findings" of the June 23 Public Hearing at City Hall declared that the tree blocks the pathway to the entrance of the house and the public-right-of-way" as well as that the public could "bump their head on the tree". These statements are quite a stratch of reasoning since all the homes have short double-wide driveway ramps ending at the sidewalk to allow access to each home's two-our side-by-side garage. Any reasoning person, entering or exiting the roadway, would do so via these driveways where thera is nothing to impede them.

In summary. This row of trees and is mature and beautiful. Their roots have been pruned and the sidewalk replaced. Cutting down this tree and replacing it would leave a jarring interruption to this currently unbroken row of lovely evergreen trees and most particularly, if a spindly young sopling of the same or another species were to be put in its place

Mv name is Scott Stawicki and I live at 2510 Diamond St. I am an active member of both the Diamond Heights and Glen Park communities in which I live. I am responding to the DPW notification of the removal of the New England Christmas Tree at 5525 Diamond Heights B lvd. I walk past this tree every day, and am outraged that DPW has decided to cut down this healthy tree. I firmly support Appeal number 74-137 from the Diamond Heights Community Association and would petition the DPW to reject the request to kill this tree.

There is no reason that I can understand that merits the removal of this city & community owned tree. The DPW Urban Forestry staff has indicated in their report (No. 182754) that " the tree has good overall vigor with fair structure " - ie. It is a healthy tree. An independent arborist from the Davey Tree Company has also confirmed the good health of this tree, and that it is growing upright. This tree is an asset to the community, - one which the city and neighbors have invested in for the last 2 decades - why would we decide to throw this tree away?

The complaint that calls for the removal of the tree is without clear merit. The tree does have a slight lean. ALMOST EVERY TREE GROWING ON DIAMOND HEIGHTS HAS SOME LEAN CAUSED BY THE VIGOR OF THE WIND IN OUR NEIGHBORHOOD.
