Dear Board of Appeals,

It is my intention to request respectfully a hearing before you to review and reverse the Zoning Administrator's unfavorable Letter of Determination regarding the medical cannabis dispensary permitting of Divinity Tree Patients' Wellness Coop (myself, co founder & currently chairman) at 958 Geary.

In March 2014, the Divinity Tree was informed by Planning that an 18 month closure period constituted permit "abandonment." In June 2014, Divinity Tree requested a Letter of Determination from the Zoning Administrator, who replied a full 9 weeks later August 11, 2014.

Briefly, several reasons for our permit reinstatement:

- 18 month closure = "abandonment," never mentioned by SF DPH, Planning
- Planning, SF DPH different closure dates (May 2012, December 2012)
- Reopening efforts February 2013, September 2013 continuing
- Provided patient services (medicine and cultivation) after ending delivery service
- 958 Geary vacancy maintained by building owner for Divinity Tree return
- SF DPH medical cannabis dispensary permitting body never revoked permit
- Special circumstances of closure US Atty landlord threats, fines, forfeiture, imprisonment.

In conclusion, as Divinity Tree chairman, I speak for myself, our Board of Directors, and Coop member patients protesting the lack of permit considerations from the Planning Dept., the absence of attention, acknowledgment, and answers addressing our reasons above, from the Zoning Administrator. His "clear and unambiguous" excuse for "permitting ineligibility" is the 1000ft proximity of 958 Geary to an elementary school, whose proximity had been allowed because of Divinity Tree beginning operating before April 2005. We hope the Board of Appeals will reconsider this narrow reasoning and vote to allow the Divinity Tree to serve our patients, neighborhood, City, and all other qualified patients.

This letter is in response to your request for a Letter of Determination regarding the property at 958 Geary Street. This parcel is located in the RC-4 (Residential-Commercial, High Density) Zoning District, North of Market Residential Special Use District, Lower Polk Alcohol Restricted Use District, Fringe Financial Services Restricted Use District, and 80-T Height and Bulk District. The request is whether a Medical Cannabis Dispensary ("MCD") may be re-established at the retail space located at 958 Geary Street ("subject property").

According to your request letter and the supporting documentation provided, Divinity Tree began operating at the subject property in March 2005. In November 2005, the Board of Supervisors adopted legislation which established the regulations and permitting process associated with MCDs, including amendments to the Planning Code. These regulations drew an important distinction between those MCDs which had been operating prior to April 1, 2005 versus those MCDs which sought to begin operation after April 1, 2005. MCDs which began operating prior to that date could seek formal approvals to continue operating in that location even if they were within 1,000 feet of a school or recreation building that primarily services persons under 18 years of age. MCDs which commenced operations after this date would not be able to operate within 1,000 feet of a school or recreation building that primarily services persons under 18 years of age.

The subject property is located within 1,000 feet of Redding Elementary School, at the southwest corner of Pine and Larkin Streets. Because Divinity Tree began operating prior to April 1, 2005, it was eligible to receive approvals to continue operating within 1,000 feet of the school. In October 2007, the Planning Commission approved the continued operation of Divinity Tree at the subject property through the Mandatory Discretionary Review process (Case No. 2007.0657D).

As described in your request letter and supporting documentation, in 2011, the U.S. Department of Justice issued letters to landlords which leased commercial space to MCDs. These letters describe that MCDs are

operating in violation of federal law, which makes no provision for use or sale of cannabis for medical purposes, even if such use is allowed by state law. These letters indicate that the landlords could be subject to criminal prosecution, with penalties that may include imprisonment and asset forfeiture, including seizure of the property where the MCD operates. Your supporting documentation includes such a letter issued to Paul Huang and Charles Huang (owners of the subject property) from Melinda Haig (U.S. Attorney in the Northern District of California, dated September 28, 2011).

Your letter indicates that, in response to the threats of prosecution, the storefront operations of Divinity Tree ceased in November 2011, and that the business shifted to a delivery-service format. Your letter further indicates that the delivery service ceased and that the lease for the space at 958 Geary Street was formally terminated in May 2012.

Planning Code Section 209.3(f) addresses the issues of abandonment of an MCD, stating:

"(f) If an MCD closes for a duration longer than 18 months <u>or</u> if the MCD's license is revoked by DPH pursuant to Health Code Section 3315, the MCD will be considered abandoned and any Planning Commission authorization for the parcel shall be null and void." [emphasis added]

More than 18 months have lapsed since Divinity Tree ceased storefront operations and the subsequent delivery service at 958 Geary Street. Therefore, the MCD use at this location is considered abandoned, and the previously-granted approvals by the Planning Commission are no longer valid. Your letter indicates that the Department of Public Health (DPH) never formally revoked the operating permit for Divinity Tree. However, regardless of the status of the DPH permit for the business, the Planning Code language cited above considers the MCD to be abandoned if the MCD is closed for longer than 18 months. Furthermore, the subject property is ineligible for new approvals to operate an MCD because it is located within 1,000 feet of Redding Elementary School.

The Planning Department acknowledges that Divinity Tree acted in good faith in obtaining necessary approvals from the various agencies within the City and County of San Francisco, and operated in good standing by complying with the conditions of these approvals. The Planning Department also recognizes the significant difficulties posed by the threat of Federal prosecution (which persisted from 2011 through 2013), as well as your efforts in collaborating with the Planning Department, the Department of Public Health, and Supervisor Kim's office in seeking to reestablish the business at the subject property. However, the cited Planning Code language regarding the abandonment of the MCD use, as well as the prohibition against the approval of new MCDs within 1,000 feet of schools, is clear and unambiguous. Pursuant these regulations, Divinity Tree's operations at 958 Geary Street are considered abandoned, and may not be reestablished at this location.

Dear Board of Appeals,

As co-founder (2005), currently chairman, Divinity Tree Patients' Wellness Coop, I respectfully request the Board of Appeals to review Zoning Administrator Scott Sanchez' unfavorable Letter of Determination decision, and to judge the facts and find the reasoning to grant discretion, re-permitting the Divinity Tree. Because the circumstances of this appeal differ from normal Planning Department land use issues, I will attempt to present the case for permit reinstatement clearly and concisely with consideration for the Board's time and busy schedule.

See below facts and reasoning for Divinity Tree's permit reinstatement, followed by a summation, with relevant documentation included at Brief's conclusion.

- 35 18 months of closure = "abandonment," never mentioned by San Francisco Department of Public Health, Planning Department
- 35 Planning Department, San Francisco Department of Public Health different closure dates (May 2012, December 2012)
- <sup>35</sup> Reopening efforts February 2013, September 2013 continuing
- <sup>35</sup> Limited patient services (medicine and cultivation) provided after ending delivery service
- 35/958 Geary vacancy maintained by building owner for Divinity Tree return
- 35 San Francisco Department of Public Health, medical cannabis dispensary permitting body, never revoked permit
- <sup>35</sup> Special circumstances of closure United States Attorney fines, forfeiture, imprisonment threats to 958 Geary landlord

Upon closing storefront operations November 11, 2011 due to possible United States Department of Justice judicial action against our supportive landlord, Divinity Tree operated a delivery service from 958 Geary until May 15, 2012, when we terminated our lease with Gordon Property Management out of financial necessity. However, hoping for our possible future return the owners maintained 958 Geary vacancy. In April and May 2012, I met with the San Francisco Department of Public Health and Dan Sider of the Planning Department. At these meetings, the unfortunate circumstances for the San

Francisco medical cannabis dispensaries targeted by the local United States Attorney were discussed as well as medical cannabis dispensary relocation possibilities.

At that time, the San Francisco Department of Public Health mentioned these considerations, specifically, a new permit fee reduction and temporary permitting at a new location, in both April and September 2012 meetings. However, the 18-month closure provision enacted in April 2011 was not disclosed or discussed, which earlier this year Planning Department and the Zoning Administrator determined our permit invalid for "abandonment". This item was not part of the original medical cannabis dispensary permit process. This omission of conditions of the additional "Abandonment" enactment by the Planning Department and San Francisco Department of Public Health brings Divinity Tree's permit issue to this point.

In the Letter of Determination decision, the Zoning Administrator did not address this serious omission of conditions of a continued permit. Finally, in the submission of Letter of Determination documents I discovered the San Francisco Department of Public Health listed the Divinity Tree closure date to be December 2012, about 8 months later than Planning Department closure date May 2012, which also was not addressed in the Zoning Administrator's decision.

Honestly, knowledge of the 18-month closure period would have precipitated Divinity Tree attempting re-opening at 958 Geary a year ago. Instead, after the United States Deputy Attorney General Cole August 2013 memo, Divinity Tree began working with San Francisco District 6 Supervisor Jane Kim in an attempt to ascertain from the local United States Attorney what actions might be curtailed regarding San Francisco medical cannabis dispensaries in light of City regulation, enforcement, and public safety, cited as concerns for prosecutorial direction in the memo.

Before completing our letter to the local United States Attorney, United States Representative Barbara Lee and three other US Representatives drafted a similar letter to the local United States Attorney, sent November 21, 2013. It seemed re-opening at 958 Geary could be attempted. In December 2013, I contacted the San Francisco Department of Public Health regarding the Divinity Tree's medical cannabis dispensary permit status. They directed me to the Planning Department. An exchange of emails followed, from January through March, in which were shared an account of Divinity Tree's activity since May 2012.

Through Dan Sider, I understood the focus of Planning Department's interest was to review Divinity Tree continued collective activities, in addition to previous re-opening plans. A Divinity Tree chronology was requested, compiled and delivered. The emails from Divinity Tree to Dan Sider and the Planning Department, will be included in documents.

This is a request for reconsideration of Divinity Tree's permit status because of the lack of clear communication regarding the 18-month closure provision for a continued permit, and additional special circumstances also deserving attention. Your serious consideration of this request and documentation is appreciated. Sincerely,

Dear Paul Huang & Charles Huang:

This office has been advised that there is a marijuana dispensary operating under the business name The Divinity Tree located at 958 Geary Boulevard, San Francisco, California (alternative address 954 Geary Boulevard, San Francisco), which property you own or have under your management or control. The dispensary is operating in violation of federal law, and persons and entities who operate or facilitate the operation of such dispensaries are subject to criminal prosecution and civil enforcement actions. Since the dispensary is operating within a prohibited distance of a playground, Sgt. John Macaulay Park, the unlawful operation of the dispensary is subject to enhanced penalties. Additionally, property involved in such operations, including real property, is subject to seizure by and forfeiture to the United States. These penalties and remedies apply regardless of the purported purpose of the dispensary or the uses for which marijuana is purportedly sold. Specifically, Title 21, United States Code, Section 856(a) provides:

It shall be unlawful to knowingly and intentionally rent, lease, or make available for use, with or without compensation, [a] building, room, or enclosure for the purpose of unlawfully manufacturing, storing, distributing or using a controlled substance.

Section 881(a)(7) of Title 21 provides:

The following shall be subject to forfeiture to the United States and no property right shall exist in them: All real property, including any right, title, and interest (including any leasehold interest) in the whole of any lot or tract of land which is used in any manner or part, to commit, or to facilitate the commission of, a

violation of this sub-chapter.

Violation of the federal law referenced above is a felony crime, and carries with it a penalty of up to 40 years in prison when operating within a prohibited distance of a school, playground, etc. An owner of real property with knowledge or reason to know of illegal drug sales on real property that he owns or controls may have his interest in the property forfeited to the government without compensation.

This letter is formal notification to you that there is a marijuana dispensary operating on the above described property within a prohibited distance of a playground. You are further advised that the violations of federal law relating to the marijuana dispensary operating on your property may result in criminal prosecution, imprisonment, fines, and forfeiture of assets, including the real property on which the dispensary is operating. Any money you receive (or have received) from the dispensary operator may also be subject to seizure and forfeiture. Your prompt attention to this matter is strongly advised. Please take the necessary steps to discontinue the sale and/or distribution of marijuana at the above-referenced location within 45 days of this letter. You may wish to seek independent legal advice concerning this matter.

To Divinity Tree Patients' Wellness Cooperative:

The Department of Public Health understands that the Divinity Tree Patients' Wellness Cooperative, a permitted Medical Cannabis Dispensary located at 958 Geary in San Francisco has been involuntarily forced to relocate its permitted operation due to sanctions against its landlord recently threatened by the U.S. Department of Justice. Within the bounds of our legal authority, the Department is committed to supporting the Divinity Tree's ongoing operation and service in San Francisco.

The Department can affirm the Divinity Tree has remained compliant with all local rules and regulations regarding the operation of a medical cannabis dispensary since receiving its permit to operate in 2009. Because Divinity Tree has a valid permit and the relocation is involuntary, and because Divinity Tree has chosen to relocate to another San Francisco property, the Department is willing to waive the share of the new application fee assigned to the Department (currently \$4336). In addition, the Department will allow the Divinity Tree to make payments on the annual license fee for the Dispensary in quarterly installments.


Once the Divinity Tree submits an application for a new location and secures required approvals from the Planning Dept, Dept of Building Inspection, Fire Dept, and Health Dept for an MCD use, the Department can issue Divinity Tree a temporary MCD permit for the new location. The temporary permit will allow Divinity Tree to operate while they finish any required construction under their issued building permit. This temporary permit will be valid for 6 months under the following conditions, or until they obtain a final permit to operate, whichever comes first:

- 1. No one appeals the permit issuance. If the permit is appealed, The Divinity Tree cannot operate until the appeal process is concluded
- 2. The Divinity Tree complies with all required operating conditions in SF Health Code Article 33.
- 3. The Divinity Tree pays required installments of the annual license fee beginning with the issuance of the temporary permit.

Guidance Regarding Marijuana Enforcement

In October 2009 and June 2011, the Department issued guidance to federal prosecutors concerning marijuana enforcement under the Controlled Substances Act (CSA). This memorandum updates that guidance in light of state ballot initiatives that legalize under state law the possession of small amounts of marijuana and provide for the regulation of marijuana production, processing, and sale. The guidance set forth herein applies to all federal enforcement activity, including civil enforcement and criminal investigations and prosecutions, concerning marijuana in all states.

As the Department noted in its previous guidance, Congress has determined that marijuana is a dangerous drug and that the illegal distribution and sale of marijuana is a serious crime that provides a significant source of revenue to large-scale criminal enterprises, gangs, and cartels. The Department of Justice is committed to enforcement of the CSA consistent with those determinations. The Department is also committed to using its limited investigative and prosecutorial resources to address the most significant threats in the most effective, consistent, and rational way. In furtherance of those objectives, as several states enacted laws relating to the use of marijuana for medical purposes, the Department in recent years has focused its efforts on certain enforcement priorities that are particularly important to the federal government:

- Preventing the distribution of marijuana to minors;
- Preventing revenue from the sale of marijuana from going to criminal enterprises, gangs, and cartels;
- Preventing the diversion of marijuana from states where it is legal under state law in some form to other states;
- Preventing state-authorized marijuana activity from being used as a cover or pretext for the trafficking of other illegal drugs or other illegal activity;

- Preventing violence and the use of firearms in the cultivation and distribution of marijuana;
- Preventing drugged driving and the exacerbation of other adverse public health consequences associated with marijuana use;
- Preventing the growing of marijuana on public lands and the attendant public safety and environmental dangers posed by marijuana production on public lands; and
- Preventing marijuana possession or use on federal property.

These priorities will continue to guide the Department's enforcement of the CSA against marijuana-related conduct. Thus, this memorandum serves as guidance to Department attorneys and law enforcement to focus their enforcement resources and efforts, including prosecution, on persons or organizations whose conduct interferes with any one or more of these priorities, regardless of state law.<sup>1</sup>

Outside of these enforcement priorities, the federal government has traditionally relied on states and local law enforcement agencies to address marijuana activity through enforcement of their own narcotics laws. For example, the Department of Justice has not historically devoted resources to prosecuting individuals whose conduct is limited to possession of small amounts of marijuana for personal use on private property. Instead, the Department has left such lower-level or localized activity to state and local authorities and has stepped in to enforce the CSA only when the use, possession, cultivation, or distribution of marijuana has threatened to cause one of the harms identified above.

The enactment of state laws that endeavor to authorize marijuana production, distribution, and possession by establishing a regulatory scheme for these purposes affects this traditional joint federal-state approach to narcotics enforcement. The Department's guidance in this memorandum rests on its expectation that states and local governments that have enacted laws authorizing marijuana-related conduct will implement strong and effective regulatory and enforcement systems that will address the threat those state laws could pose to public safety, public health, and other law enforcement interests. A system adequate to that task must not only contain robust controls and procedures on paper; it must also be effective in practice. Jurisdictions that have implemented systems that provide for regulation of marijuana activity

¹ These enforcement priorities are listed in general terms; each encompasses a variety of conduct that may merit civil or criminal enforcement of the CSA. By way of example only, the Department's interest in preventing the distribution of marijuana to minors would call for enforcement not just when an individual or entity sells or transfers marijuana to a minor, but also when marijuana trafficking takes place near an area associated with minors; when marijuana or marijuana-infused products are marketed in a manner to appeal to minors; or when marijuana is being diverted, directly or indirectly, and purposefully or otherwise, to minors.

Memorandum for All United States Attorneys Subject: Guidance Regarding Marijuana Enforcement

must provide the necessary resources and demonstrate the willingness to enforce their laws and regulations in a manner that ensures they do not undermine federal enforcement priorities.

In jurisdictions that have enacted laws legalizing marijuana in some form and that have also implemented strong and effective regulatory and enforcement systems to control the cultivation, distribution, sale, and possession of marijuana, conduct in compliance with those laws and regulations is less likely to threaten the federal priorities set forth above. Indeed, a robust system may affirmatively address those priorities by, for example, implementing effective measures to prevent diversion of marijuana outside of the regulated system and to other states, prohibiting access to marijuana by minors, and replacing an illicit marijuana trade that funds criminal enterprises with a tightly regulated market in which revenues are tracked and accounted for. In those circumstances, consistent with the traditional allocation of federal-state efforts in this area, enforcement of state law by state and local law enforcement and regulatory bodies should remain the primary means of addressing marijuana-related activity. If state enforcement efforts are not sufficiently robust to protect against the harms set forth above, the federal government may seek to challenge the regulatory structure itself in addition to continuing to bring individual enforcement actions, including criminal prosecutions, focused on those harms.

The Department's previous memoranda specifically addressed the exercise of prosecutorial discretion in states with laws authorizing marijuana cultivation and distribution for medical use. In those contexts, the Department advised that it likely was not an efficient use of federal resources to focus enforcement efforts on seriously ill individuals, or on their individual caregivers. In doing so, the previous guidance drew a distinction between the seriously ill and their caregivers, on the one hand, and large-scale, for-profit commercial enterprises, on the other, and advised that the latter continued to be appropriate targets for federal enforcement and prosecution. In drawing this distinction, the Department relied on the common-sense judgment that the size of a marijuana operation was a reasonable proxy for assessing whether marijuana trafficking implicates the federal enforcement priorities set forth above.

As explained above, however, both the existence of a strong and effective state regulatory system, and an operation's compliance with such a system, may allay the threat that an operation's size poses to federal enforcement interests. Accordingly, in exercising prosecutorial discretion, prosecutors should not consider the size or commercial nature of a marijuana operation alone as a proxy for assessing whether marijuana trafficking implicates the Department's enforcement priorities listed above. Rather, prosecutors should continue to review marijuana cases on a case-by-case basis and weigh all available information and evidence, including, but not limited to, whether the operation is demonstrably in compliance with a strong and effective state regulatory system. A marijuana operation's large scale or for-profit nature may be a relevant consideration for assessing the extent to which it undermines a particular federal enforcement priority. The primary question in all cases — and in all jurisdictions — should be whether the conduct at issue implicates one or more of the enforcement priorities listed above.

As with the Department's previous statements on this subject, this memorandum is intended solely as a guide to the exercise of investigative and prosecutorial discretion. This memorandum does not alter in any way the Department's authority to enforce federal law, including federal laws relating to marijuana, regardless of state law. Neither the guidance herein nor any state or local law provides a legal defense to a violation of federal law, including any civil or criminal violation of the CSA. Even in jurisdictions with strong and effective regulatory systems, evidence that particular conduct threatens federal priorities will subject that person or entity to federal enforcement action, based on the circumstances. This memorandum is not intended to, does not, and may not be relied upon to create any rights, substantive or procedural, enforceable at law by any party in any matter civil or criminal. It applies prospectively to the exercise of prosecutorial discretion in future cases and does not provide defendants or subjects of enforcement action with a basis for reconsideration of any pending civil action or criminal prosecution. Finally, nothing herein precludes investigation or prosecution, even in the absence of any one of the factors listed above, in particular circumstances where investigation and prosecution otherwise serves an important federal interest.

The chronology next week will be shorter, I promise. Perhaps after reviewing each chrono, you could whatever documentation necessary. What I have available is in red type. You could just give me the date for any requested material.

In March 2005, Health and Wellness MCD was initiated and opened on Howard St. between 5th and 6th. We had a lease, business permit and SFDPH listing as an SF MCD. After April 1, our status was challenged twice, but we prevailed providing all proper documents, perhaps to Planning or Building Insp. While dispensing medicine since late March, we had an unhappy neighbor, Laura Weil, who managed to obtain a restraining order in July.

At that time friends from Stockton, who had opened Divinity Tree also in March, invited us to take over their lease and dispense from 958 Geary. They were weary of the commute and we all believed the City would appreciate 2 dispensaries merging, and did. New paperwork was adjusted; grandfathered in because of pre-April 1 operations, we began the permit process in 2006. Our small space was ironically difficult to meet the permit process accessibility standards. A combination of diligence by our architect, thoroughness by the MOD (Jim and Susan), and Divinity Tree perseverance -managing to have Supes Alioto and Daly co-sponsor accessibility adjustment to the permit process and passing BOS unanimously January 2009. After installing an expensive top of the line platform lift in our store, I believe our final permit was issued August 2009. By the way, at our Planning Dept. public hearing, we had no public objections despite existing under a 6 floor apartment building. adjacent to 2 others, and across the street from 2 more. We employed 12 (half with families) at \$20 per hr, with full benefits. Divinity Tree mantra - best possible medicine, lowest cost, for those most in need. We had excellent relations with Gordon Property Management; I believe our lease was renewed for 5 years in 2009. By 2011 Divinity Tree had over 7500 member-patients. We operated in strict compliance with the AG guidelines, August 2008, and paid over a million dollars per year in sales tax. On September 28, 2011 our landlord received a letter from the US Atty. Melinda Haag threatening fines, forfeiture and 40 years imprisonment. Divinity Tree's proximity to Sgt. Macaulay Park was given as the reason. We were involved in park maintenance, and have promised District 6 Sup Jane Kim to continue, offer improvements and upgrade the park working with Parks & Rec., and contribute financially to accomplish that goal. Divinity Tree closed in 45 day compliance on November 11, 2011. We began a delivery service in December lasting until June 2012. One last note, on Post St., Grassroots MCD, across the alleyway (Cedar St.), behind Divinity Tree was allowed to stay open, prospered and opened another establishment south of Market. Thanks Dan, Charley Pappas - chairman, Divinity Tree Patients' Wellness Coop.

Because it appears that the property is located within 1,000 feet of at least one school and at least one recreation building primarily serving youth, the site appears to be ineligible under today's Planning Code for a new MCD. 


