3. Approval of Excused Absences

4. Update from SF Youth Commission on CBA Youth Town Hall [Discussion]

Event scheduled for Thursday, June 11th at Spotify

Presentation given by SF Youth Commissioner Joyce Wu. Ms. Wu gave brief update on the upcoming CBA Youth Town Hall – highlights include strong coordination from Twitter, Zendesk, Yammer, Spotify, and all six CBA liaisons expected to attend the Town Hall. Commissioners took a tour of Spotify, Zendesk and Twitter and are looking forward to the continued dialogue with the CBAs. Increasing the amount of internships at companies is

something the youth are looking to achieve. Allen Lu mentioned that the youth commissioners' goal is to use the town hall as a platform to bring more ideas from other young people. The town hall will consist of mainly youth ages 12-24 living in District 6, or utilize services in the area.

5. Presentation by Community Liaisons [Discussion]

This section of the agenda allows companies to present on their monthly progress for May 2015. Liaisons presented: Twitter and One King's Lane.

- Caroline B. of Twitter provided a March and April report. Highlights include cash grants for March over \$100K to groups like Safe Passage, Glide, Friday Night Markets, and Catholic Charities STEM (Science Technology Engineering and Math) Camp. ECS behind the scenes speaker series. April \$115K in cash-grants; including but not limited to: Larkin St. Youth Services employment academy, Boys and Girls Club, Hands-on bay area, Stern Grove on the Road at Boeddeker Park. Bi-Annual Friday for Good coordinated with 40 organizations. NeighborNest ribbon cutting May 20th. In partnership with Compass Family Services NeighborNest will help many families in the area.
- Mckenzie F. and Charllotte. March volunteered for a total of 24hours at ECS senior home. In-kind donations \$1,995 to Hamilton House. Working with Glide on major refurbish of community room. 12 hours volunteering at the Princess Project.
 Partnering with Layme to supply products in gift bags for their fund raising gala.

Discussion and possible action for the election of a new Chair and Vice Chair for 2015. Stephen Tennis is the Vice Chair. Peter M. motioned to nominate Rob Gitin to be new chair of the CAC, seconded by Stephen T. 7 ayes 0 nos. Rob Gitin accepted nomination to be new chair.

8. CAC Framework Amendment [Discussion/Possible Action]

The CAC to revisit the Framework of their committee and make possible changes to reflect current priorities. Discussion on amending the framework touched on displacement issues. Also discussion on having the next CAC meeting dedicated to discuss any amendments members would like to draft. This discussion will be the first of

a few discussions on the matter. Each member should talk with their respective communities to seek input on what edits the framework should be included, as well as speak with community liaisons and discuss the framework with them. R. Gitin asked liaisons which areas within the framework do they think they've excelled on and where do they need to increase their focus? Also, does the current framework address the type of efforts they feel are useful and if not how do they think the framework should change to address the goals they've been seeking to achieve?

- directing staff to place the item on a future agenda. (Government Code Section 54954.2(a).)
