7. Vacant Seats and renewal process [Discussion]

Two members need to reapply. The date for Rules is tentatively scheduled for October 22^{nd} .

Vacant seat 4, succeeding John Bogacki, term expiring on August 2, 2015, must be a senior or disabled resident of the Central Market Street and Tenderloin Area or Adjacent Area, for a four-year term ending August 2, 2019. (John expressed interest in renewing)

Vacant seat 5, succeeding Brad Paul, term expiring on August 2, 2015, must have expertise in affordable housing or tenant protection and anti-displacement policies and strategies, and have familiarity with the Central Market Street and Tenderloin Area, for a four-year term ending August 2, 2019. (Brad has expressed interest in renewing)

Vacant seat 10, succeeding Antoinetta Stadlman, term expiring on August 2, 2015, must be a resident of the Central Market Street and Tenderloin Area or Adjacent Area, for a four-year term ending August 2, 2019. (Antoinetta has reapplied)

At this time, members of the public may address the Citizens Advisory Committee on items of interest to the public that are within the subject matter jurisdiction of the Committee but do not appear on the agenda. With respect to agenda items, the public will be given an opportunity to address the Committee when the item is reached in the meeting. - requesting staff to report back on a matter at a subsequent meeting, or
- directing staff to place the item on a future agenda. (Government Code Section 54954.2(a).)
