# San Francisco Receives Human Rights Award for our Work to Advance Women

On November 15, 2010, Executive Director Emily Murase will travel to Atlanta, GA to accept, on behalf of Mayor Gavin Newsom, the **Americas Award for Excellence in Public Service** from the United Nations Institute for Training and Research and CIFAL Atlanta. CIFAL selected San Francisco as the 2010 Laureate in the category of "Promoting Gender Equality," highlighting the Department on the Status of Women's groundbreaking work in the advancement of women and girls in San Francisco as a model for cities worldwide.

The Americas Award honors remarkable public officials from the Americas who have contributed to the economic and social development of our societies and have achieved tangible progress toward the United Nations Millennium Development Goals. The Department is excited to have San Francisco's work recognized by this prestigious body.



## Commissioner Dorka Keehn Honored by the Domestic Violence Consortium

On October 5, 2010, the San Francisco Domestic Violence Consortium (DVC) hosted "A La Cart," a dinner event kicking off Domestic Violence Awareness Month. At the event, the DVC honored Commissioner Dorka Keehn for her contributions to the domestic violence community.



Since her appointment to the Commission on the Status of Women, Commissioner Keehn has been a champion for the movement to end domestic violence. She helped form the Justice and Courage Oversight Panel in the wake of the tragic homicide of Claire Joyce Tempongko, and has chaired the panel for the last 8 years. The DVC is a group of 17 community-based agencies dedicated to eliminating domestic violence and ensuring safety for survivors. Commissioner Keehn will step off the Commission in January, and this honor from the DVC is a touching tribute to her many accomplishments.
