Violence Against Women Prevention and Intervention (VAW) Grants Program FY2010-2011 Year-End Performance Summary

In Fiscal Year 2010-2011 (FY1011), the Department on the Status of Women distributed grants totaling \$2,743,550 to 34 programs that provided services in six core service areas: Crisis Lines, Intervention & Advocacy, Legal Services, Prevention & Education, Emergency Shelter, and Transitional Housing. During FY1011, Partner Agencies served a total of 34,902 unduplicated individuals and provided 54,215 hours of supportive services.

Unduplicated Individuals Served by Programs

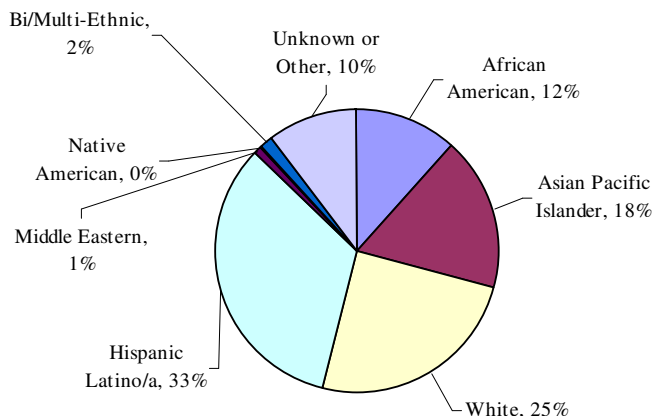
Ethnicity and Age

Due to the confidential nature of the work, especially for crisis line services, the ethnicity of many of the individuals served is unknown.

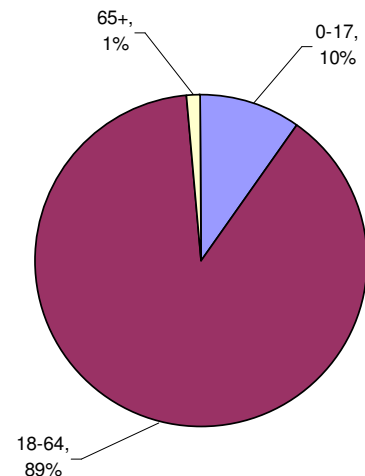

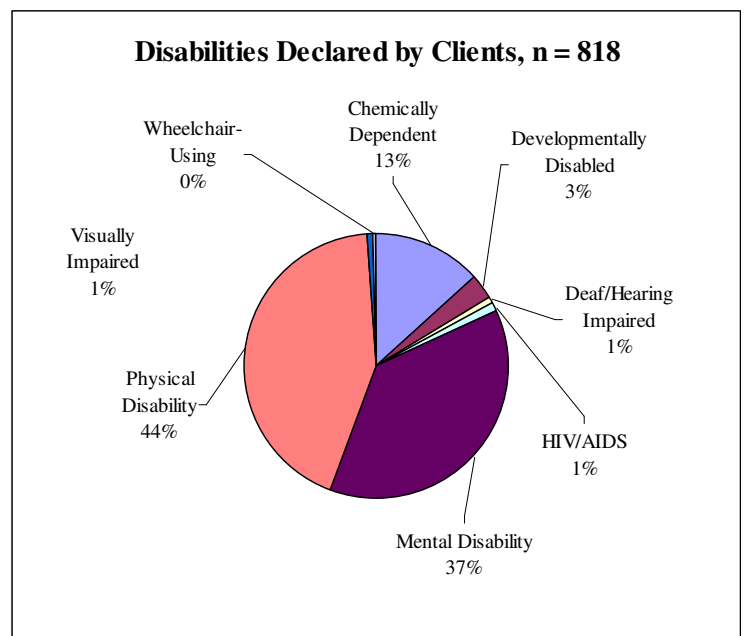
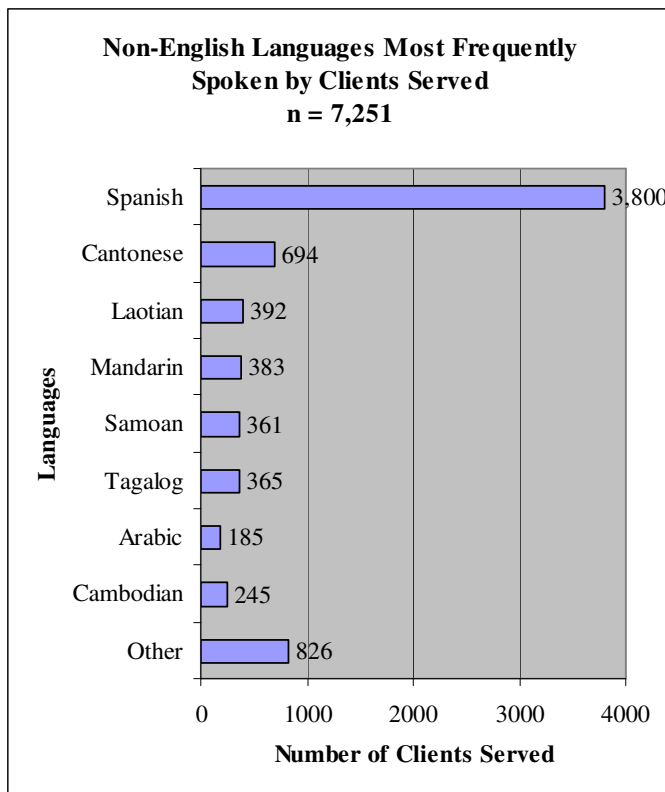
Additional Characteristics

The strength of the Partner Agencies providing the services is in their capacity to serve such a broad array of community members. The diversity of the San Francisco population is apparent in the number of languages spoken by clients served by the Partner Agencies. What follows is a summary of the disability status, sexual orientation and gender identification, and languages spoken by the clients served by VAW Grants Program Partner Agencies. Of the 34,902 individuals served during FY1011, 21% spoke a language other than English. A total of 531 individuals identified as Lesbian, Gay, Bisexual or Transgender, 2% of all individuals served. A total of 818 cases of disability were reported by individuals served, though it is possible that some individuals may possess multiple disabilities, and other disabilities went undeclared.

Services Provided

Supportive Services

Partner Agencies provided a total of 54,215 hours of supportive services during FY1011. Emergency Shelter and Transitional Housing constitute an important component of the VAW Grants Program. The agencies providing these services report on the number of bed nights, or the number of beds filled by clients each night. Over 12 months, 3 emergency shelters provided 4,796 bed nights to women and their children escaping domestic violence, while 3 transitional housing programs and one permanent supportive housing program provided 12,770 bed nights to women seeking long-term stability. Sadly, these shelters and programs turned 1,333 individuals away, due to a lack of space.

The Department funds two crisis lines, one for victims of domestic violence and the other for victims of sexual assault. These agencies fielded a total of 21,797 calls during the year. The graph below illustrates the many ways Partner Agencies have provided critical services to populations in need.
