
Let me say to our friends who celebrate it – Ramadan Mubarak! May this Holy Month of prayer, reflection and community be filled with peace and love and safety.

Child Abuse Prevention Month

April is also Child Abuse Prevention Month. Although the rates of child abuse in San Francisco have decreased in recent years, even one child being abused is one too many.

DOSW works to prevent and address child abuse through our Family Violence Council (FVC), a public body consisting of governmental and nongovernmental agencies working to end domestic violence across the lifespan. The FVC is chaired by three community-based organizations: the Domestic Violence Consortium, the Institute on Aging, and Safe & Sound. Safe & Sound is a child abuse prevention organization that provides direct services to children and families, advocates around policies and programs, and collaborates with government and nonprofit agencies. Many people do not know that child sexual exploitation can be viewed as both a form of human trafficking as well as a form of child abuse. At DOSW, one of the ways we work to address the exploitation of youth and children in the commercial sex industries is through the SF SOL Project. The SF SOL Project was created by a \$9.3 million grant from the California Department of Social Services and is a collaboration of San Francisco government and nonprofit agencies led by DOSW. The project is a new pilot that provides housing options and other services to youth who have been exploited with the goal of being replicated statewide.
