INTRODUCTION

Enclosed is the Office of Citizen Complaint's statistical report for the 2008 second quarter. The OCC had a very productive quarter; opening more cases this quarter, than the first quarter of 2008 and more than in the second quarters the previous two years.

ORGANIZATIONAL CHANGES

This quarter represents the second full quarter under my leadership. This second quarter we held an all staff facilitated retreat and an extended management team facilitated work session. We also began strategic planning for case management and began the hiring process for filling key staff vacancies. We also adopted performance plans for the investigators.

BUDGET

On June 2, 2008, Mayor Gavin Newsom released the proposed 2008/09 City and County of San Francisco budget that included a budget increase for the Office of Citizen Complaints. The proposed \$4,229,167 budget represented a 7% increase over the 2007/2008 \$3,944,726 budget. This modest \$284, 441 increase provided the following:

- Annualized a .25 8124 Investigator position to a 1.0 full time equivalent
- Annualized a .75 Senior Clerk typist position to a 1.0 full time equivalent
- Added an 8126 Senior Investigator position mid-cycle
- Added a 1450 Executive Secretary position mid-cycle
- Added a 1426 Senior Clerk Typist position, mid-cycle

INVESTIGATION OF CASES

As of the end of the second quarter of 2008, the agency opened 537 new cases, and closed 572 cases. Both the number of new cases, as well as the number of cases closed, is higher than that at the end of previous second quarters in 2006 and 2007. During this quarter, the OCC closed 18 more cases than it opened, and we continued to reduce the backlog of old cases that had built up over the past few years. At the beginning of this second quarter, there were 4 pending cases from 2005 and 20 pending cases from 2006. By the end of the second quarter, the investigators had eliminated the 2005 backlog and reduced the 2006 backlog to one case.

Staff has demonstrated its commitment to the OCC's mission of timely, fairly and in an unbiased manner investigating citizen complaints of police misconduct or failure to perform a duty, despite the staffing issues faced by the agency. During this reporting period, the agency was staffed with only 13 investigators. This constitutes one less in number than were on staff when the Controller's Office reported that, after studying comparable caseloads at other agencies, OCC investigators had a far higher caseload than investigators in comparable agencies. With the release of the Mayor's proposed budget, the OCC began the hiring process to fill four vacant investigator positions that remained unfilled pending the budget release. Once these four vacancies, plus two additional vacancies, are filled, the OCC will be at its full complement of 18 budgeted investigator positions.

While the agency has continued closing cases at an accelerated rate, insufficient staffing has had a negative impact on the time it takes to investigate a case to completion, and potentially on the rate of sustained misconduct findings. For example, while 62% of OCC cases closed in the second quarter were investigated within six months, 80% of the 15 cases sustained in the second quarter took more than nine months to investigate and two of those exceeded a year. The rate of sustained cases, too, was down overall. In the first quarter of 2008, 3% of cases were sustained, which is significantly lower than the agency's historical average, which hovers between eight and ten percent. The sustain rate rose somewhat in the second quarter to 5%, for an overall six month sustain rate of 4%. In 2007 the six month sustain rate was 5% and in 2006 it was 7%. One theory is that heavy investigator caseload – the unavoidable result of insufficient staffing and investigator attrition – may negatively impact the rate of sustained findings.

STATUS OF CURRENT OCC CASES – THE 'KEANE' REPORT

By the end of the 2008 second quarter, staff had completed intake on all 2007 cases, and closed 87% of these, leaving 13% of the cases pending. In comparison, by the end of the 2007 second quarter, staff had also completed intake on all 2007 cases, and closed 85% of these, leaving 15% of the cases pending. Through closer case management, staff has significantly reduced the number of cases in intake over the same period last year.

On June 30, 2008, only 5% of 2008 cases were in intake, while on June 28, 2007, 17% of 2007 cases were still in intake.

MEDIATION

The OCC has made significant progress in increasing the number of cases mediated. Under the leadership of the agency's Mediation Coordinator, and the efforts of a dedicated panel of talented pro bono mediators, the agency mediated 16 cases in the second quarter of 2008, an increase of six over the same period of 2007. All of these cases were successfully mediated, meaning that both complainants and officers were able to voice their concerns and have a frank discussion regarding the complaint. The mediation program serves to educate officers and complainants alike, and the OCC will continue to promote the program to the community. During this second quarter, in May, the Mediation Coordinator offered an orientation session for 17 new volunteer applicants, which enlarged our pool of mediators and will enable us to increase our mediation efforts. Additionally, in June, the Mediation Coordinator conducted recruitment at a Community Boards training. As a result of her recruitment efforts we have received six new volunteer mediator applications.

OUTREACH

Through our policy work on juvenile justice and language access issues, the OCC has continued to work in cooperation with representatives of numerous legal and community groups, including the Asian Law Caucus, La Raza Legal Central, Youth Law Center, Asian Pacific Islander Legal Outreach, Chinese for Affirmative Action and Lawyers Committee for Civil Rights, to name a few. In May, two Chinese newspapers and a Spanish television network interviewed our Policy Analyst regarding our work on the language access Department General Order.

In addition to its work investigating complaints, the OCC continued its efforts to inform members of the Police Department and community about OCC services and procedures. OCC representatives made presentations to San Francisco Police Academy recruits at the beginning and end of their Academy training. In addition, OCC representatives made presentations at Police Commission community meetings held in the Ingleside and Central Districts. OCC representatives also staffed tables or made presentations at the Asian Heritage Festival, the San Francisco Public Defenders Juvenile Justice Summit, the Immigrants Rights Commission meeting, Chinese for Affirmative Action Celebration of Justice, and Community Boards mediation training.

This quarter, our agency distributed materials in multiple languages to Community United Against Violence, the Asian Law Caucus, the Ella Hill Hutch Community Center, the Public Defender's Office, the District Attorney's Office, the Mayor's Office on Adult and Aging, the Human Rights Commission, the Mayor's Office of Neighborhood Services, the ACCESS Center, 27 branch libraries, the San Francisco Law Library, La Raza Centro

Legal, the Bernal Heights Neighborhood Center, Arriba Juntos, the Sunset Beacon Center, Chinese for Affirmative Action, the African Immigrant Resource Center, and the Asian Pacific Islander Youth Advocacy Network. Finally, during this quarter, representatives from OCC met with foreign dignitaries at the International House at UC Berkeley, the Russian Consulate (Climate of Trust Organization) in San Francisco and with State Department hosted international delegations at the Office of Citizen Complaints. We also visited the Civilian Complaint Review Board offices in New York City.

POLICY ANALYSIS

During the second quarter of 2008 the agency's policy work has been focused primarily in three areas. These are: 1) Community Outreach Strategic Plan 2) Police Interactions with Juveniles and 3) Language Access.

First, the OCC developed a 2008 Community Outreach Strategic Plan this quarter. This plan outlines outreach goals in the areas of community presentations and partnerships, language access, training, website development, media relations, and program effectiveness and resources. By using a community-based approach that relies upon presentations, widely distributed written materials in multiple languages, and the OCC website, the OCC's Outreach Strategic Plan provides a roadmap for strengthening its relationships with communities historically and statistically likely to have encounters with the police and for reaching communities that have been racially, culturally or linguistically isolated from police services. The OCC presented the Outreach Strategic Plan to the Police Commission on April 23, 2008. Despite significant staffing shortages, the OCC has been implementing this ambitious outreach strategy.

Second, in collaboration with juvenile justice advocacy groups, city agencies, commissions and the Police Department, the OCC proposed extensive revisions to Department General Order 7.01, a protocol for police interactions with juveniles. Adopted by the Police Commission on May 7, 2008, this newly revised Department General Order significantly increases protections to juveniles by permitting parents to be present during interrogations, mandating the tape recording of all juvenile interrogations, notifying parents when juveniles are detained, and requiring that juveniles be brought to juvenile-centered facilities such as the Community Assessment and Referral Center (CARC) and the Juvenile Justice Center instead of district stations where juveniles are exposed to adult lock-up facilities and adult suspects.

Finally, as part of its policy work to develop police training and public education materials on Department General Order 5.20 (Language Access Services for Limited English Proficient (LEP) Persons), the OCC developed a brochure to inform the public of the availability of bilingual officers, interpreters and translated materials under the Police Department's new general order, in conjunction with representatives from several community organizations. By June 26, 2008, over 20 community groups, city agencies and commissions had reviewed and endorsed this brochure. The Police Department is currently reviewing it. In the upcoming quarter, the OCC and language access advocacy groups will

continue meeting with the Police Department to discuss the translation, publishing and distribution of this brochure.

CONCLUSION

The OCC is committed to its mission of timely, fairly and in an unbiased manner investigating citizen complaints of police misconduct or failure to perform a duty. We look forward to filling staff vacancies so we can effectively carry out our mission. We will continue to focus on staff management and strategic case management.






Days to Close - Cases Closed Second Quarter 2008

Days to Close - Cases Sustained Second Quarter 2008








Days to Close - Cases Sustained Second Quarter 2007













OCC Caseloads by Investigator as of 07/02/2007




OCC Case Closures - Second Quarter 2008 by Investigator




OCC Case Closures - Second Quarter 2007 by Investigator





OCC Weighted Closures - Second Quarter 2008 by Investigator







