1. Call to Order & Roll Call

Meeting called to order at 6:01 p.m.

2. General Public Comment

Brent Turner, on behalf of California Association of Voting Officials, read a letter sent to Governor Newsom regarding election systems security.

3. Open Source Voting

Open Source Voting (OSV) Technical Advisory Committee (TAC) Member Roan Kattouw gave updates on issues discussed at the TAC meeting. He also explained the Primary Elections results page.

Also discussed were results of other counties, and the recent allocation of monies.

Commissioner Donaldson joined the meeting at 6:14 pm during this item.

President Mogi asked Director Arntz questions regarding San Francisco (SF) elections results. She wondered if there is a way to show totals of Primary Elections candidates in an easier format.

Laron Sandrolini presented for Department of Technology Director Linda Gerull and gave an update on the open source pilot project to conduct a risk-limiting audit of a ranked choice voting contest. He explained risk-limiting audits, including ballot-polling audits. Director Arntz gave a brief explanation of voter verification methods. Commissioners asked questions regarding the voting process, and verification processes used for auditing. Mr. Sandrolini gave a breakdown of how voting is tabulated. Commissioner Jerdonek inquired about the known source location and asked for a link to the repository.

Commissioner Jung moved to commend members of the team who were identified on the slide presentation and to authorize the President or her designee to draft a letter of commendation to the Mayor. Seconded by Commissioner Jerdonek.

Public Comment

A member of the public expressed support for the Voting Rights Taskforce.

Brent Turner, California Association of Voting Officials thanked the creators for the design work on the Elections Commission website.

A member of the public expressed that the American people deserve accountability and to be educated about this issue.

A member of the public recommended sending a to copy of the proposed letter to our Speaker Nancy Pelosi and the Secretary of State.

4. Commissioner's Reports

Commissioner Bernholz reported that she and Commissioner Jerdonek met with Department of Technology Director Linda Gerull and Information Security Officer Michael Maxman on November 18, 2019, and that they discussed election security and cyber system reporting. Elections security was discussed and cyber system reporting. Some decisions were tabled until Director Gerull could attend the meeting. They agreed to provide the Department of Technology with a brief introductory training for the commissioner's critical incident strategy, cyber plan overview, and regular elections cyber security updates.

President Mogi reported that the meeting minutes from the last couple of meetings are not ready.

5. Director's Report

Director Arntz reported expecting to certify the November 5, 2019 election the week of November 25, 2019. He also stated that ballots will have an audit mark and, gave specific information regarding ballots and recalls.

Commissioner Donaldson requested having the Elections Commission included at the beginning of the voter information pamphlet and in the table of contents.

Commissioner Jerdonek asked regarding the vote by mail versus election day totals on the summary, which category are the provisional ballots? Director Arntz said they will be in the precinct.

President Mogi asked if persons who vote at voting centers have the ability to change their party preference at the voting centers on the same day? Director Arntz said yes, they can.
