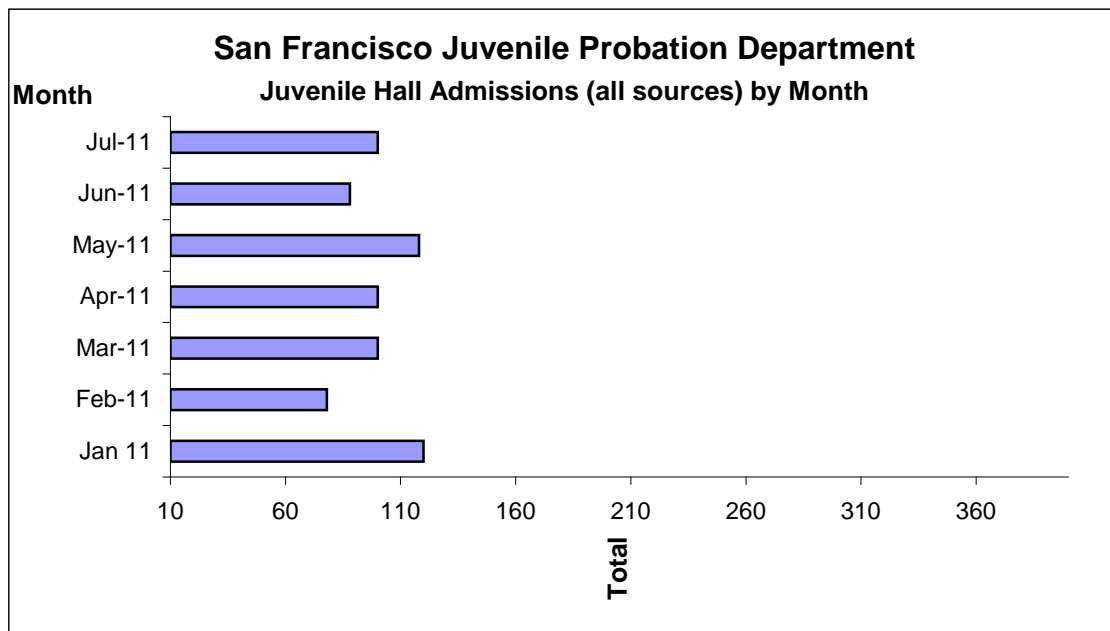
Bay Area Resident Juvenile Hall Comparison

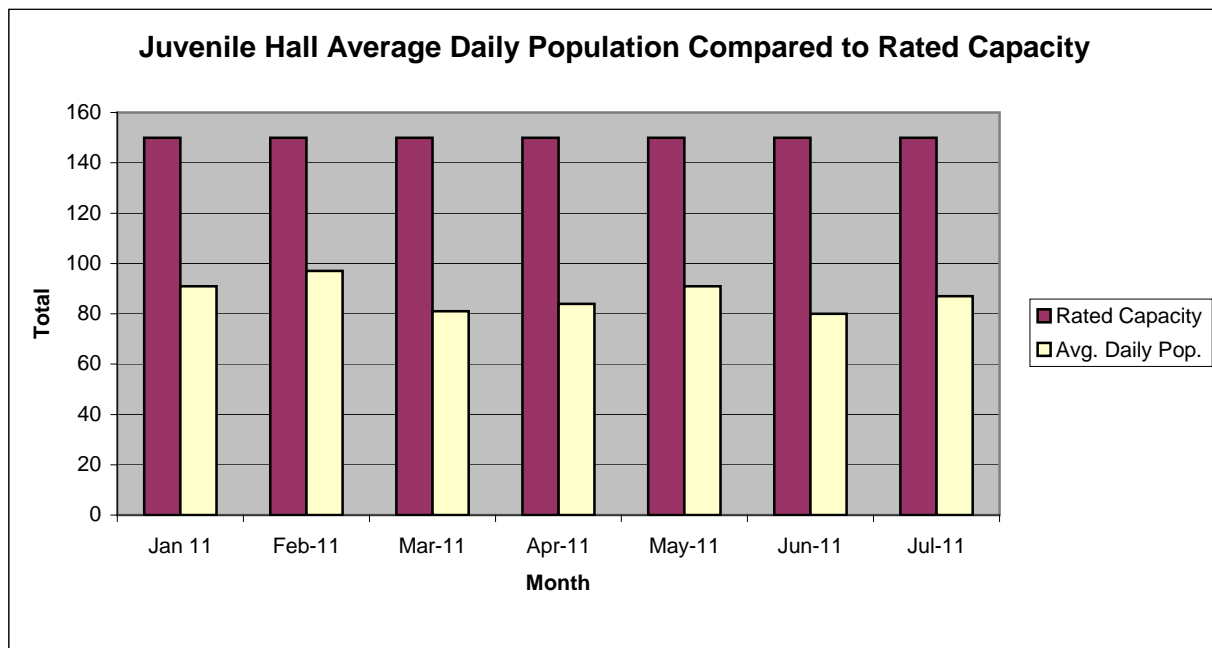

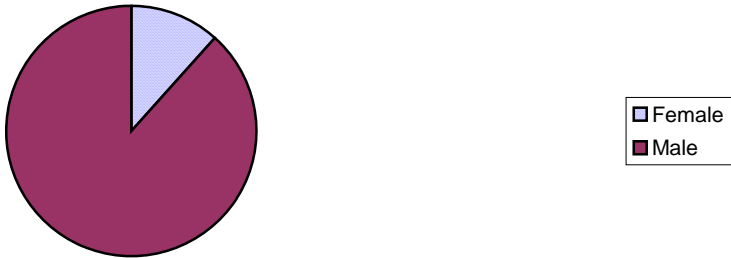

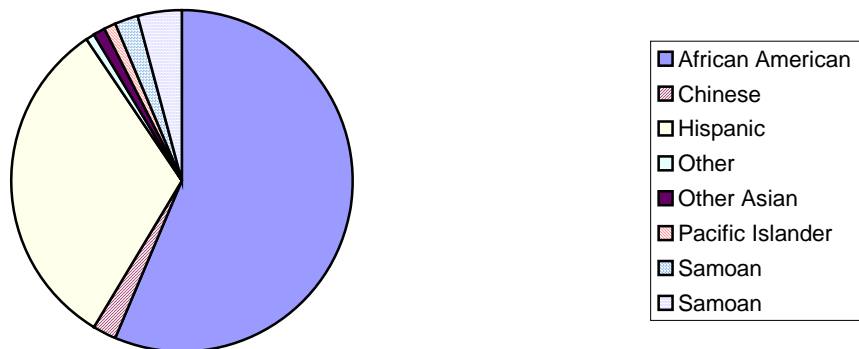

Of Juvenile Hall Detainees on 7/31/11 by Gender**

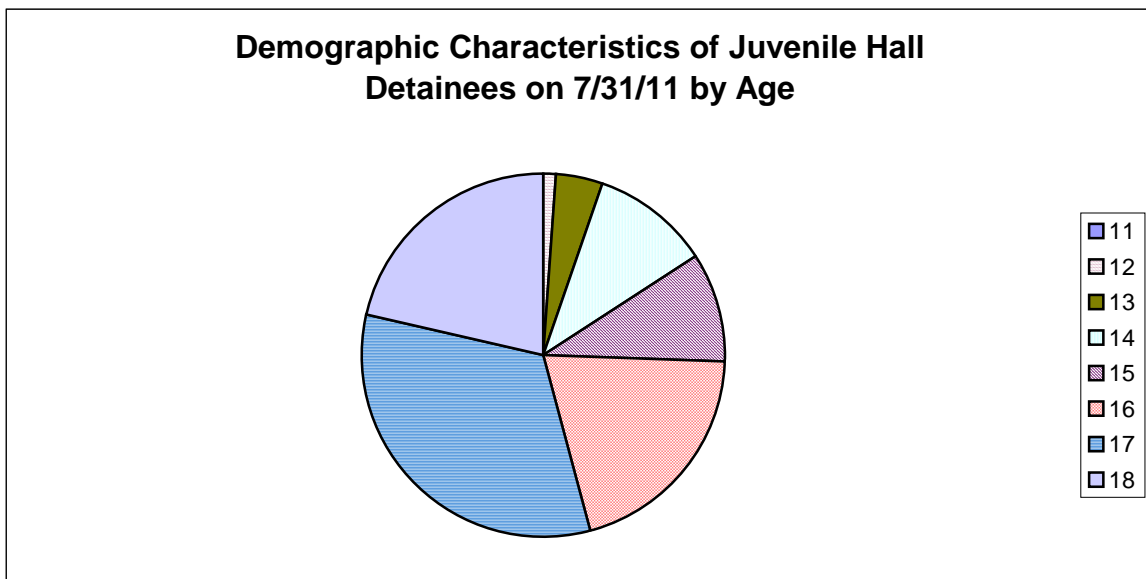

7/31/11 by Race**

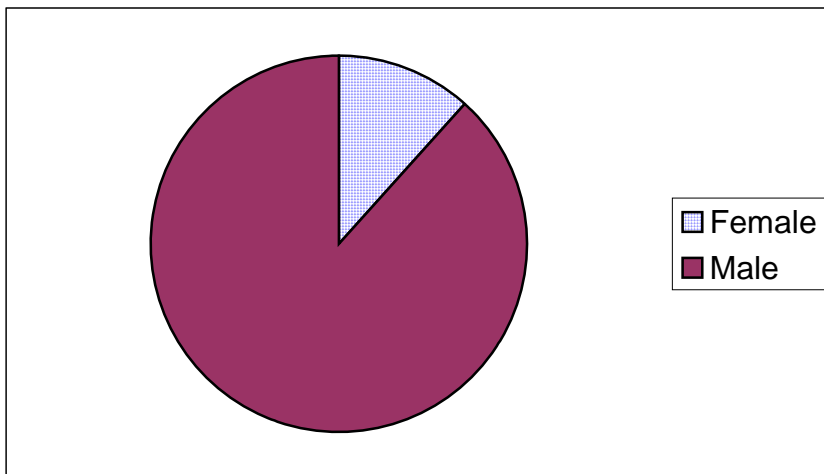

(2008-2010)

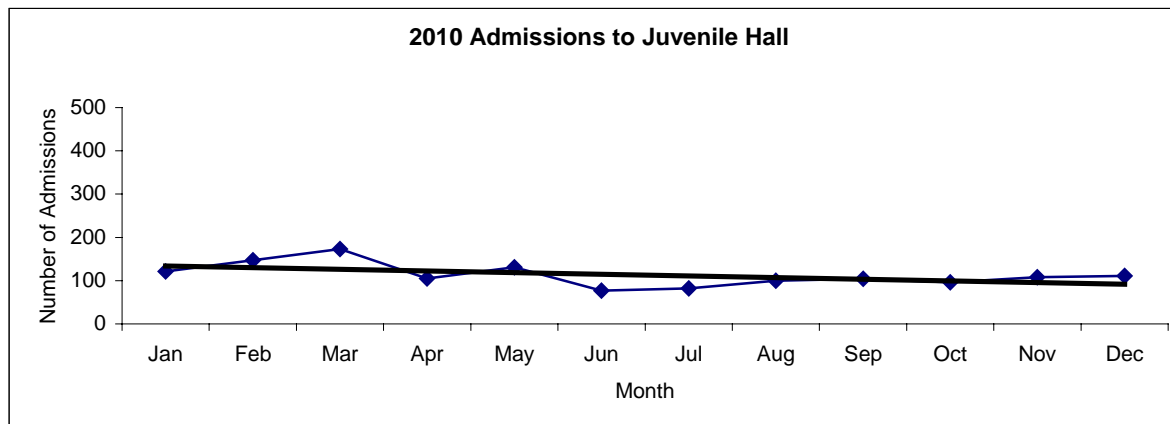

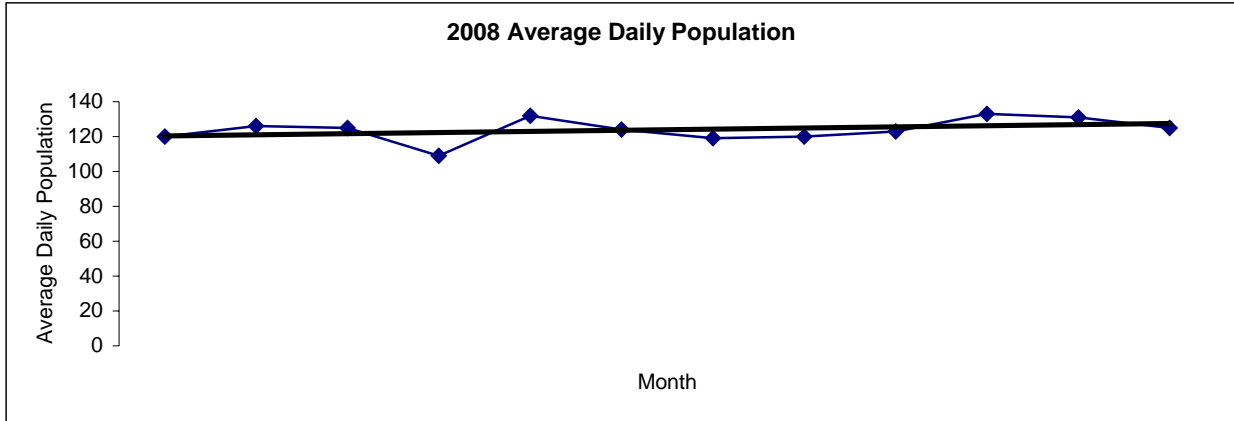

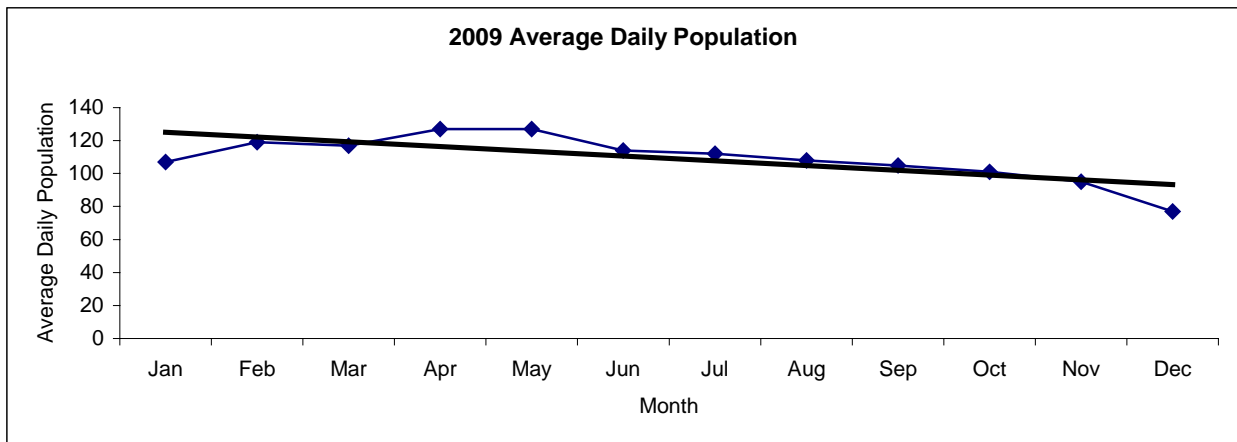
