I. INTRODUCTION

Attached is the Office of Citizen Complaints' statistical report for the 2015 second quarter. The OCC received an adjusted total of 164 complaints of police misconduct or failure to take action and closed 162 complaints in the second quarter. It sustained allegations of misconduct or failure to take action in 19 complaints against San Francisco Police officers which is a 12% sustained rate. The OCC mediated 12 cases, which is an 8% mediation rate. Combining the first and second quarters, the adjusted total of complaints received is 339, the total of complaints closed is 321, the total of complaints sustained is 27, and the total of mediations is 29. Combining both quarters the sustained rate is 8% and the mediation rate is 12%

II. ORGANIZATIONAL AND BUDGET MATTERS

A. Staffing

By the close of this period, 16 permanent line investigators (8124) staffed the OCC, but only 13 of them had full caseloads during this quarter. Two permanent line investigators were acting senior investigators during the second quarter. One of the permanent line investigators acted as a senior investigator continuing to fill the vacancy created when Senior Investigator Erick Baltazar was promoted to the deputy director/chief of investigations position in August 2013. Another permanent line investigator acted as a senior investigator while a senior investigator was on a long term leave. By the close of the second quarter, there were two investigator vacancies; two line investigators and one senior investigator. The OCC's budget provided for 17

line investigators, three senior investigators and a deputy director/chief of investigations. By the close of the quarter, 18¹ employees staffed the 21 investigator positions.

San Francisco City Charter section 4.127 provides a floor for investigators of one line investigator for every 150 police officers. With 2,176 sworn SFPD members during the second quarter, the floor was 15 line investigators.

B. Technology

During the second quarter the IS Business Analyst troubleshoot various aspects of OCC's transition to Microsoft Office 365 services, began work on next generation template installations for all OCC PCs and laptops, conducted inventories and audits and worked with vendors on fiscal year-end purchases. As always, he assisted investigators and other staff with technical aspects of their work and prepared statistical data for reports.

C. Training

During the second quarter of 2015, the OCC continued implementing its strategic plan for training its employees. In May, the investigators received training from Sergeant Cristina Franco of SFPD Internal Affairs Division. They also received training on accessing DMV records. During the second quarter, an OCC staff member received language access training.

D. Budget

During the second quarter, the OCC Director testified at two Board of Supervisors Public Safety Committee meetings, and three Board of Supervisors Budget and Finance Committee meetings on how enhancements to the OCC's budget could contribute to increasing public trust in the San Francisco Police Department. During the first quarter the OCC proposed budget enhancements rather than reductions to include 4.25 (FTEs) full time equivalents in additional staffing. The proposed staffing included one 8124 journey level investigator, one 8126 senior investigator, one 1051 information systems business analyst assistant and 1.25 – 8177 attorneys. Additionally the OCC requested partial relief from step and attrition adjustments. The proposed enhancements totaled \$636,118 for fiscal year 2015/16 and ongoing costs in 2016/17 totaling \$961,596.

On April 30, 2015, Mayor Edwin M. Lee, Board President London Breed, other members of the Board, announced a proposed package of initiatives to increase

public safety and implement police reforms including accelerated hiring, increased civilian oversight, more training for officers and deploying body cameras for every SFPD police officer on the street. Mayor Lee accepted the OCC's budget request to fund 4.25 positions. The press release read as follows:

“San Francisco deserves the best in 21st Century policing and this comprehensive package of public safety reforms will help our police officers further strengthen their ties with the community,” said Mayor Lee. “It is that community trust that has helped San Francisco remain one of the safest big cities in the nation and this plan will ensure that our Police Department has the resources they need to continue their work to protect and serve. “With increased civilian oversight, more training, accelerated hiring, and the latest technology, our sworn officer can do their job with even greater transparency and accountability.”

“We entrust the police to keep our citizens safe and as elected officials our citizens entrust us to ensure the police have all the tools, resources and education to do their job,” said Board President Breed. “This is a win-win for both the police and the community.”

“We have learned lessons from around the country, and we are responding to our residents’ requests,” said Supervisor Malia Cohen. “Investing in body cameras for our police force, and providing additional resources for the Office of Citizens’ Complaints are proactive and measurable steps towards strengthening community trust in the police.”

“San Francisco is embracing, acknowledging and promoting 21st Century policing policies every day,” said Chief Suhr. “More sworn officers, additional training, greater civilian oversight, and the use of body cameras on all our sworn officers will help protect the people of San Francisco and at the same time create a greater sense of community trust as police officers do the job they have sworn to do.”

Mayor Lee’s hiring plan will accelerate the hiring of 250 new police officers over the next two years. This will include two additional academy classes at a cost of \$10.2 million in FY15-16 and \$11.1 million in FY16-17. This proposal will allow the City to meet its mandatory staffing requirement of 1,971 officers in June of 2017, a full year ahead of schedule.

Additionally, the Mayor’s proposed budget will fund four new staff at the Office of Citizens Complaint (OCC) to fully fund OCC’s budget request which

*includes a new investigator, a senior investigator, attorney and a technician assistant.*²

At the conclusion of its June budget hearings, the Board of Supervisors Budget and Finance Committee forwarded the proposed City and County of San Francisco 2015/2016 and 2016/2017 two year budget to the full Board of Supervisors for first reading at its July 14, 2015 meeting.³ Pursuant to Charter, Section 9.100(b), time period for the Board of Supervisors to finally adopt the Budget was no earlier than July 15th nor later than August 1st.

III. INVESTIGATION OF CASES

A. Case Inventory

By the end of the 2015 second quarter, the OCC opened 167⁴ new cases, and closed 162 cases. During this period, the OCC opened 5 more cases than it closed. The OCC closed the quarter with 361 pending cases, which are 39 more pending cases than the close of the second quarter in 2014. By the end of the 2015 second quarter, there were 248 cases from 2015, 109 pending cases from 2014, two from 2013, and two cases from 2011. Between January 1, 201, and June 30, 2015, the OCC opened 347 cases, closed 321 cases and sustained 27 cases.

B. Caseloads and Disposition of Cases

With only 13 investigators assigned full caseloads the second quarter of 2015 and 16 investigators assigned full caseloads the second quarter of 2014, caseloads were higher than best practices both years.⁵ In the second quarter of 2015, the caseload was 33 cases per investigator versus 23 cases per investigator in the second quarter of 2014. Comparing the second quarters of 2014 and 2015, the average number of days to close cases increased by 12% from 170 to 190. The OCC's goal is to conclude its investigations within 270 days. During the second quarter of 2015, OCC investigators closed 162 cases with 71% of them closing within 270 days and only six of them, which had no sustainable allegations, took more than a year to close. This differs by six percent from 2014 where of the 172 cases closed, 80% of them were closed within 270 days. The average number of days to close sustained cases also increased, but only by 3% from 291 days to 299 days. In working to better manage the OCC's challenging caseload, the OCC is continuing to focus on closing sustainable cases

sooner. However, with three less investigators in the second quarter of 2015 than the second quarter of 2014, reducing case closure time remained elusive.

C. Sustained Cases

The number of sustained cases in the second quarter of 2015, 19, is three more than the 16 sustained cases the second quarter of 2014 and is a 12% sustained rate. In the second quarter of 2015, 42% or eight of the sustained cases closed within nine months which is similar to the closure time in the second quarter of 2014, where 44% of sustained case closures occurred within nine months. Combining the eight sustained cases in the first quarter with the 19 in the second quarter, the half year sustained rate is 8% compared to 7% as of June 30, 2014.

The ongoing impediments to prompt completion of sustained cases are attributable to at least four factors: 1) Larger than best practices caseloads for investigators resulting in longer times to complete investigations, 2) Several high profile and complex investigations, 3) active trial calendars for the two prosecuting attorneys who also serve as advice attorneys on sustained cases and sustainability reviews and 4) increased policy work for the policy analyst attorney who also serves as an advice attorney on sustained cases and sustainability reviews.

During the second quarter of 2015, there were sustained allegations of neglect of duty in 17 of the 19 sustained complaints, or 89% of them. Seven of the complaints were sustained in whole or in part for neglect of duty for failure to collect traffic stop data.

The sustained allegations during the second quarter were as follows:

1. Unwarranted action
 - Wrongful detention and arrest of a bicyclist on a sidewalk by plainclothes officers in an unmarked vehicle.
2. Conduct reflecting discredit:
 - a. In violation of DGO 2.01, General Rules of Conduct, Rule 14, an officer yelled at the complainant and used profanity.
 - b. In violation of DGO 10.08 and Department Bulletin 13-165, an officer used a Department computer to conduct personal business on behalf of his parents.
 - c. In violation of DGO 2.01, General Rules of Conduct, Rule 9, an officer while off duty and in civilian clothes, invoked his status as a police officer to address a noise complaint on behalf of his parents by saying, "You know I'm a cop, right?"

- d. The officers filed false charges against the complainant for violations of Penal Code section 148(a) (1).
 - e. In violation of DGO 2.01, sections 9 and 14, in response to the complainant's profane fighting words, the officer flexed his muscles and replied to the complainant with profane fighting words.
3. Neglect of duty for:
- a. In violation of Vehicle Code section 23123 and Department Bulletin 13-135, an officer used his cell phone for a personal call while driving his personal vehicle.
 - b. In violation of DGO 7.01, an officer left the juvenile complainant's handcuffs unadjusted for up to 90 minutes after the complainant said his handcuffs were too tight.

Another officer prepared an incomplete and inaccurate incident report in violation of DGO 7.01, the Department's report writing manual and Department Bulletin 13-185 and 14-020.

In violation of DGO 1.04 (2) (a), a sergeant failed to properly supervise.

- c. In violation of DGO 5.03 section II. Paragraph A. subsection 2, an officer failed to issue a certificate of release and prepare an incident report after handcuffing and detaining the complainant for 40 minutes, then releasing the complainant.
- d. In violation of Department Bulletin 13-091, an officer failed to collect traffic stop data.
- e. In violation of Department Bulletin 14-059, an officer failed to collect traffic stop data.
- f. In violation of Department Bulletin 14-059, an officer failed to collect traffic stop data.
- g. In violation of Department Bulletin 14-059, an officer failed to collect traffic stop data.
- h. In violation of DGOs 2.01, rule 19, 1.03, 6.15 and 5.03, officers failed to properly investigate a bicycle theft, failed to book the

bicycle into evidence, failed to book into evidence the City of San Francisco construction vest worn by the suspect, failed to prepare an incident report and failed to issue a certificate of release after detaining and releasing the suspect.

- i. In violation of Department Bulletin #13-194, officers failed to document in the incident report that the arrested juvenile had received a Know Your Rights for Youth brochure.

The officers' sergeant failed to properly supervise by approving the insufficient incident report.

- j. In violation of DGO 5.04, an officer failed to prepare an incident report after determining there was insufficient evidence for a private person's arrest.
- k. In violation of DGO 5.04, an officer failed to prepare an incident report after the complainant requested a private person's arrest, but refused to sign the citizen's arrest form.
- l. In violation of DGOs 2.01 and 1.03, officers failed to meet with the complainant and write an incident report in response to a 911 call from the complainant that he had been threatened by someone with a handgun.
- m. In violation of DGO 2.01, an officer transposed two numbers of the complainant's license plate causing the complainant's car to be towed before contacting complainant.
- n. In violation of DGO 5.08, plainclothes officers in an unmarked vehicle conducted a traffic stop of a bicyclist on the sidewalk for a minor traffic violation. The officers failed to call for a marked vehicle.

In violation of Department Bulletin 13-091, officers failed to collect traffic stop data.

The officers' sergeant failed to properly supervise.

- o. In violation of Department Bulletin 14-059, an officer failed to collect traffic stop data.

- p. The officer's sergeant failed to properly supervise the officer when the sergeant, who was standing close to the officer, did not intervene and either stop or correct the officer's behavior.
- q. In violation of DGO 5.08, plainclothes officers in an unmarked vehicle conducted a traffic stop for the complainant's seatbelt violation.

The officers failed to call a marked unit for backup. In violation of DGO 5.05, the officers engaged in a pursuit of the complainant without notifying Dispatch.

In violation of Department Bulletin 13-091, the officers failed to collect traffic stop data.

4. Unnecessary force:

Officers used unnecessary force when arresting the complainant.

D. Sustained Findings for Failure to Collect Traffic Stop Data

In the second quarter of 2015, officers failed to collect traffic stop data in 7 of 19 cases with sustained findings or in 37% of cases with sustained findings. In the first quarter of 2015, there were no cases with sustained findings for failure to collect traffic stop data and in the second quarter of 2014, four of the 12 complaints with sustained neglect of duty findings, or 33% of them were for failure to collect traffic stop data.

The Chief of Police is imposing progressive discipline for officers who repeatedly fail to collect traffic stop data. The discipline generally begins with an admonishment for the first offense, but for repeated offenses, the Chief of Police has recommended that the OCC prepare charges for him to file with the Police Commission.

Dr. Lorie Fridell in her 2007 study on Fair and Impartial Policing in San Francisco discusses the importance of accurate data collection should a department determine that it will collect traffic stop data.⁶ The Northeastern University Racial Profiling Data Collection Center cites several benefits of collecting stop data for both

law enforcement and the community. The Center has found that collecting data about those who are stopped, searched, cited and arrested can⁷:

- Send a strong message to the community that the department is against racial profiling and that racial profiling is inconsistent with effective policing and equal protection
- Build trust and respect for the police in the communities they serve
- Provide departments with information about the types of stops being made by officers, the proportion of police time spent on high-discretion stops, and the results of such stops
- Help shape and develop training programs to educate officers about racial profiling and interactions with the community
- Enable the development of police and community dialogue to assess the quality and quantity of police-citizen encounters
- Allay community concerns about the activities of police
- Identify potential police misconduct and deter it when implemented as part of a comprehensive early warning system
- Retain autonomous officer discretion and allow for flexible responses in different situations

E. Chief of Police's Adjudication of OCC Sustained Cases

When the OCC Director forwards a sustained case to the Chief of Police, she can either recommend that the Chief of Police file charges with the Police Commission and after meeting and conferring with the Police Chief the OCC Director can file charges on her own with the Police Commission if the Police Chief declines her request. Alternatively, the OCC Director can determine that a case warrants ten days or less of suspension. Sustained cases that the OCC Director determines would warrant no more than ten days of suspension are adjudicated by the Chief of Police. The Chief of Police determines whether or not to sustain the OCC's findings and what discipline to impose. During the second quarter, the Chief of Police adjudicated eight OCC sustained cases as follows:⁸

- **Neglect of duty and Conduct Reflecting Discredit** – In violation of Department General Order 2.01, an officer engaged in discourteous conduct. In violation of Vehicle code sections 21100.3, 23123, and Department Bulletin 13-135, Use of Cellular Phones, an officer used his cell phone while driving. Chief Suhr found improper conduct for the cell phone use. **The officer is retired.**

- **Neglect of duty** – In violation of Department General Order 7.01, an officer, failed to adjust a juvenile’s handcuffs after the juvenile complained they were too tight. Another officer violated DGO 7.01 for preparing an incomplete incident report that omitted significant details and information about the juvenile’s detention, arrest and custody. In violation of Department General Order 1.04 and SFPD’s Report Writing Manual, a sergeant failed to recognize the inadequacy of the incident report. **The officers and sergeant received written reprimands and were retrained.**
- **Conduct reflecting discredit** – An officer violated Department General Order 10.08 when he used a department computer to email the complainant warning the complainant about the complainant’s conduct. **The officer was admonished and retrained.**
- **Neglect of duty** – In violation of Department General Order 5.04, an officer failed to prepare an incident report documenting that he did not find cause to facilitate a citizen’s arrest. **The officer was admonished and retrained.**
- **Conduct reflecting discredit** – An officer engaged in misconduct and abused his authority as a police officer while off duty and out of uniform by reminding an individual with whom he was having a dispute, “I am a cop.” **The officer received a written reprimand and was retrained.**
- **Neglect of duty** – In violation of Department General Order 5.03, an officer failed to issue a certificate of relief after detaining, handcuffing and releasing the complainant. **The officer was admonished and retrained.**
- **Neglect of duty** – An officer failed to collect traffic stop data. **The officer was admonished and retrained.**
- **Neglect of duty** – In violation of Department General Order 5.03, an officer failed to issue a certificate of release after detaining, handcuffing and releasing the complainant. **The officer was admonished and retrained.**
- **Neglect of duty** – An officer failed to collect traffic stop data. **The officer was admonished and retrained.**

- **Neglect of duty** – An officer failed to collect traffic stop data. **The officer was admonished and retrained.**
- **Neglect of duty** – An officer failed to collect traffic stop data. **The officer was received a written reprimand and was retrained.**
- **Conduct reflecting discredit** – Officers violated Department Bulletin 13-194 when they failed to document in the incident report the juvenile arrested for fighting another juvenile had received a “Know Your Rights for Youth” brochure. **The officers were admonished and retrained.**
- **Neglect of Duty** – In violation of Department General Orders 1.03 and 6.15, an officer failed to properly investigate the theft of a bicycle and failed to properly process property. In violation of Department General Order 5.03, an officer failed to issue a certificate of relief after detaining, handcuffing and releasing the complainant. **The officer received a written reprimand and retraining.**
- **Neglect of Duty** – In violation of DGO 5.04 an officer failed to prepare an incident report when he declined to take a person into custody pursuant to a request for a private person’s arrest. **The officer received a written reprimand and retraining.**
- **Unwarranted Action** – An officer caused a car to be wrongfully towed because the officer transposed numbers and entered an incorrect license plate number. **The officer was admonished and retrained.**
- **Neglect of Duty** – Two officers failed to meet with the complainant and prepare an incident when the complainant called 911 to report that a man had threatened to shoot him. **The officers received written reprimands and retraining.**
- **Neglect of Duty** – In violation of DGO 5.04 an officer failed to prepare an incident report when he declined to take a person into custody pursuant to a request for a private person’s arrest. **The officer received a written reprimand and retraining**
- **Neglect of Duty, Unlawful Detention, Filing False Charges and Failure to Properly Supervise** – In violation of Department General Order 5.08 plainclothes officers made a traffic stop of a bicyclist riding

his bicycle on the sidewalk. The bicyclist's conduct did not meet the exceptions to the general prohibition against plainclothes officers making traffic stops. Those exceptions include the officer engaging in an activity related to an ongoing investigation or regulated vehicle enforcement, e.g. taxicabs, shuttle buses or limousines or when the officer witnesses an aggravated situation requiring immediate action to protect life or property, e.g. drunk driving. Moreover, even if the stop had met the exceptions, the officers failed to call for a marked backup unit. The officers also failed to collect traffic stop data. **The officers received written reprimands and retraining.** Chief Suhr did not concur with additional sustained allegations including unlawful detention, filing false charges, and failure to properly supervise.

- **Conduct Reflecting Discredit and Failure to Properly Supervise** – An officer used profane and threatening language when detaining the complainant and the sergeant who was at the scene did not intervene or correct the officer's conduct. **The officer received a written reprimand and retraining.** Chief Suhr did not concur that the sergeant engaged in misconduct.

IV. COMPLAINTS OF NOTE

A. **Officer-Involved Shootings**

At the end of the second quarter 2015, the OCC continued to investigate two officer-involved shootings which resulted in the death of the suspects.

B. **Single Room Occupancy Hotels**

The OCC continued to investigate two complaints filed in 2011 involving multiple officers regarding unlawful entries and searches of single room occupancy (SRO) hotel rooms. Other allegations in these complaints include unlawful search of persons, unlawful detentions and arrests, failure to properly process property including laptops and cameras, failure to investigate, failure to supervise and inappropriate behavior.

C. **San Francisco Police Department Crime Lab**

The OCC continued to investigate a complaint from a sexual assault victim who complained about SFPD's failure to promptly process evidence.

D. **Officer-Involved Discharge During Vehicle Pursuit**

The OCC continued to investigate a complaint regarding a vehicle pursuit where an officer discharged his firearm at the suspect during the pursuit.

E. **Domestic Violence Resulting in Woman's Death**

The OCC continued to investigate a complaint regarding a San Francisco woman who was shot and killed by her ex-boyfriend before he fatally turned the gun on himself. The woman was shot in her home where there had been calls for help involving the same address.

F. **Wheelchair Incident**

The OCC continued to investigate a complaint regarding an alleged mistreatment of a physically disabled man in a wheelchair in Visitacion Valley. The interaction between the police and the disabled man was captured on video.

G. **San Francisco Public Defender's Arrest at the Hall of Justice**

The OCC continued to investigate complaints regarding an arrest of a Public Defender that occurred at the Hall of Justice.

H. **Racist and Homophobic Text Messages By Members of the San Francisco Police Department**

The OCC continued to investigate a complaint regarding racist and homophobic text messages by members of the San Francisco Police Department.

I. **Baby Bjorn Bicycle Incident**

The OCC continued to investigate a complaint regarding a father accusing San Francisco police officers of wrongfully arresting him and forcibly taking his 10-month-old son from him after stopping him for riding his bike with his child strapped to his chest in a Baby Bjorn infant carrier.

J. **SFPD Department General Order 8.10, Guidelines For First Amendment Activities**

The OCC received a complaint regarding a man questioned by a Federal Bureau of Investigation (FBI) Agent and a member of the San Francisco Police Department regarding a Freedom of Information Act (FOIA) request that the man had filed concerning his recent travel issues. The complaint alleges among other things violations of Department General Order 8.10 and biased policing prohibitions.

K. **Complaint Filed by a San Francisco Department Head Against an SFPD Lieutenant**

In the second quarter 2015, the OCC received a complaint from a San Francisco Department Head regarding an alleged battery committed by an SFPD lieutenant during a meeting.

V. STATUS OF CURRENT OCC CASES – THE ‘KEANE’ REPORT

By the end of the 2015 second quarter, staff had completed intake on all its 2014 cases and had closed 85% of them, leaving 15% of the 2014 cases pending. At the end of the 2014 second quarter, staff had also completed intake on all its 2013 cases, and had closed 89% of them, leaving 11% of the 2013 cases pending.

VI. LEGAL UNIT

Four attorneys staff the OCC’s Legal Unit under the supervision of Executive Director Joyce Hicks. Attorneys Ines Vargas Fraenkel and R. Manuel Fortes are the OCC’s two trial attorneys but they also conduct sustainability reviews and review sustained reports for form and legality, prepare legal opinions and manage records requests including subpoenas, Pitchess motions and Sunshine Ordinance and Public Records Act requests. Attorney Donna Salazar staffs the OCC’s mediation and outreach programs and her work is outlined in sections VII and VIII of this report. Attorney Samara Marion conducts the OCC’s policy work and also conducts sustainability reviews and reviews sustained reports for form and legality. Her policy work is outlined in section IX.

The OCC’s trial attorneys prosecute police misconduct cases in matters investigated and determined by the OCC to be misconduct or failure to perform a required action. They present cases to the Police Chief when officers object to proposed discipline of up to ten days suspension. They present cases before the Police Commission when the proposed discipline is greater than ten days suspension up through termination.

During this second quarter, the Legal Unit did not present any cases on appeal by an officer at the Chief’s Hearing level.

As part of their duties, the Legal Unit’s two trial attorneys also review and edit sustained reports after a matter has been investigated and one or more allegations are deemed sustainable. During the second quarter, the Legal Unit reviewed, revised, and submitted five sustained reports, each of which involved one or more sustained allegations against one or more officers. They also provided legal opinions for five complaints. Additionally, they advised staff on a subpoena duces tecum.

VII. MEDIATION

During the second quarter 2015, the OCC mediated seventeen cases compared to thirteen in 2014. At the end of the second quarter, the OCC has mediated twenty-nine cases compared to thirty during the first six months of 2014.

In 2015, there was an increase in officer participation. During the first half of 2015, two officers or 5% declined to meet. In the first half of 2014, five officers, or 9% declined mediation. The mediation coordinator continues to document the numbers and circumstances of officers who decline to meet. The responses indicate that officers who decline, do so because of the circumstances of the particular case and/or the complainant rather than a reluctance to participate in the program.

During the second quarter of 2015, the Coordinator served as a grant reviewer for the National Association for Community Mediation (NAFCAM) and the Judicial Arbitration and Mediation Services (JAMS). The coordinator was previously contacted regarding the proposed mini-grant program to promote conflict resolution services between local community mediation programs and local law enforcement. In that capacity she worked with colleagues in ADR, civilian oversight, and law enforcement from around the country.

The mediation program continues to provide a forum for officers and civilians to have a frank discussion regarding the complaint, as well as serves as an educational experience for all participants.

VIII. OUTREACH

During the second quarter of 2015, the OCC was engaged in local outreach activities as well as networking with other agencies on a state and national level.

During the second quarter, the Executive Director Hicks testified at two Board of Supervisors Public Safety Committee meetings, on how recruitment of a diverse SFPD workforce, implicit bias and diversity training for SFPD officers, body worn cameras for SFPD officers and enhancements to the OCC's budget could contribute to increasing public trust in the San Francisco Police Department.

Beginning in January and continuing through the second quarter, the Director and Attorney Manuel Fortes met monthly as members of the Bar Association of San Francisco Criminal Justice Task Force.⁹ Director Hicks and Attorney Fortes serve on

Each committee has undertaken a comprehensive examination of current practices of the San Francisco Police Department and the surrounding bay area law enforcement agencies. A bipartisan and thorough analysis of best practices,

the civilian oversight subcommittee and Attorney Fortes also serves on the data collection subcommittee.

On April 17, 2015, Director Hicks appeared on KQED NEWSROOM's televised show entitled "Public Trust in SFPD Shaken."¹⁰ Director Hicks joined San Francisco Supervisor David Campos, Police Chief Greg Suhr, District Attorney George Gascón, San Francisco Public Defender Matt Gonzalez, and Officers for Justice President and SFPD Sergeant Yolanda Williams to discuss issues within the police department ranging from the bigoted text messages to management of the crime lab.

The Deputy Director and Senior Investigator Sherry Fletcher taught a class of cadets at the San Francisco Police Academy in May. Investigators Sara Maunder and Kacy Green participated in a career fair for youth in San Francisco. This event was sponsored by Mo' MAGIC and SFPD and also honored recipients of Mayor Lee's "I am the Future" Scholarship Awards.

Mediation Coordinator Donna Salazar met with community organizations regarding upcoming outreach activities for the fall. She also attended a Peninsula Conflict Resolution function on improving public safety in communities. Ms. Salazar and Staff Attorney Manuel Fortes staffed a table at San Francisco's Juneteenth Festival. Ms. Salazar and other OCC staff members attended the Public Defenders' Justice Summit on Race and Reform, and the District Attorney's Summit on Law Enforcement, Race, and Justice.

In May, OCC Policy Attorney Samara Marion gave a talk on strategies and solutions to minimize trauma to children of arrested parents to law enforcement and social service agencies during a conference hosted by Alameda County Children of Incarcerated Parents Partnership.

On June 10, 2015, Director Hicks presented the OCC's 2014 Annual Report, the 2014-15 Strategic Outreach Report and Plan, as well as a report on OCC's customer satisfaction surveys. In June, Director Hicks, Deputy Erick Baltazar Director, and Policy Attorney Samara Marion met with a delegation of twenty-five Indian government officials who were attending the Goldman School of Public Policy.

They provided a presentation on OCC's history, investigative and policy-making roles, which fostered a lively comparison of policing in India and the United States.

In June, Ms. Marion made a presentation entitled, "The Office of Citizen Complaints and Its Collaborative Role in Police-Community Relations" during a hearing before the Mayor's Disability Council on police interactions with individuals with mental illness and cognitive disorders. Ms. Marion also attended the opening exhibit "The Sentence Unseen: Portraits of Resilience" at Alcatraz that featured visual and performance art by youth impacted by their parent's incarceration. Ms. Marion also participated in a roundtable discussion on "Ending Violence Against Women and Girls" sponsored by the San Francisco Department on the Status of Women and It's Time Network.

The OCC's informational, mediation and Youth Know Your Rights' brochures were translated into Braille this quarter. OCC staff also provided brochures and complaint forms to La Raza Central Legal, the La Raza Community Venter, Community United Against Violence, two offices of the Mission Resource Center, the Instituto Laboral de la Raza, Arriba Juntos, the SF Public Defender's office, the Mayor's Office of Neighborhood Services, the ACCESS Center, the Jewish Vocational Center, Asian Pacific Islander Outreach, the Asian Law Caucus, Chinese for Affirmative Action, Horizons Unlimited, the Bernal Neighborhood Center, as well as the ten District Police Stations.

The OCC continues to be a resource for oversight agencies statewide and nationally. Agencies frequently consult with OCC staff regarding its unique model of civilian oversight, its police-citizen mediation program, and its policy work regarding juveniles, language access, and most recently, children of arrested parents.

IX. POLICY ANALYSIS

Policy work is an essential aspect of the Office of Citizen Complaint's mission. The San Francisco City Charter requires the OCC to present quarterly recommendations concerning SFPD's policies or practices that enhance police-community relations while ensuring effective police services. Attorney and policy analyst Samara Marion leads the OCC's policy work. Policy work during the second quarter focused on language access and children of arrested parents protocols.

Throughout the second quarter, the OCC continued its language access policy work. The OCC meets monthly with domestic violence and sexual assault service providers, language access advocates, city agencies, Police Commissioner Sonia

Melara, and the Police Department, a practice the OCC initiated in 2012 to enhance language access services. The OCC recommended that the Department establish a written procedure for the timely translation of statements from Limited English Proficient victims, witnesses and suspects. The OCC is working with the Police Department to issue a Priority “A” Department Bulletin on this topic. The OCC also worked with the Police Department on a survey for Department General Order 5.20 training to enable officers to evaluate language access services and the training video developed by the Language Access Working Group.

Ms. Marion presented the OCC’s policy work on children of arrested parents on two webinars during the second quarter. On June 3, 2015, Ms. Marion joined SFPD Chief Greg Suhr on an Urban Institute Webinar entitled “Promising and Innovative Practices for Children of Incarcerated Parents: Arrest through Pre-Adjudication.” Over 300 attendees listened to the panel. Participants included correctional officers, academics and representatives from the media, social services and community organizations from across the country.¹¹

In conjunction with this webinar, the Urban Institute released their report on “Children of Incarcerated Parents Framework Document: Promising Practices, Challenges, and Recommendations for the Field” a culmination of their study of the San Francisco Bay Area and two other study sites. This report includes the OCC’s role in establishing SFPD’s permanent parent arrest protocol and officer training video. The Urban Institute also released a “Toolkit for Developing Parental Arrest Policies” which includes the collaborative work the OCC initiated to establish SFPD’s permanent parent arrest policy.¹²

On June 15, 2015, Ms. Marion was also a presenter on a webinar entitled “Developing a Policy to Protect Children of Arrested Parents” that the International Association of Chiefs of Police hosted in collaboration with the Bureau of Justice Assistance, Office of Justice Programs and the U.S. Department of Justice. Ms. Marion joined Chief Suhr, Nell Bernstein (author and co-founder of San Francisco Children of Incarcerated Parents Partnership), and two youths from Project WHAT (an organization for youth whose parents are incarcerated) to discuss a collaborative approach to developing and implementing a parent arrest policy.¹³

Last, Ms. Marion's article entitled "Civilian Oversight as Bridge-Builders: Collaborating with Communities and Police To Develop Trauma-Reducing Procedures for Children of Arrested Parents" was published by the National Association of Civilian Oversight of Law Enforcement (NACOLE) in its Summer 2015 NACOLE Review.¹⁴

X. CONCLUSION

Despite budget and staffing constraints the OCC remained committed to its mission to investigate civilian complaints of police misconduct or failure to perform a duty promptly, fairly, and impartially.

The named officer stated that Department General Order 2.04 instructs officers that “a Citizen Complaint form shall not be completed when the complainant is a member of the Department or is a representative of another police department or government agency. Instead, prepare a memorandum specifying the nature of the complaint and forward it to the accused officer’s commanding officer.” The DGO 2.04 instruction that an OCC complaint form shall not be completed when the complainant is a representative of a government agency conflicts with the OCC’s jurisdiction as established in San Francisco City Charter §4.127. San Francisco City Charter §4.127 states that the OCC shall investigate “all complaints of police misconduct, or that a member of the Police Department has not properly performed a duty except those complaints which on their face clearly indicate that the acts complained of were proper and those complaints lodged by other members of the Police Department.” Moreover, Penal Code §832.7 requires that a “department or agency shall release to the complaining party a copy of his or her own statements at the time the complaint is filed.” Thus, regardless of the OCC’s jurisdiction to receive and investigate the complainant’s complaint, Penal Code §832.7 requires the police department to provide a complainant a copy of his or her own statement at the time the complaint is filed.</p> <p>The OCC recommends that the Police Department issue a Priority A Department Bulletin that instructs officers to comply with Penal Code §832.7 and provide complainants a copy of their statement at the time the complaint is filed.</p>

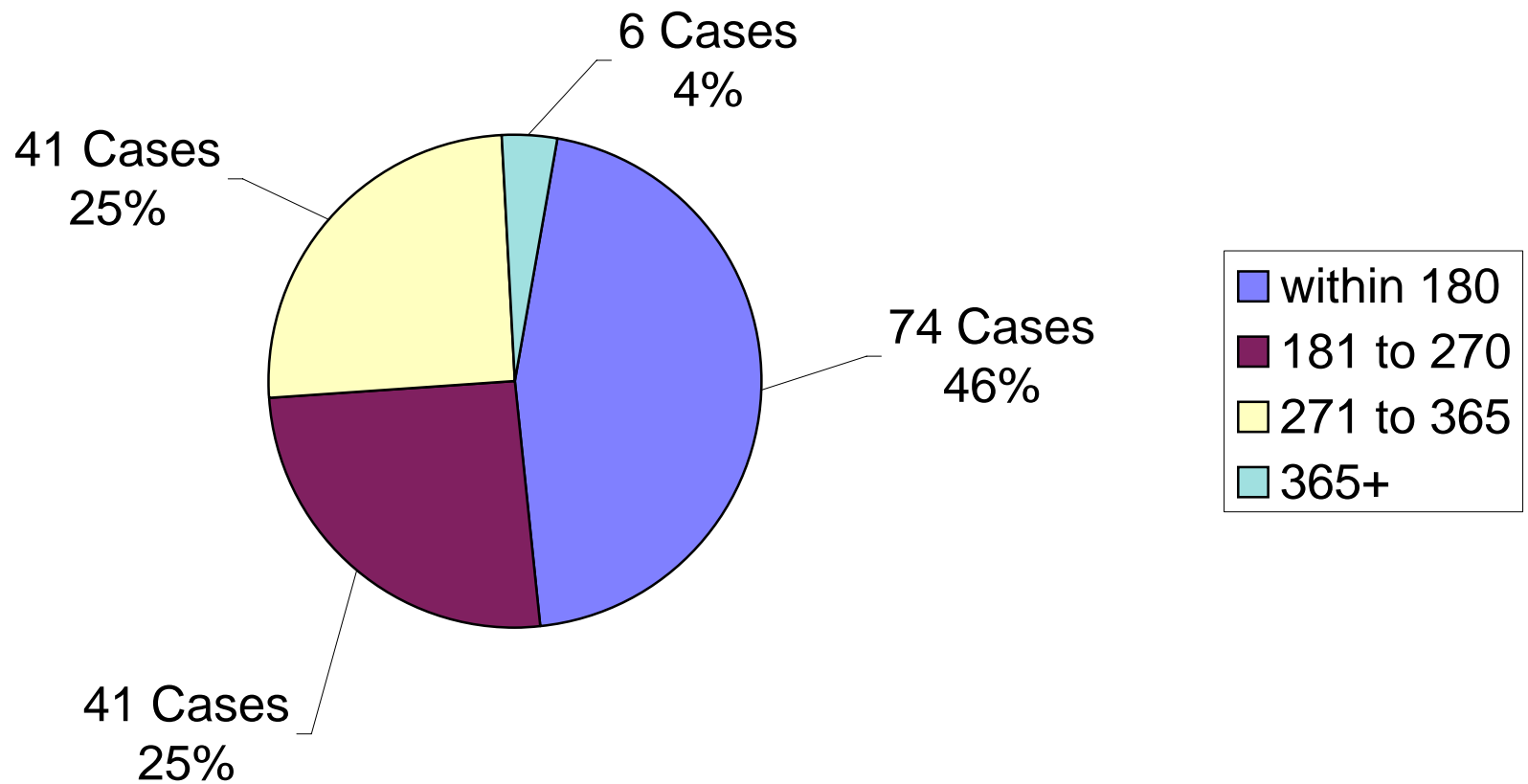

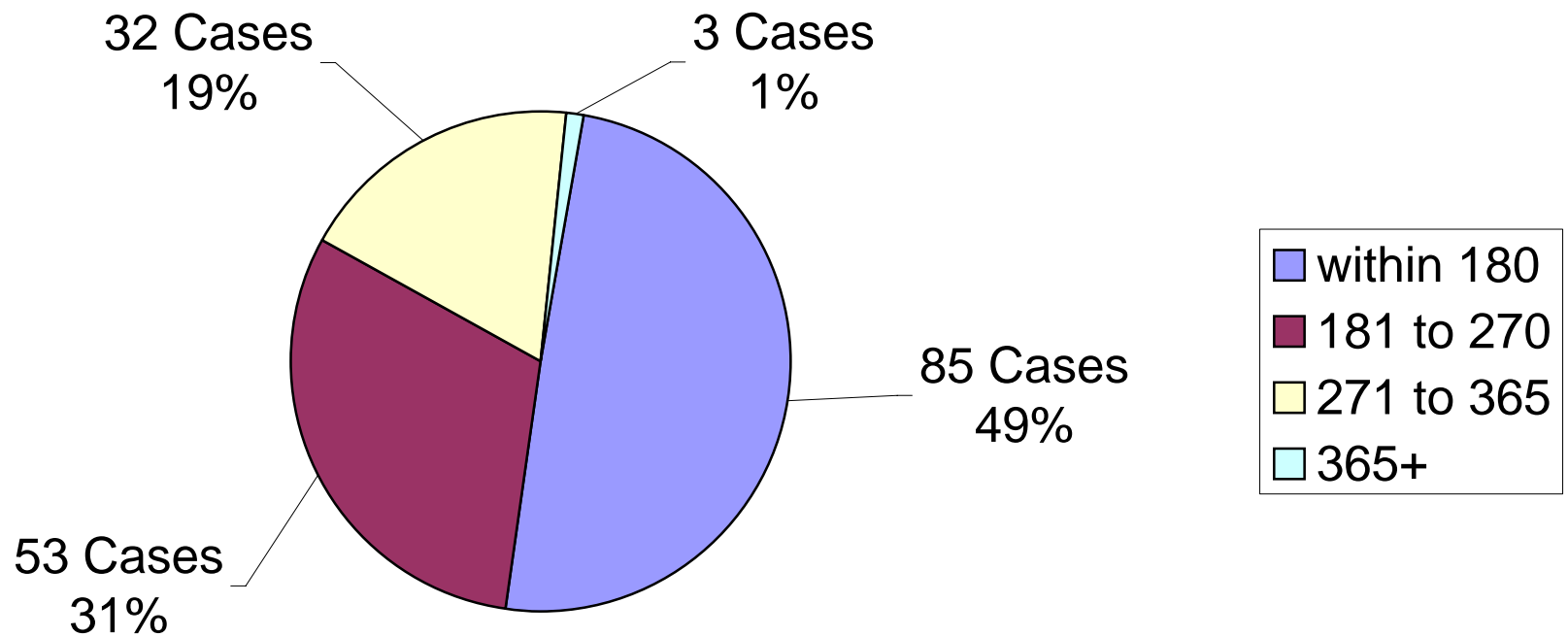

Days to Close - Cases Closed Second Quarter 2015



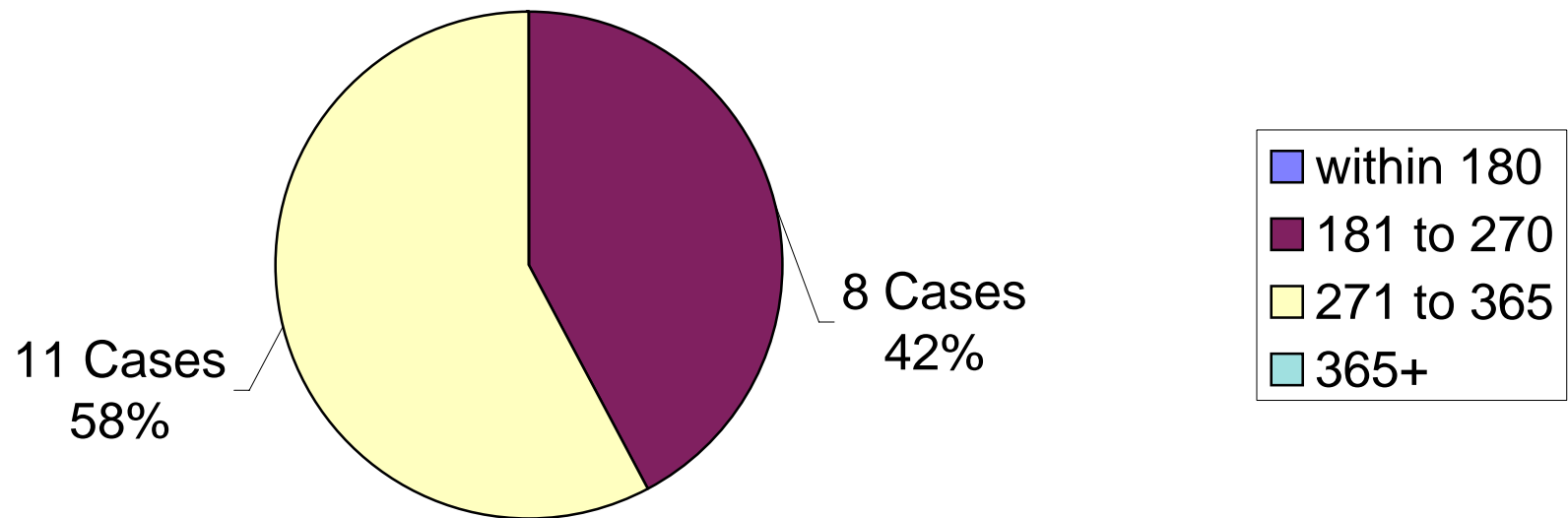

Days to Close - Cases Closed Second Quarter 2014



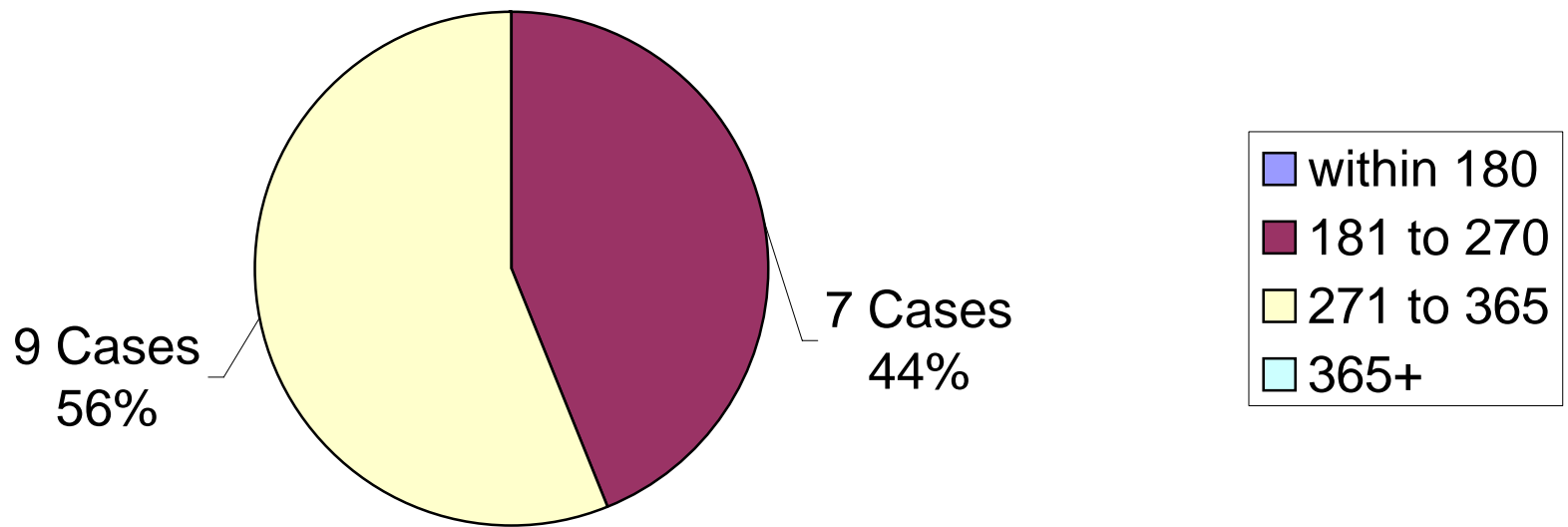

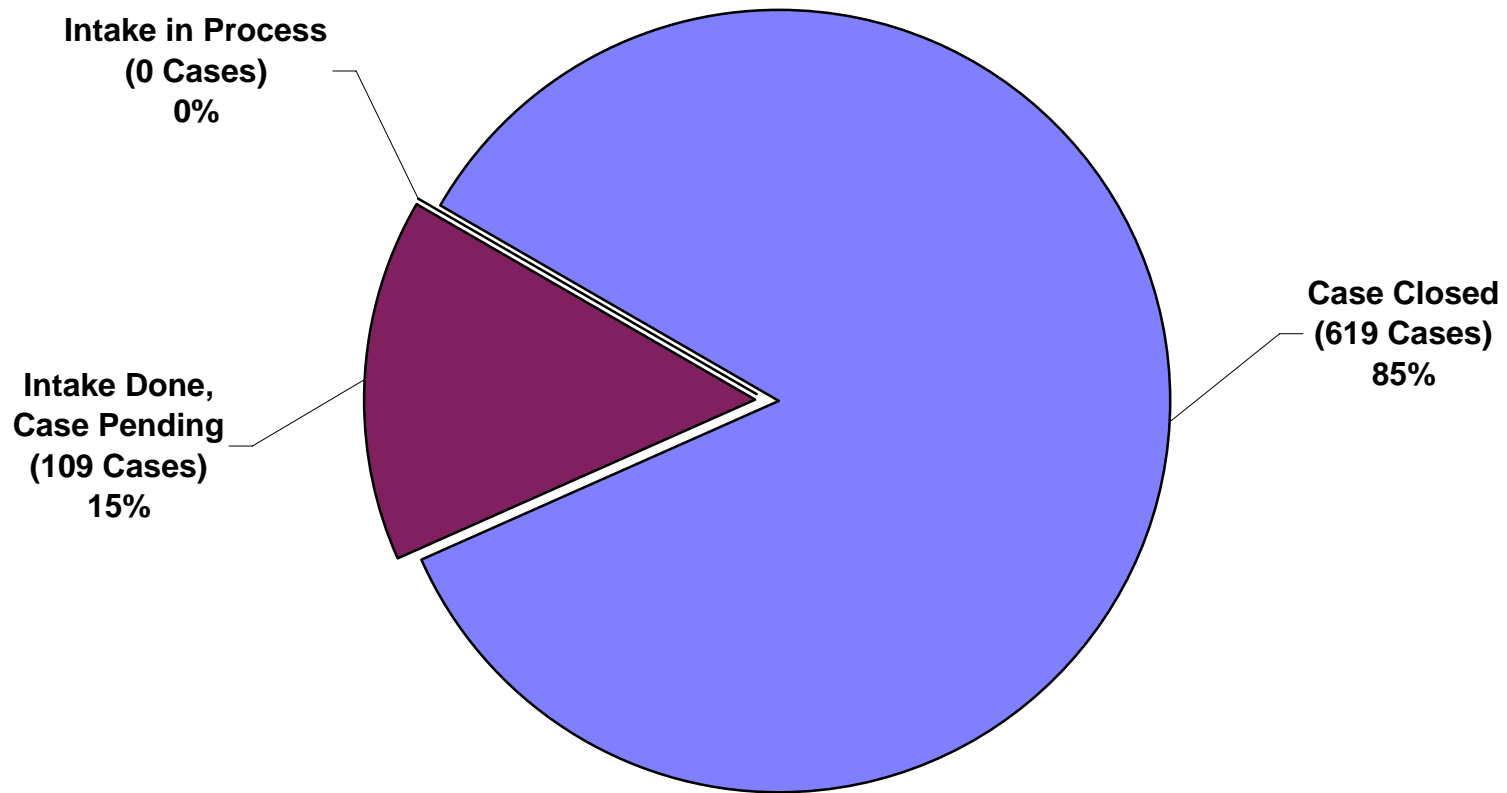

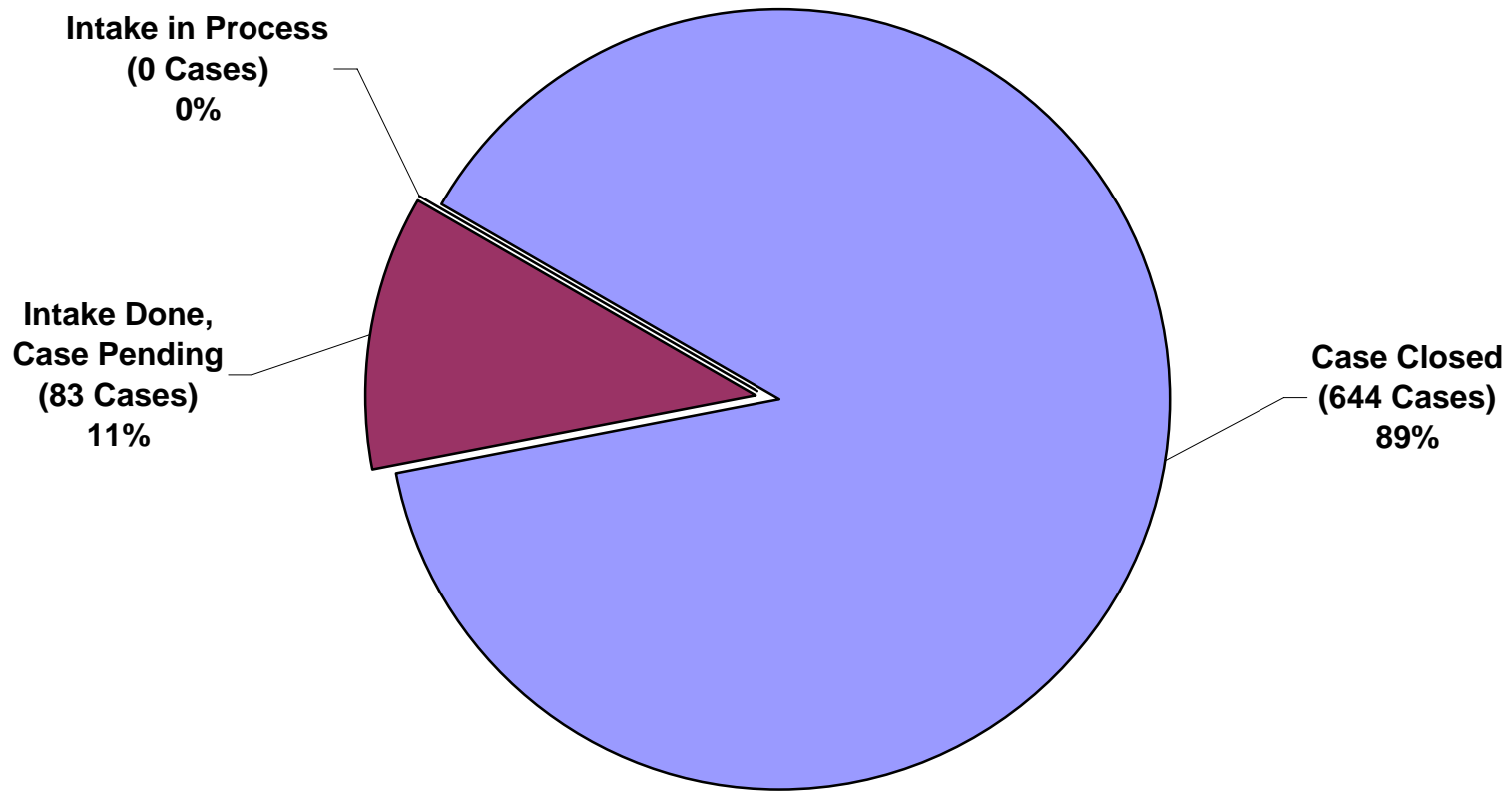
Status of OCC Cases - Year 2014

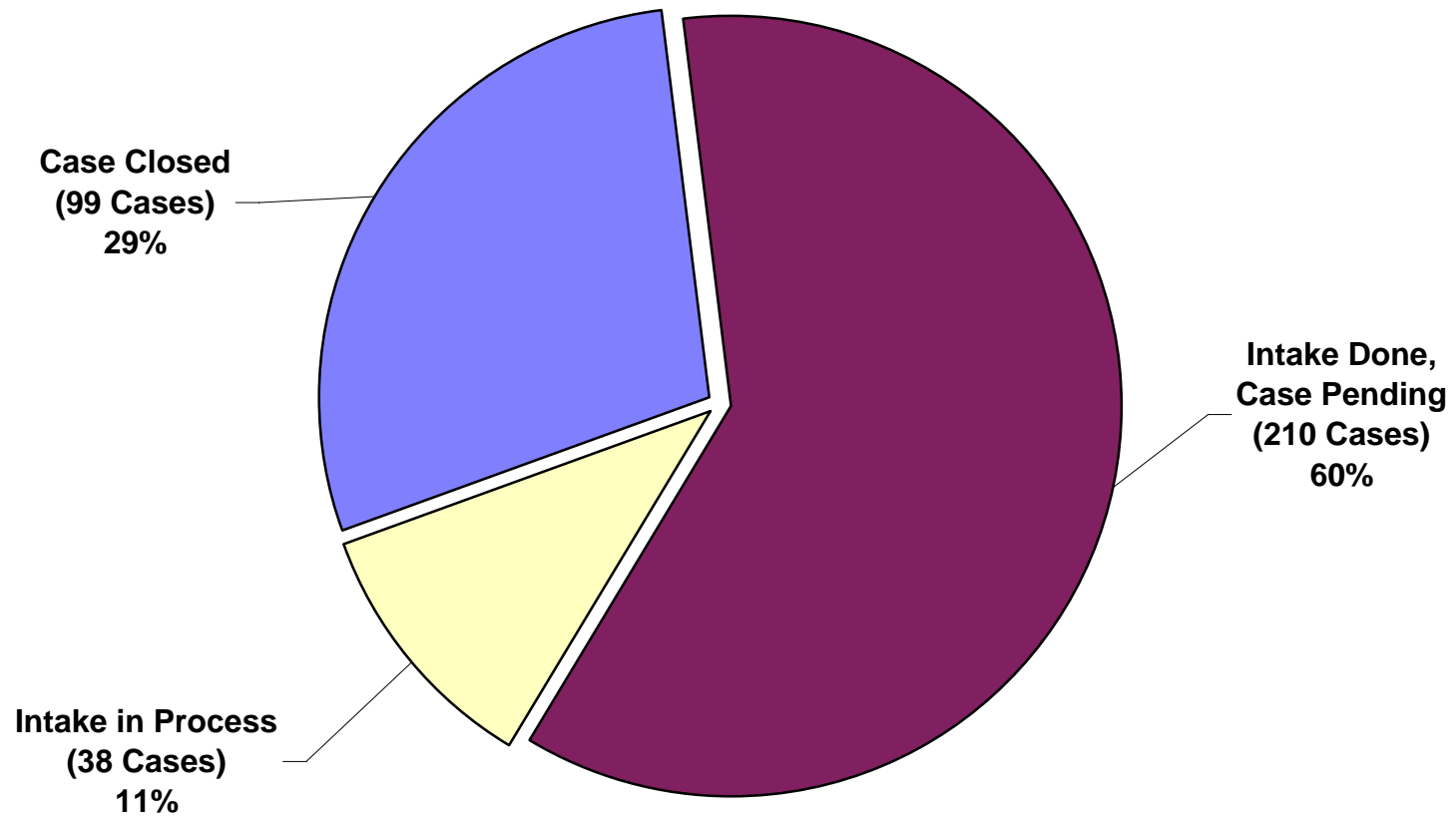

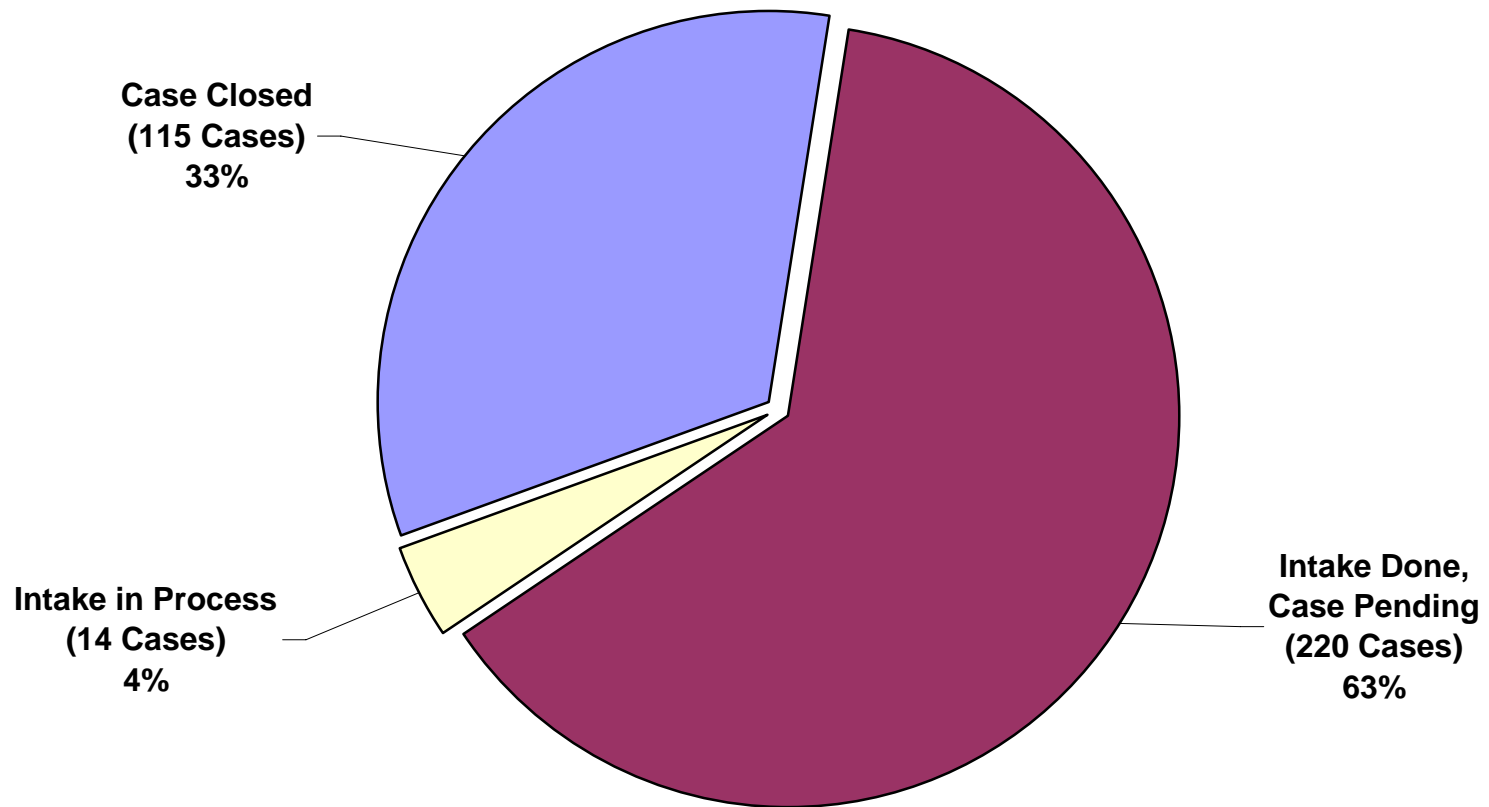
Status of OCC Cases - Year 2015

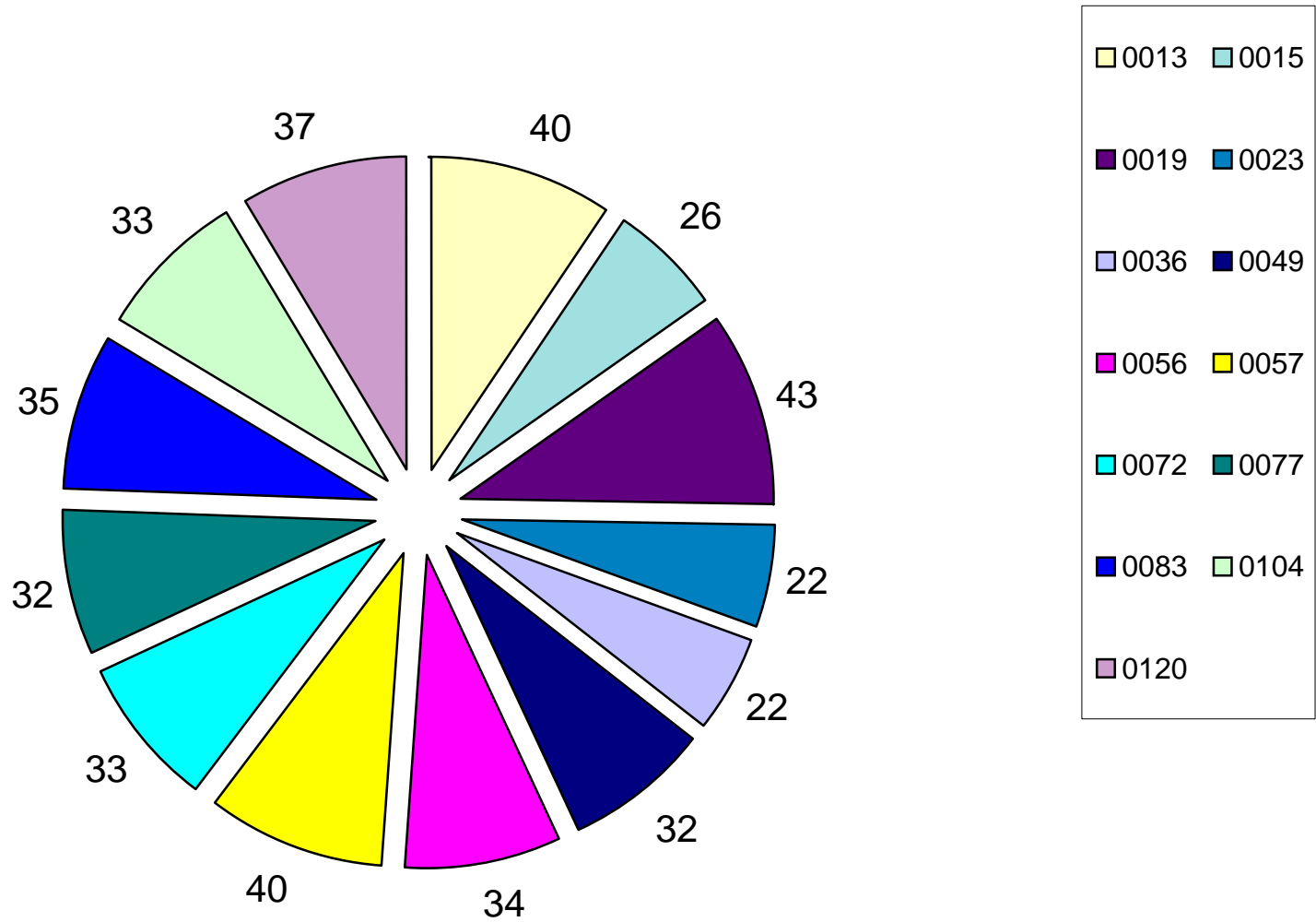

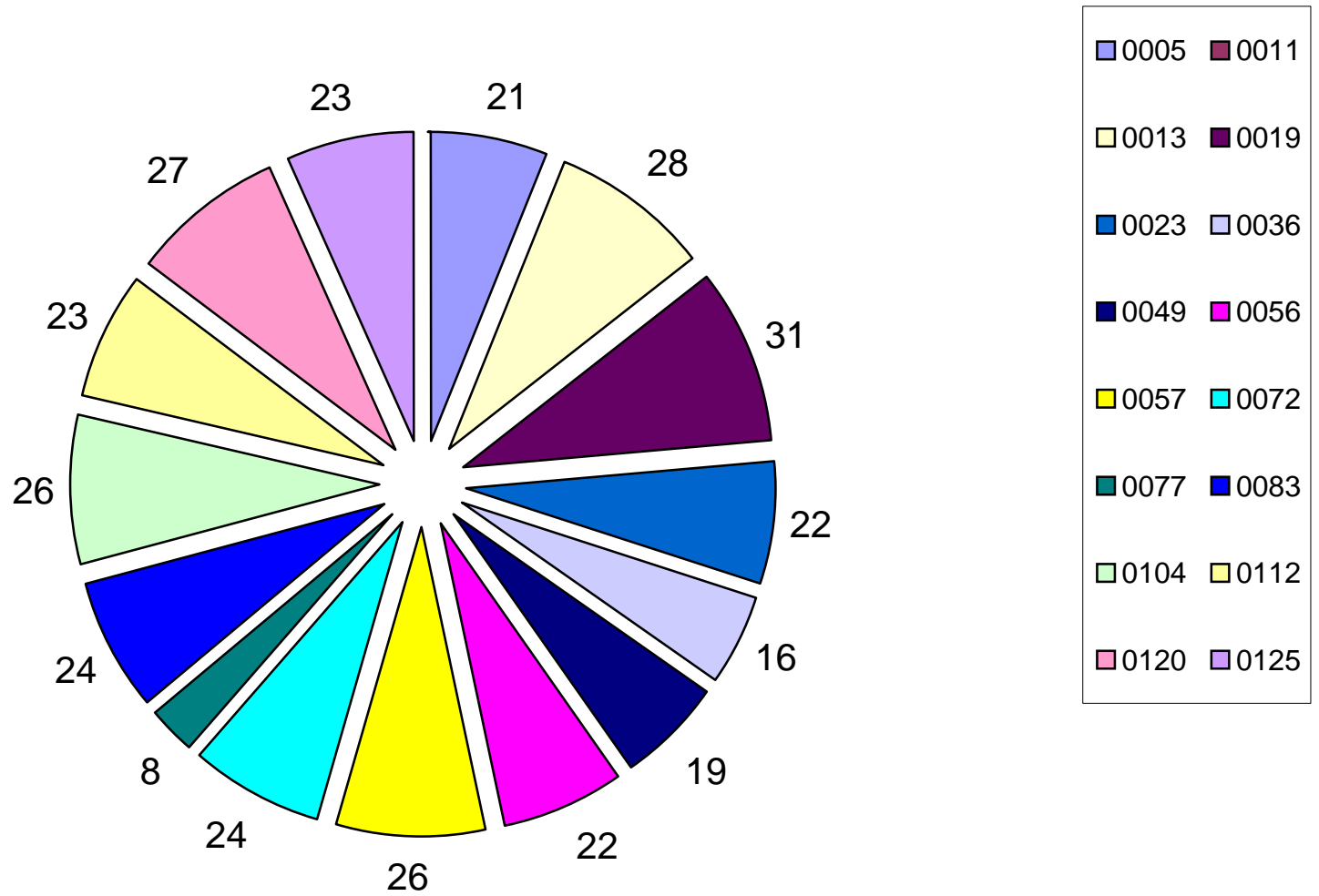

OCC Caseloads by Investigator as of 06/30/2015



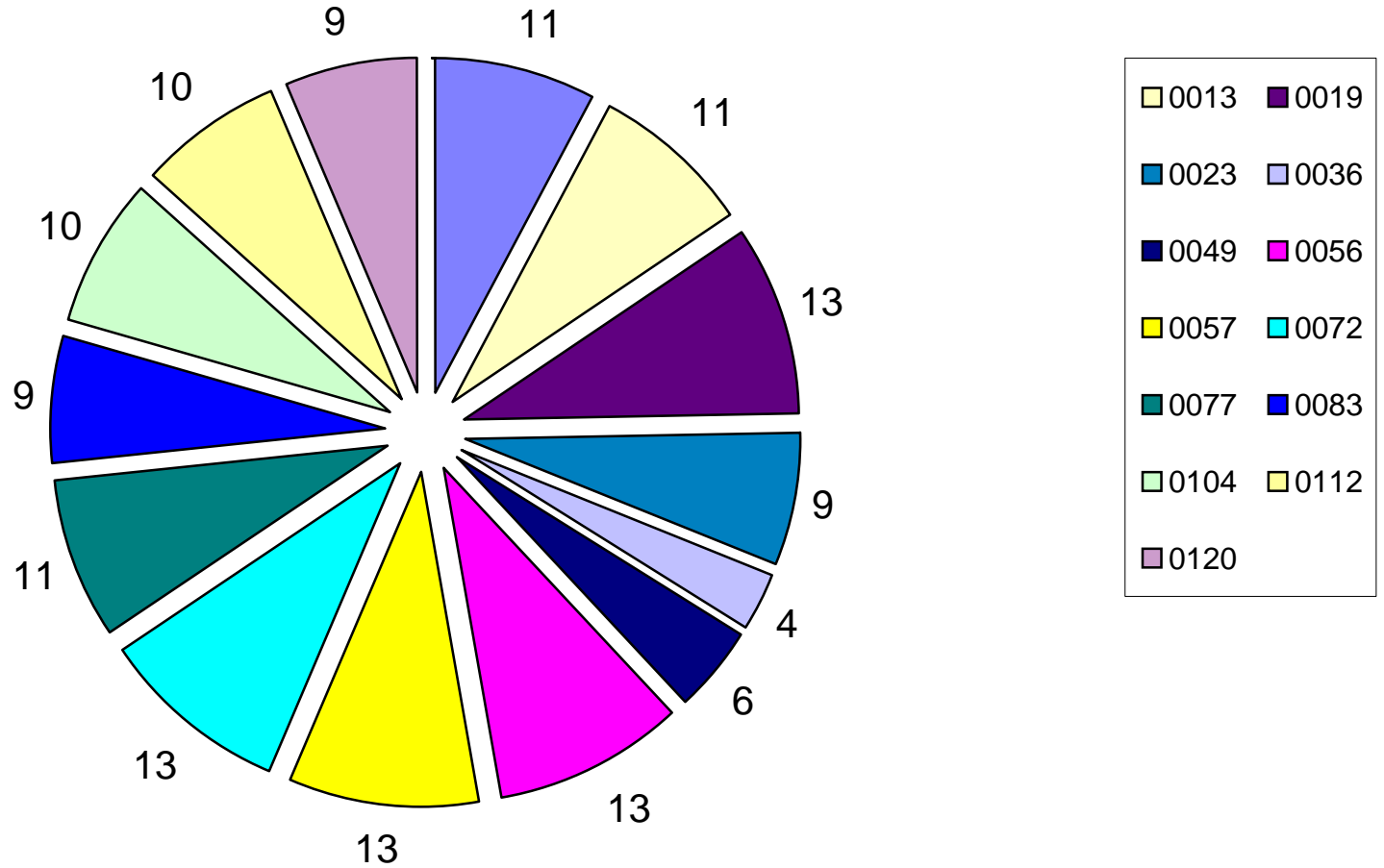

OCC Caseloads by Investigator as of 06/30/2014



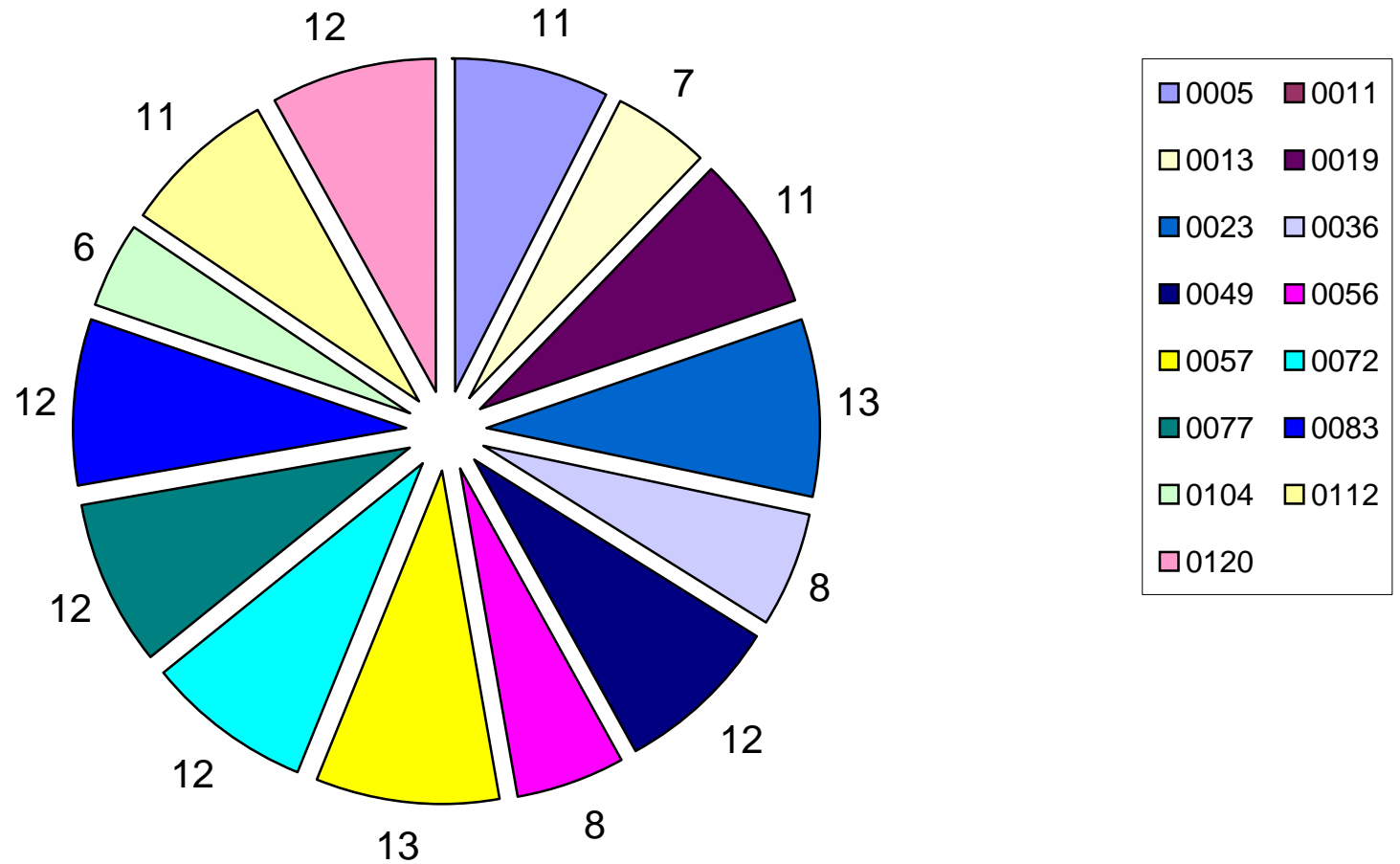

OCC Case Closures - Second Quarter 2015 by Investigator



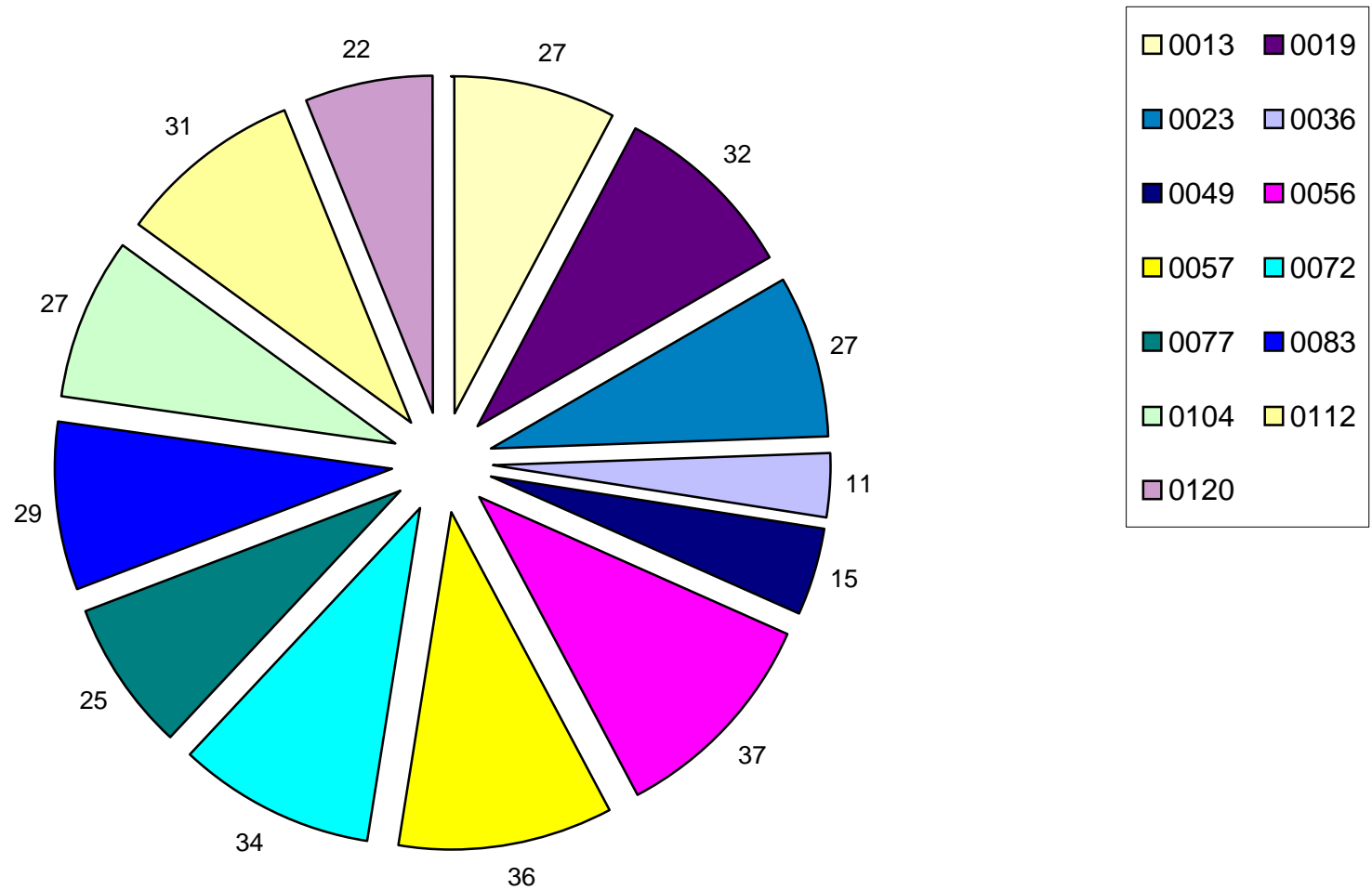

Average Case Closures by Number: 11 or 3 cases per month per investigator

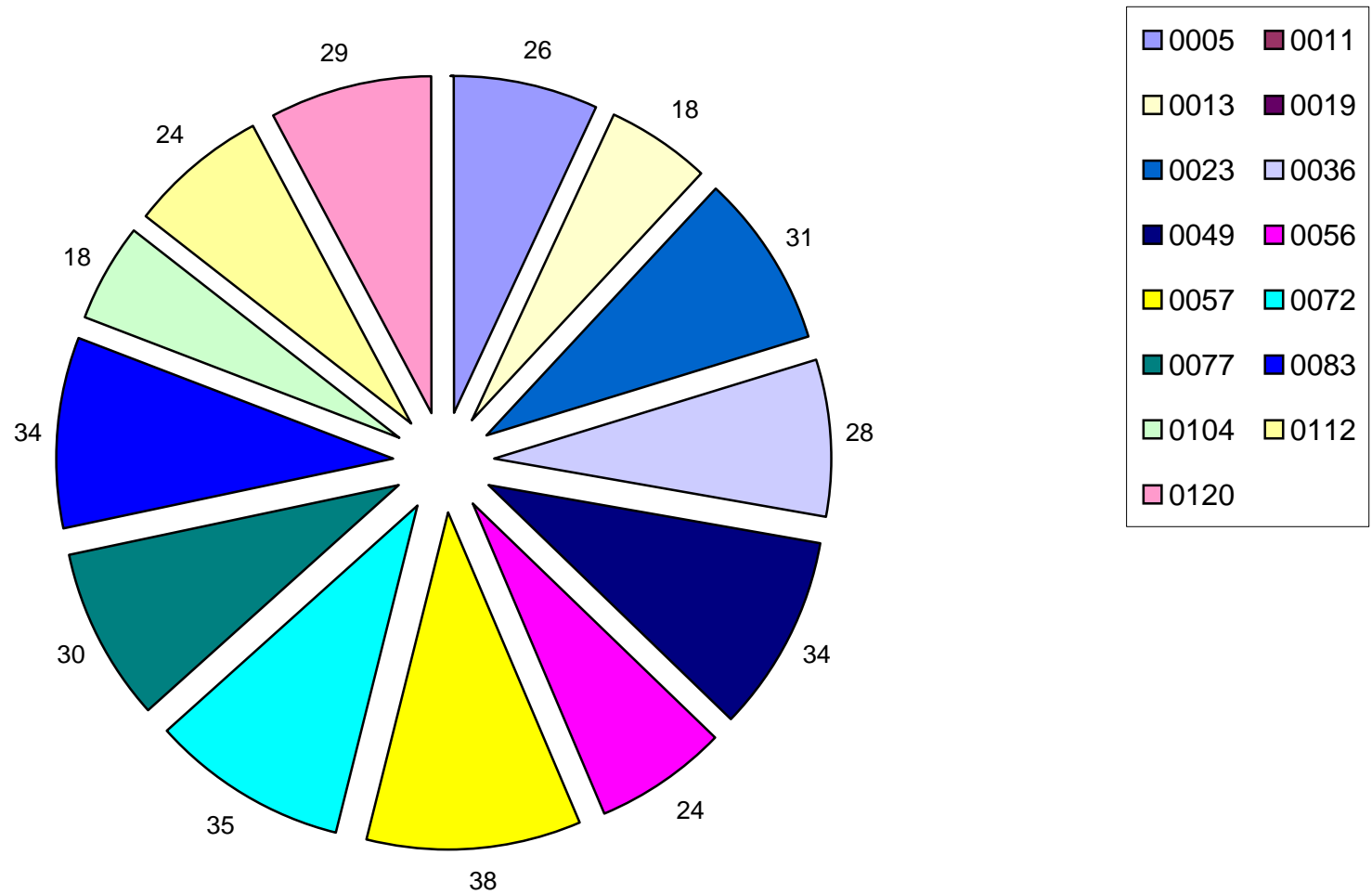
OCC Weighted Closures - Second Quarter 2015 by Investigator

CASE COMPLEXITY WEIGHTED ON A 1 TO 5 SCALE

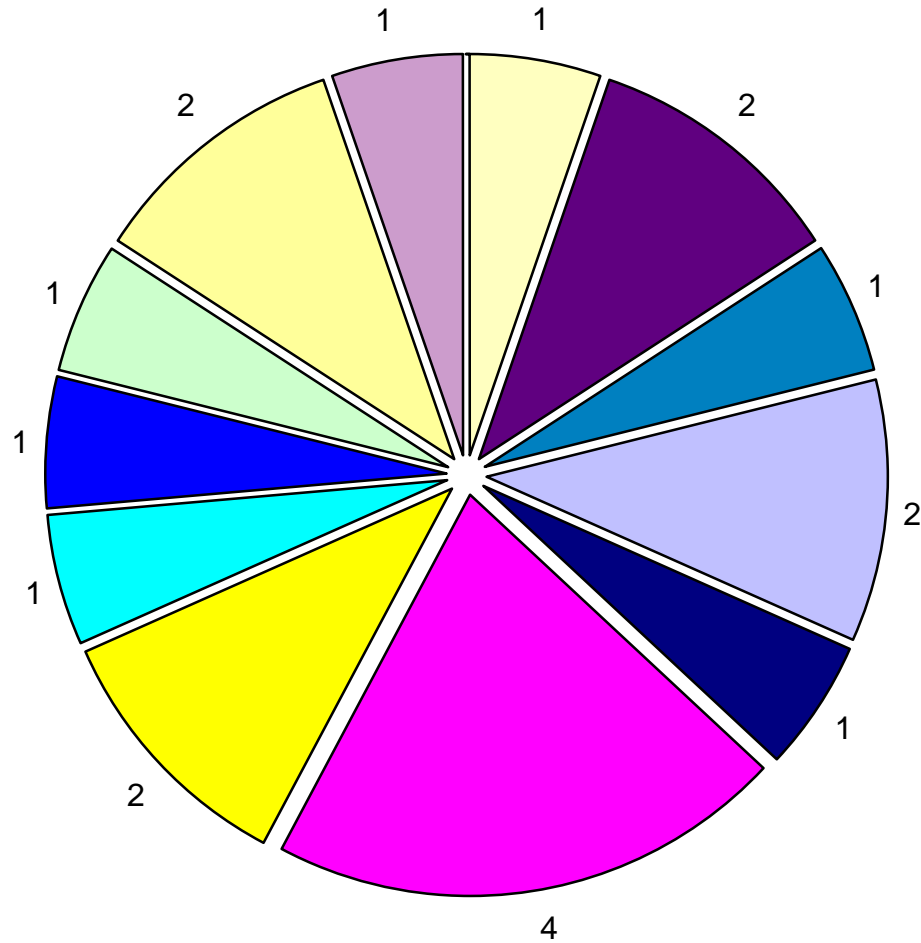
OCC Weighted Closures - Second Quarter 2014 by Investigator



Average Case Closure by Weight: 30

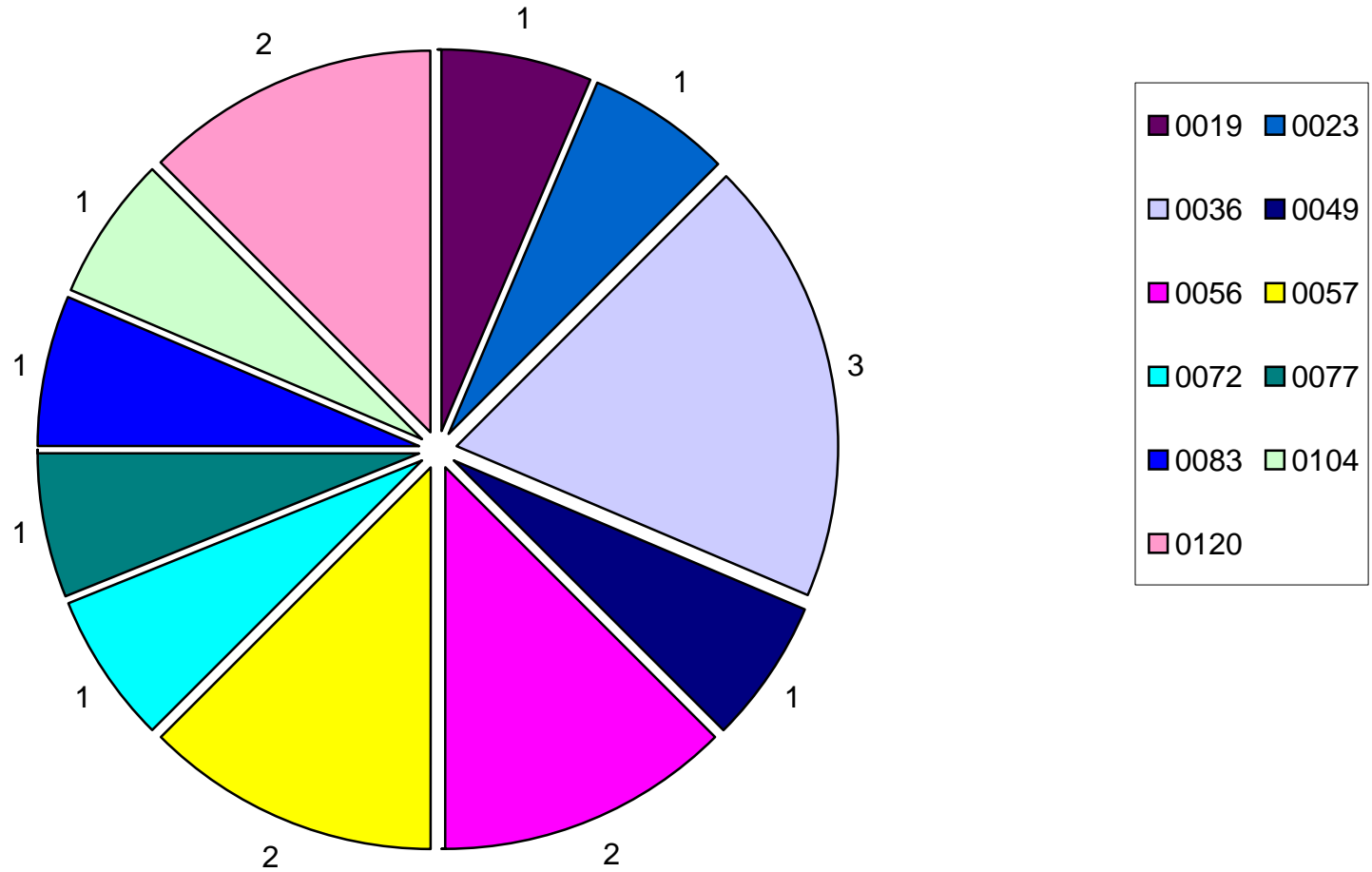
