## A. COMPLAINT POLICY & PROCEDURE

# A. DEPARTMENT OF HOMELESSNESS AND SUPPORTIVE HOUSING Emily Cohen 15 min

Emily Cohen provided an update from the Department of Homelessness and Supportive Housing, which included a presentation on the Department's accomplishments in its first year. Emily Cohen and Member Kimura had a discussion about the new HSH office and resource space. Emily Cohen and Member Hall discussed health services available inside Navigation Centers and how the public can provide input on proposed Navigation Center policies.

  Member Ward presented the Department of Homelessness and Supportive Housing
  (DHSH) Report, which included:
  - Shelter Vacancy Report
  - Shelter Turn Away Report-Family Shelter-Hamilton Emergency
  - Family Waiting List-Connecting Point
  - Winter Shelter for Single Adults and Families
- C. STANDARD OF CARE STAFF REPORT Committee Staff 10 min
  Committee staff reviewed the June 2017, Standard of Care Staff report. Committee
  staff Jeff Simbe presented on a pending investigation into the lights being left on at
  Bethel AME at night. Chair Mukami suggested documenting the situation and sending it
  to the HSH Contract Monitor. Member Bilbro thanked Committee staff for going out to
  the site late at night to investigate the allegations. Committee staff Howard Chen
  presented on the investigations that were completed in June. Members Bilbro and James

requested that allegations that cannot be confirmed with evidence be inconclusive instead of in or out of compliance.

**Public comment:** Cynthia Lee stated that she has seen health and safety violations take place at Next Door shelter. Cynthia Lee also stated that she requested that the shelter review security footage of the incident but had that request denied.

**Public comment:** Ann Jones asked if the Committee was going to do anything about the lights at Bethel AME besides sending the investigation findings to the HSH Contract Monitor.

**Member comment:** Chair Mukami stated that it wasn't OK for the site to leave lights on at night, but because the church is contracted with the City to provide services that it is up to the City to hold the church accountable to their contract.

**Member comment:** Member Ward stated that the City does not have a contract with Bethel AME church, it is the shelter provider that has a contract with the church.
