II. OLD BUSINESS

DISCUSSION/ACTION

A. PSSMC 082016-1: Shelter Bed Utilization

SMC Chair Mukami 10 min

The Subcommittee had a discussion on whether or not Shelter Utilization should be an issue that the Subcommittee takes a closer look at. Members Amick and Mukami discussed how the Committee has continued to receive complaints from clients regarding empty beds at various shelters. Member Mukami stated his concerns that there are many different policies factoring in on how the different shelter beds (senior beds, disability beds, VA, GA, etc.) are handled. Chair McCoy shared his concern that it might not be possible to have an overall policy

The Subcommittee discussed the history of the Shelter Training Manual. The Subcommittee stated that their priority would be to create a list of recommendations for the new department on sections of the manual that need to be updated or new sections that need to be created as well as identifying any supplemental documents or trainings that were also used to train shelter staff. *Explanatory documents – Shelter Training Manual*

B. PSSMC 082016-3: Revision of Site Inspections, Procedures, and Reports Chair McCoy 10 min

The Subcommittee discussed the possibility of revising site inspection procedures and reports. Member Hall stated her view that it would be beneficial to include a narrative section on the site visit forms for Committee members to write down their opinions. Members Steen and Bohrer stated that they both already include similar notes on the existing site visit forms. Members Steen and Mukami stated their concerns that including an expanded narrative section on the site visit forms would allow personal biases to be introduced and because the narratives could potentially address topics that are outside of the Standards of Care. Subcommittee Chair McCoy stated that this topic would be tabled for the time being.
