Regular Meeting

Members: Dean Schmidt (Chair), Laura Stein and Saul Sugarman

1. CALL TO ORDER, ROLL CALL, AND AGENDA CHANGES (00:49:55 - 00:52:33)

Chair Schmidt called the meeting to order at 5:33 p.m. On the call of the roll Chair Schmidt, Member Stein and Member Sugarman were noted present. A quorum was present.

There were no agenda changes.

4. **File No. 20008**: Complaint filed by Ann Treboux against Dwight Moore and the Office of the City Attorney, for allegedly violating Administrative Code (Sunshine Ordinance), Sections 67.25 and 67.27, by failing to respond to an Immediate Disclosure Request in a timely and/or complete manner. (01:07:04 – 01:47:55)

Ann Treboux (Petitioner) provided a summary of the complaint and requested the Committee to find a violation. Ms. Treboux stated that over 10 days passed after submitting an Immediate Disclosure Request, and that the requested documents have not been provided.

Jen Kwart (City Attorney's Office) (Respondent) provided a summary of the department's position. Ms. Kwart stated that the City Attorney's Office responded to Ms. Treboux request for records and all non-privileged records have been provided.

A question-and-answer period occurred.

Action: Moved by Member Stein, seconded by Member Sugarman, to find that the requested records are public, the SOTF has jurisdiction, and to refer the matter to the SOTF for consideration.

(01:48:09 – 01:52:35)

The Petitioner was not present at the meeting and did not inform the SOTF prior to the meeting.

The Respondent representative was present.

6. **File No. 23081** Complaint filed by Zahir Naseri against San Francisco International Airport (Ground Transportation Unit) for allegedly violating Administrative Code (Sunshine Ordinance), Section(s) 67.21, by failing to provide public records in a timely and/or complete manner. (01:52:52 – 02:21:18)

Zahir Naseri (Petitioner) provided a summary of the complaint and requested the Committee to find a violation. Mr. Naseri stated that he submitted a public records request for six documents but received only two of the six. Mr. Naseri stated that neither of the two documents were received within 10 days.

Doug Yakel (San Francisco International Airport) (Respondent) provided a summary of the department's position. Mr. Yakel stated that the Airport responded timely, producing all responsive and non-privileged elements on a rolling basis.

A question-and-answer period occurred.

Action: Moved by Member Stein, seconded by Member Sugarman, to find that the requested records are public, the SOTF has jurisdiction, and refer the matter to the SOTF for consideration of a timeliness violation.
