1. CALL TO ORDER, ROLL CALL, AND AGENDA CHANGES

Chair Washburn called the meeting to order at 4:40 p.m. Members Chopra, Haines, and Hyland were absent. There was a quorum.

Agenda Changes:

Brian Browne (Complainant) requested a continuance of Item No. 2 via email.

Items 5, 6 and 8 were withdrawn by Peter Warfield (Complainant).

2. **File No. 15008**: Complaint filed by Brian Browne against the San Francisco Public Utilities Commission for allegedly violating Administrative Code (Sunshine Ordinance), Section 67.21, for failure to respond to a request for public records in a timely and/or complete manner. (00:04:00 – 00:17:00)

Member Pilpel disclosed his former association with the SFPUC as a member of its Citizens Advisory Committee and stated that he does not believe that it will affect his ability to evaluate the issues in a fair and impartial manner.

Brian Browne (Complainant) was not present at the meeting, but submitted an email request to continue his complaint to a future date. Deborah Chilvers, SFPUC (Respondent) objected to the request for continuance and provided a summary of the department's efforts to satisfy the request of the Complainant.

Member Hepner, seconded by Member Hinze, moved to table the matter.

Public Comment:

Peter Warfield stated that the Task Force has not read the Complainant's email into the record and expressed support for a continuance.

3. **File No. 15094:** Determination of Jurisdiction of the Sunshine Ordinance Task Force over the San Francisco Housing Authority in regards to the complaint filed by John Kelly against the San Francisco Housing Authority for allegedly violating Administrative Code (Sunshine Ordinance), Section 67.21, for failure to respond to a public records request in a timely and/or complete manner. (00:17:00 – 01:13:00)

(The hearing on File No. 15094 is for the purpose of determining if the SOTF has jurisdiction over the San Francisco Housing Authority. If jurisdiction is found, a future hearing date will be scheduled on the merits of the complaint.)

John Kelly (Complainant) provided an overview on the issue of the Task Force's jurisdiction over the San Francisco Housing Authority. Linda Martin, San Francisco Housing Authority, provided their position that the Task Force does not have jurisdiction as the San Francisco Housing Authority is authorized to exist pursuant to California State Law.

Deputy City Attorney Colla commented on the matter.

Member Pilpel, seconded by Member Fischer, moved to find that the Task Force does not have jurisdiction over the San Francisco Housing Authority.

Public Comment:

Peter Warfield expressed support for the Complainant.

The complaint was withdrawn by the Complainant via email.

6. **File No. 15061:** Complaint filed by the Library Users Association against City Librarian Luis Herrera and the San Francisco Public Library for allegedly violating Administrative Code (Sunshine Ordinance), Sections 67.21 and 67.22, for failure to respond to public records requests in a timely and/or complete manner in regards to BiblioCommons webinar and other associated records.

The complaint was withdrawn by the Complainant by email.

7. **File No. 15081:** Complaint filed by the Library Users Association against City Librarian Luis Herrera and the San Francisco Public Library for allegedly violating Administrative Code (Sunshine Ordinance), Sections 67.21 and 67.22, for failure to respond to a request for public records in a timely and/or complete manner during normal and reasonable hours of operation, without unreasonable delay, and without requiring an appointment in regards to BiblioCommons. (01:13:00 – 01:26:00)

Member Hepner, seconded by Member Hinze, moved to find jurisdiction.

8. **File No. 15082:** Complaint filed by the Library Users Association against City Librarian Luis Herrera and the San Francisco Public Library for allegedly violating Administrative Code (Sunshine Ordinance), Sections 67.21 and 67.25, for failure to respond to a request for public records in a timely and/or complete manner during normal and reasonable hours of operation, without unreasonable delay, and without requiring an appointment in regards to BiblioCommons and other related communications.

The complaint was withdrawn by the Complainant by email.

9. **File No. 15098:** Complaint filed by Anonymous against Karen Strauss and the San Francisco Public Library for allegedly violating Administrative Code (Sunshine Ordinance), Sections 67.21 and 67.25, for failure to respond to an Immediate Disclosure Request in a timely and/or complete manner. (01:26:00 – 02:20:00)

Member Hepner, seconded by Member Hinze, moved to find jurisdiction.

Anonymous (Complainant) provided an overview of the complaint and requested the Task Force to find violations. There were no speakers in support of the Complainant. Sue Blackman, Commission Secretary, and Michael Lambert, Deputy City Librarian, Public Library (Respondent) provided a summary of the department's position. There were no speakers in support of the Respondent. A question and answer period followed. The Respondent provided a rebuttal.

Deputy City Attorney Colla commented on the matter.

Peter Warfield suggested additional violations of the Sunshine Ordinance and commented on what is a public record.

Member Pilpel, seconded by Member Hepner, moved to find a violation of Administrative Code (Sunshine Ordnance), Section 67.21(c), for failure to assist a requester in identifying the existence, form and nature of any records maintained by, available to, or in the custody of the department and whether or not the content of those records are exempt from disclosure.

Member Pilpel, seconded by Member Hepner, moved to continue the matter to the next meeting of the Task Force.

Peter Warfield stated that the amendments are bylaw changes that require noticing prior to adoption and that too much discretion is provided to the staff of the Task Force.
