#### 1. CALL TO ORDER, ROLL CALL, AND AGENDA CHANGES

Chair Wolfe called the meeting to order at 4:05 p.m. Members Chopra, Baranetsky, J. Wolf and Fischer were noted absent. There was a quorum.

There were no agenda changes.

## 2. Approval of minutes from the Sunshine Ordinance Task Force October 5, 2016, meeting.

The Task Force discussed the meeting minutes.

## Member Hinze, seconded by Member Fischer, moved to approve the October 5, 2016, meeting minutes.

3. **File No. 16062:** Complaint filed by Magick Altman against the Police Commission for allegedly violating Administrative Code (Sunshine Ordinance), Section 67.9, by failing to make supporting documents available 72 hours prior to the Police Commission's June 22, 2016, meeting (Use of Force Policy). (00:04:00 – 01:08:00)

(On September 12, 2016, the Compliance and Amendments Committee heard and referred the matter to the Task Force with the recommendation to find jurisdiction and find that a violation of Administrative Coded (Sunshine Ordinance), Section 67.9 (a) occurred for failing to post supporting documents as soon as they became available.)

## Vice Chair Hyland, seconded by Member Hinze, moved to find jurisdiction.

Public Comment: None.

Magick Altman (Complainant) provided an overview of the complaint and requested that the Task Force find violations. Ms. Altman stated that the Police Commission did not provide sufficient notice on the agenda and that the Draft Use of Force Policy was significantly changed at the last moment. Jackie Barshack and Adrian Fong spoke in support of the Complainant. Sgt. Rachael Kilshaw, Police Commission (Respondent), provided a summary of the department's position. Sgt. Kilshaw stated that there is no timeframe set in the Sunshine Ordinance for posting supporting documents online and that the amendment made to the Draft Use of Force Policy was not considered 'significant'. Sgt. Kilshaw stated that the document in question was posted as soon as they were able to accomplish the task. There were no speakers in support of the Respondent. A question and answer period followed. The Respondent and Complainant were provided the opportunity for rebuttals.

Deputy City Attorney Colla provided comments and responded to questions from the Task Force.

Upon discussion the Task Force modified motions and created separate motions to include violations of Sunshine Ordinance, Sections 67.7 (b) and 67.9 (b).

Vice Chair Hyland, seconded by Member Tesfai, moved to find that the Police Commission violated Administrative Code (Sunshine Ordinance), Section 67.9 (a), by failing to post supporting documents online as soon as they became available.

Public Comment:

Peter Warfield stated that at the time of creation of the Sunshine Ordinance the web was in its infancy and that all departments should now be able to post documents only. Mr. Warfield suggested that and addition violation of 67.9 (b).

Vice Chair Hyland, seconded by Member J. Wolf, moved to find the Police Commission in violation of Administrative Code (Sunshine Ordinance), Section 67.7 (b), by failing to reference to "explanatory documents" that have been provided to the policy body in connection with an agenda item and failing to post the explanatory documents adjacent to the agenda.

Peter Warfield thanked the Task Force and stated that the ruling would prevent parties from concealing their proposals until the last moment.
