1. Call to Order and Roll Call

The meeting was called to order at 4:41 pm. Present: Commissioners Amable, Mesler, Matz, Juarez; Absent: Commissioners Galeano, Krause; Staff present: Kiely Hosmon; There was quorum.

G. Presentation on Distribution of Prop 64 (Marijuana Legalization) Funds towards Youth Programs
Presenter: Laura Thomas, Drug Policy Alliance



Prop 64 legalized adult recreational use of marijuana and decriminalized youth use of it. 60% of revenue from sales would fund youth substance abuse and education and the state is trying to figure out where/how it is spent, exactly.

There are very few youth at the table regarding this issue of spending and wants to see how the YC can be involved with how the money is spent.

Some money will be for treatment and some prevention and is not limited to in school programs and youth is not defined, but the Direct Policy Alliance is pushing for up to 26 and emphasizing impact on TAY.

There is the connection of this money with the YC and their BPP #5 regarding TAY substance abuse.

Questions:

Commissioner Juarez-how can we help even if some of us are terming out? They could still use youth voices even if you are terming out.

Commissioner Matz-we think this falls into a BPP area, could a YC'er go and be a part of the decision making body/task force and act as liaison to YC. Anyone can come to the meetings and they are open. Staff will need to check regarding Commissioners being on a state focused body.

Commissioner Amable- is there a deadline for this funding? Marijuana sales would start about January 2018 and revenue could be collected after that however there is no deadline/timeline yet.

Commissioner Amable-is concerned about impacts in communities of color. You can't have dispensaries within 1000 feet of schools and there are very few parts of SF that can actually have dispensaries because of this rule. SF Task Force is trying to shrink the areas around schools but also don't want to have a created concentration in specific areas. They are keeping a racial and economic frame with a public health lens to this issue.

Commissioner Matz- are there laws regarding density not just around schools? No.

Commissioner Amable-this money should go to programs where dispensaries are located.

Commissioner Matz, seconded by Commissioner Juarez, made a motion of general support regarding this issue. There was no public comment and the vote was approved by acclamation.

- H. Debrief and discuss next steps from Youth Empowerment Allocation townhall and providing input on the DCYF RFP (release date: July 31, 2017)

The Commissioners want to draft a letter to DCYF as well as present at the July OAC meeting. They also want to update the youth who participated in the town hall with a draft of the DCYF letter as well as including ways that youth can get involved with putting pressure on DCYF and this important issue of funding youth organizing.

Jail visiting BPP-Adele is working on this. Commissioner Juarez knows that they should be having a meeting to convene the work group and will commit to getting this scheduled in collaboration with staff, Commissioners Matz and Mesler.

SFPD-Commissioner Mesler is good to go on being a part of community policing steering committees.

FRERO- Commissioner Amable will reach out to D6 aide and Supervisor Kim. Commissioner Matz will reach out to Commissioner Yu to reach out to D3 Peskin office. Commissioner Matz will reach out to D9 Ronen office (as well as request Sup. Ronen to also sponsor a hearing on alternatives to incarceration). Commissioner Matz will draft up an email draft for all Commissioners by Friday, June 14th of this week and will send to staff to review. Ideally, will send out these email requests early next week around Monday, June 19th.
