The meeting was called to order at 5:05 pm. All members were present.

Commissioner Mesler, seconded by Commissioner Gregory, moved to approve the agenda. There was no public comment. The motion was approved by acclamation.

#### **A. Review of 2012-17 Justice, Employment & Immigration Priorities**

Commissioner Gregory and Commissioner Mesler presented on Youth-Police relations, including:

Commissioner Mesler spoke about Children of Incarcerated Parents Priorities, including:

Commissioner Franet reviewed the Commission's past priorities on alternatives to incarceration, including:

Commissioner Mesler was elected committee vice chair with votes from the following commissioners: Vigil, Gregory, Franet. Commissioner Mesler voted for Commissioner Vigil.
