B. Discussion and Debrief on CA ID Waiver Research

Commissioners reviewed their research and found:

-we'll have to go the route of CA IDs and not SF IDs

-we want to waive all the money and not just a portion (\$30)

-we still need to get the accurate number of 16, 17, and 18 year olds in SF. Basic research shows that there are 8656 15-17 year olds in SF and 6478 18-19 year olds in SF. This does not include



homeless youth numbers. Could roughly cost \$454,020 but that includes the numbers for 15 and 19 year olds so we still need a total of what this could potentially cost

-Would undocumented youth want to be considered in this? Or would it put them in the system and be a potential target by federal government?

-Need more information on social security numbers and undocumented folks

C. Updates on Priority Areas

Josh gave an update on the pre reg project in SFUSD. Has finished draft of implementation plan and will be sending to SAC for their notes/plans, and then will have the Department of Elections look at it.

Kiely will work on getting presenters to the meeting to see how DACA fee waivers worked and if we can follow a similar process.

D. BPP Timeline and Roles

Four BPPs will be written on:

- 1) CA ID fee waivers for youth (Felix lead, Owen co-lead)
- 2) Immigration issues (Conna lead, Paola and Owen co-lead)
- 3) Vote16 2020 (Arianna lead, Josh co-lead)
- 4) SFUSD Voter Pre Registration Lessons in American Dem classes (Josh lead, Felix co-lead)

Timeline:

Feb 7th until Feb 21st: do research (read old BPPs, look at YC website, research legislation from BOS if it supports or provides info on what the City is doing on your particular issue, read the news, get quotes from other youth, etc.)

Feb 21-March 7th: Create rough draft and bring to CEI meeting on March 7th

March 7th: at CEI meeting use committee time to make changes/edits and get/give feedback on drafts

March 14th: first draft due to get in full YC agenda for March 19th

Jarrett will advise and support on all BPP documents and will make sure everyone follows the timeline.
