Appreciate both Nora & Amara for consistently asking specific committees to speak up. Let's bring back that doc & highlighting the advice that the YC can give. From my experience, it feels uncomfortable to ask a question on something you dont know about. I think it's important to state that as a baseline...tips on how to ask questions based on what the presentation gives you...who are you reaching out to? - recurring questions bc they aren't always covered in the presentation.

Commissioner Zhang: the awkward pauses aren't that awkward bc i

Staff Truong: i need a more transparent conversation about live tweeting - update on our IG - we need more follow up for presentations - like EXEC can send reminders

Staff Estrada: maybe we can lean on committee chairs & include this in our general updates portion in the committee updates during FYC

Commissioner Santos: its kinda hard...for participation i support it, but my capacity feels hard...i wish i knew how this landed for other folks

Staff Estrada: maybe this can happen within the buddy system..how's that going?

Commissioner Zhang: last time we talked about it was during MYR

Commissioner Santos: i have taken a step back bc my buddy (erika) has been going through personal life.

Commissioner Asfaw: I had a temporary buddy during the MYR, but Commissioner Murphy didn't want a buddy so I haven't reached out.

Commissioner Hylton: i feel like with buddies there's only a certain amount of reaching out you can do w/o it being forced.

Staff Estrada: folks have tried, we've been entirely online
