Commissioner thoughts:

-Could have been more prepared for those that are just doing it for extra credit

-Don't think it's bad to get extra credit, and others don't think someone should get extra credit AND stipends.

-We don't know how they would then talk about the voter registration and what they are saying if they aren't doing it with some sort of actual interest behind the cause

-Outreach could have been better focused on government classes or government oriented community orgnaizations

-we should have emailed YC applicants who were not picked for this year's term

-Reach out to those YC applicants for a 'phase 2', will wait two weeks to see how it shakes out with current cohort of trainers. If any drop off, we can reopen up training opportunity to YC applicants.

-Put a cap on transportation of 1 hour

-Give stipends at next scheduled meetings (Dec 6 and Jan 3)
