General ideas:

- Follow up on goal of Navigation Centers and have them create new one
- b. Parks and the Shadow impact (Chiara)

General ideas:

- POPOs:
 - Youth Commission approve POPOs, or at least have a say in the approval process
 - Create a youth task force (consisting of youth who are impacted by POPOs) re: approval of POPOs
 - Changes the characteristics/guidelines of what can be included in a POPO
 - Resolution
- Land Use: city provide cultural competency trainings on land use and what it is
- Parks: sandboxes, shadow impact, accessible drinking fountains, clean bathrooms

To do/Action Steps:

- Schedule presentation from the Planning Commission to HECS (Mary Claire, to put in motion before 12/15/17)
- Schedule presentation from YOHANA to HECS (Mary Claire, to put in motion before 12/15/17)
- Try to schedule both of these on the same HECS Cmte Day, if possible
- Create a list of questions to ask and include questions regarding affordable housing as well (Mary Claire & Mampu, to put in motion before 12/15/17)
- Request/schedule presentation to HECS or full YC on Park and Recs equity plan to see how they are working on issues of water and clean facilities. Possible connection to former YCer Rosa Chen here

- c. Pedestrian safety, bike share, environmental education, public transit (Lisa)

General ideas:

- Muni-digging deeper into the positives/negatives of removing the application process for Free Muni for Youth. Follow up with the folks who wrote the Op Ed piece on this particular idea. Decrease fares for everyone and/or only increase fares when minimum wage goes up
- Bike Share-create a city wide bike share that is not connected to a corporation, outreach/education to communities on bike share program
- Pedestrian Safety-Implementation/outreach for Vision Zero

To do/Action Steps:

- Schedule presentation/update to HECS from Walk SF (Claire, to put in motion before 12/15/17)



- Schedule presentation from the Op Ed folks regarding the Free MUNI SF forms (Lisa, to put in motion before 12/15/17)
- Start thinking about a resolution that could encourage the BOS to encourage SFMTA to only increase fares when minimum wage also increase

d. Alcohol density, health, environmental equity and racism (Elsie)

General ideas:

- Community surveys from youth perspective
- Alcohol education
- Write a resolution from the community focus
- Cannabis issue-reduction of sentences, War on Drugs reparations? Read The New Jim Crow

- Attend the Environmental Prevention Coalition meetings (Elsie-this week or next meeting, maintain liaison relationship with them)

- Increase funding for affordable housing
- Fund existing affordable housing efforts
- Follow up on definition of family housing
- Attend more hearings
- Create guidelines per district/community regarding equitable family housing

To do/Action Steps:

- Follow up on definition of family housing
- Research planning code on family housing (how is it being implemented? Is it a guideline or a requirement? Could we create a definition that is equitable, ie a definition for houses versus SROs or studios?)

f. Environmental issues (Kristen)

General ideas:

- "Meatless Mondays"-mimic Los Angeles resolution
- Environmental Education
 - Research if any existing policies are not being implemented (Styrofoam, plastic bags, zero waste, etc.)
 - Enact a 12N type implementation process via trainings, utilizing Dept of Env.

To do/Action Steps:



- Research how L.A. did Meatless Monday resolution as well as schedule a meeting with Student Advisory Council to get their input on this idea (but not high priority if Dept of Env already said they have tried doing this and it didn't work the first time)
- Schedule presentation from Dept of Env (Kristen and Kiely, already in motion for Feb. 5th agenda)
- Research if any policies exist that aren't being implemented (12N style-zero waste, Styrofoam, plastic bags)

G. Scheduling upcoming presentations for the committee

The Committee decided to invite the Department of Environment to the full YC meeting on February 5th and to request information more specific to youth; as well as ideas that are policy focused that the YC could work on.
