Fahad, YLI staff shared background information about the Prevention Coalitions alcohol density advocacy in recent years. They hope to follow up with members of the Board of Supervisors to introduce measures based on recommendations for a recent Budget and



Legislative Analyst report. The committee members ask how the commission can best support their efforts, and to share potential policy recommendations they can advise the Board of Supervisors. YLI staff will be in communication with YC staff moving forward. There was no public comment.

#### G. Review Environmental Education Survey results

The committee reviewed the initial survey results from their environment education opinion survey. Commissioner Tam and staff thanks the committee for their help with disseminating the survey within their network. As of Feb 12<sup>th</sup>, there have been 525 respondent so far. The committee hopes to analyze the data in a spreadsheet moving forward, looking at the data by age group. There was no public comment.
