- a. **File No. 230420: Calling on the Mayor to Fund 2,000 New Shelter or Temporary Housing Placements** (Discussion and Possible Action Item)
- i. Presenter: Commissioner Miller and Legislative Aide Jackie Thornhill

Legislative Aide Jackie Thornhill goes over the legislation. Commissioner Miller goes over why he requested this legislation to be referred and asks if this resolution is in response to the court case and allowing the city to resume the sweeps and bag and tag. Jackie responds.

Commissioner Miller Questions:

1. If people don't want to accept shelter, what is the Department of Emergency Management doing about it
2. What is the pathway to permanent housing?
3. What is the feedback from community organizations?

Jackie responds to the questions.

Commissioner Barker Plummer thanks Jackie and Supervisor Mandelman for writing the legislation. He asks about the timescale for building the shelter beds and temporary shelters.

Commissioner Wong asks about the location of these temporary shelters.



Jackie responds to all the questions. This ends the Q&A.

Commissioner Miller offers his input on this legislation. He emphasizes funding resources and rehabilitation and not temporary solutions and emphasizes permanent solutions.

Commissioner Barker Plummer offers his input on this legislation.

Commissioner Miller responds. This legislation feels like a way to reinforce the ordinances to conduct inhumane sweeps.

Commissioner Adair supports a no position from the Youth Commission, it's a solution but not the solution we need.

Commissioner Nguyen comments that we do need funding for temporary units but at the same time work on permanent solutions. She supports a no position.

Commissioner Barker Plummer motions to have no recommendation with all the comments from the Commissioners, Commissioner Utting seconds the motion.

Commissioner Nguyen comments that the Commission can accept the nuances and continue working on this.

Commissioner Miller asks staff to invite the Coalition of Homelessness to come to talk about this legislation and get their input.

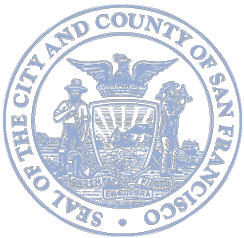

Officer Response to Calls for Service

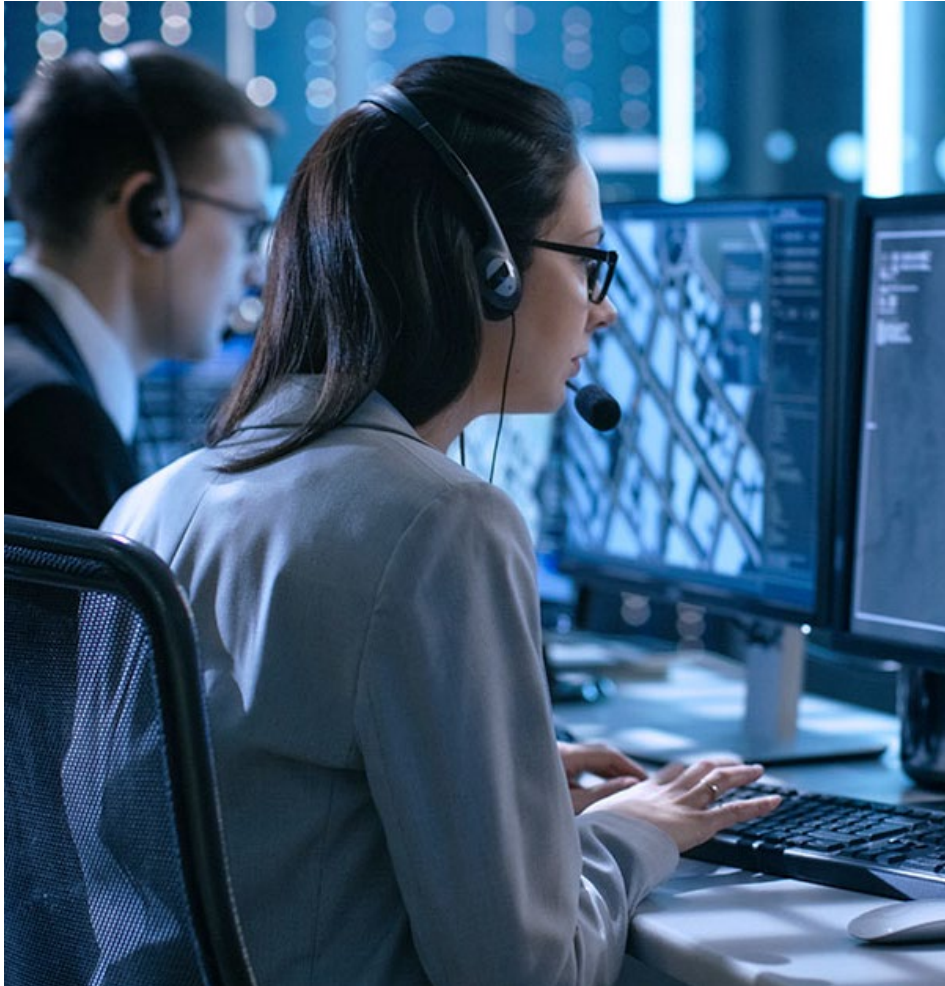
Background:

- In June 2020, the San Francisco Unified School District (SFUSD) elected not to renew the MOU with the SFPD resulting in the disbanding of the School Resource Officer Program
- Prior to disbanding, each station had a school resource officer assigned to the schools within their district.
- Being on campus daily, these officers developed a working relationship with their schools and handled calls for services directly.

Currently:

- With no school resource officers on campuses, calls for service and/or requests for a police response are handled by district officers according to priority.
- In case of an emergency call for services, such as an active shooter, officers respond immediately implementing Department protocols for such events.
- While on school campuses, SFPD members are bound by Department policies, procedures, and protocols.

SFUSD and SFPD Relationship



- When assistance is needed, school officials contact the station captain and/or command staff.
- For emergencies or violent crimes, school officials request a call for service, including 9-1-1, through DEM.
- Community Engagement Division (CED) has direct regular contact with the SFUSD – including weekly meetings with the SFUSD Director of Emergency Planning, Preparedness and Prevention Facilities Division and the Director of High Schools.
- SFPD is available 24-hours a day and 7 days a week to address the needs of the schools.

Preparation for Emergency Response

Safety Threat Training

Active Attacker

Roll call training that addresses mass causality events in which persons are attacked and the best tactics and principles

Active Shooter/Violent Intruder

Classroom instruction with simulated scenarios on tactics and best practices to deploy during critical incidents

Critical Mindset Coordinated Response

Teaches the skills needed for de-escalation, creating time and distance, planning, coordinating, and taking leadership at an incident scene through teamwork and communication

Crisis Intervention Training

Teaches crisis de-escalation, recognition of signs/symptoms of mental illness, substance abuse, recognizing persons in behavioral crisis and options for using less force.

Tactical Unit Train the Trainer

SFPD Tactical Team trains district station's command staff on the best tactic to use when responding to safety threat incidents which can be passed on to the officers at the station and the community.

Emergency Response to Safety Threats

What is a Safety Threat?

SFPD takes all safety threats at schools as a priority

- An act or condition that has the capacity to seriously harm any child
- The overriding objective of the suspect(s) is that of mass murder, rather than other criminal conduct such as robbery or hostage taking

Law Enforcement Response – Active Shooter

Law enforcement's objective is to stop the active shooter as soon as possible and will respond directly to the area where the last shots were heard.

- First officers arrive on scene and survey the surroundings
 - Are people running, what can be heard
 - These officers do not stop to help the injured
- Make contact with the responsible adult, e.g., principle
- Following officers form rescue teams and are responsible for evacuating and treating the injured

Law Enforcement Response – Bomb/Suspicious Device

- Set up a perimeter – isolate - evacuate if necessary
- Bomb Squad responds and takes necessary steps to render the device safe
- Follow-up investigation

Emergency Response to Safety Threats

What To Do When Law Enforcement Arrive



If known, inform the officer of the location of the shooter/suspect

Remain calm and follow instructions

Do not run at or grab onto officers

Put down any items in your hands (e.g. bag, jackets)

Raise your hands and spread your fingers

Keep your hands visible at all times

Do not stop to ask officers for help or directions when evacuating

Emergency Response to Safety Threats

What To Do After the Threat Is Over

REMEMBER - Law Enforcement will not allow anyone to leave until the situation is under control and all witnesses have been identified and questioned

- Cooperate and follow all directions from the police and school administrators
- Keep in mind that the entire area is still a crime scene
- Advise your family that you are OK
- Avoid making statements to the press



Street Violence Response Team (SVRT)

Purpose: To coordinate and plan an effective city response to street violence and critical incidents throughout San Francisco, in order to ensure supportive services to those impacted.



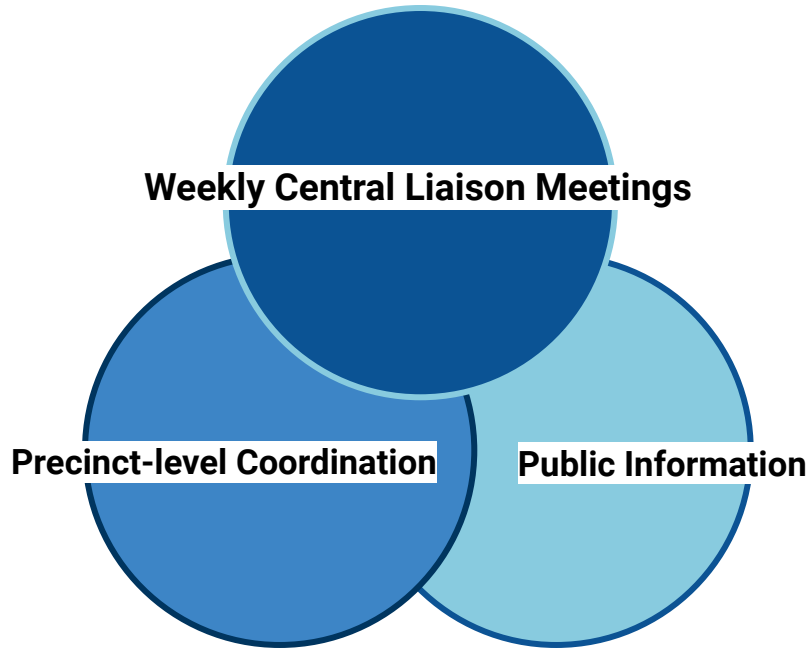
