STATEMENT ON SFPD RESPONSE TO THE "DOLORES HILL BOMB" SKATE EVENT

The San Francisco Youth Commission is concerned by the disorderly event that occurred between the youth and police during the "Dolores Hill Bomb" event on July 8th, 2023. Looking forward, we hope to foster an environment of collaboration between youth and the City to create safe spaces for events. Key to this will be the City, particularly the SFPD, working to maintain positive relationships and trust with youth. Additionally, we encourage all youth to respect the shared space of our city and the safety of its residents.

On July 8th, 2023, a large gathering of young skateboarders held an unpermitted and unsanctioned "hill bomb", where they skated at full speed down Dolores street. Prior to the arrest of youth, SFPD witnessed fireworks and reports of vandalism. After a 16 year old was arrested for spitting in the face of an officer, the crowd of skateboarders threw items including ignited fireworks, glass bottles, and other projectiles at officers. As a result, police declared "unlawful assembly and issued warnings for dispersal.

SFPD proceeded to detain and charge 83 underage youth and 34 adults with multiple criminal offenses, and with several young people stating that their rights were violated as they were not read their Miranda Rights, were not told what they were being detained for, and were not told that they were officially arrested by police officers. These arrests resulted in the youth and young adults being sat on the cold ground, with their hands zip-tied behind their backs for more than five hours, and unable to see or speak to their parents or guardians.

Many of the youth arrested stated that they were leaving the event area, as SFPD had instructed them to do so. Other youth stated that they were not involved with the event at all. However, it appears that the SFPD chose to detain any and all youth and young adults who were in the area. Thus, the Youth Commission calls for a full review of how minors were detained and arrested.
