- WHEREAS, Gun violence is a national crisis in the United States that
  disproportionately impacts youth and transitional aged youth; and
- WHEREAS, Gun violence is the leading cause of death for children and teens in the United States<sup>1</sup>; and
- WHEREAS, Communities of color are disproportionately impacted by gun
  violence, with Black Americans experiencing 10 times the gun homicides, 18 times the
  gun assault injuries, and nearly 3 times the fatal police shootings of White Americans<sup>2</sup>;
  and
- WHEREAS, Black youth are four times more likely to be killed from gun violence than White youth<sup>3</sup> *in the United States*; and
- 18 <u>WHEREAS, Black and Latino men between the ages of 18-35 are</u>
   19 <u>disproportionately impacted by and at the highest risk of gun violence in San</u>
- 20 Francisco⁴; and

1	WHEREAS, A Gun Violence Restraining Order (GVRO) is a California court
2	order that prohibits an individual from possessing a firearm(s) and/or ammunition in the
3	case a court finds reasonable cause to believe that an individual poses an immediate
4	and present danger of causing personal injury to themself or another by having in their
5	possession a firearm(s) and/or ammunition; and
6	WHEREAS, Following the Isla Vista terror killings in 2014 when a college student
7	killed six people and wounded 13 others near the University of California, Santa
8	Barbara campus, California enacted Assembly Bill 1014,5 which was the first Gun
9	Violence Restraining Order (GVRO) law, or "red flag" law, in the nation; and
10	WHEREAS, Assembly Bill 1014 authorized law enforcement officers to file a
11	petition for and allowed courts to issue a GVRO when a court deems reasonable cause
12	to believe that an individual poses an immediate and present danger of causing
13	personal injury to themself or another by having in their possession a firearm (s) and/or
14	ammunition; and
15	WHEREAS, Since Assembly Bill 1014 was first enacted it has been amended
16	multiple times to strengthen and expand the program; and
17	WHEREAS, Current California law allows 1) an immediate family member, 2) an
18	employer, 3) A coworker (if they have had substantial and regular interactions with the
19	individual for at least one year and have obtained the approval of the employer), 4) an
20	employee or teacher of a school that the subject has attended in the last six months (if
21	they have obtained the approval of a school administrator or a school administration

1 staff member with a supervisorial role), and/or 5) a law enforcement officer to petition for a GVRO to be issued<sup>6</sup>: and 2 WHEREAS, Current California law also allows a court to issue Ex Parte GVROs 3 and Emergency GVROs (before a notice and hearing) in the case that the court finds 4 there is a substantial likelihood that the individual poses a significant danger to themself 5 or others in the near future7; and 6 WHEREAS, Assembly Bill 1014 has been proven to be effective, <sup>8</sup> yet public 7 awareness of GVROs and their effectiveness remains low9; and 8 WHEREAS, A survey<sup>10</sup> conducted in 2020 by the University of California Firearm 9 Violence Research Center reported that approximately 65% of California respondents 10 were not aware of GVROs nor of "red flag" laws; and 11 WHEREAS, The aforementioned survey also reported that approximately 52% of 12 California firearm owners were not aware of GVROs nor of "red flag" laws; and 13 14 WHEREAS, The aforementioned survey also reported that approximately 71% of California respondents who lived with a firearm owner(s) were not aware of GVROs nor 15 of "red flag" laws; and 16 17 WHEREAS, The aforementioned survey also reported that the main reason

1	WHEREAS, A 2021 report <sup>11</sup> from the San Francisco Chronicle found that San
2	Francisco was consistently behind the Bay Area average for the issuances of GVROs
3	between 2017 and 2020, and that GVROs "went nearly unused in San Francisco in the
4	first three years of the [red flag] law"; and
5	WHEREAS, The San Diego Office of the City Attorney has championed the use
6	of GVROs through the creation of a specific team "gun violence restraining order unit"
7	dedicated to processing and pursuing GVRO requests and working with local police to
8	implement these orders <sup>12</sup> ; and
9	WHEREAS, The aforementioned unit processes approximately 30 GVRO
10	request referrals from local police every week; and
11	WHEREAS, The aforementioned unit has successfully filed for a GVRO more
12	than 1,350 times between the end of 2017 and April 2022; and
13	WHEREAS, In July 2022, the San Diego Office of the City Attorney was awarded
14	a \$1,000,000 grant from the California Governor's Office of Emergency Services to train
15	and educate city attorney offices and law enforcement groups in California on how to
16	utilize GVROs <sup>13</sup> ; and
17	WHEREAS, A key component of any effective strategy to keep schools safe from
18	gun violence is schools sharing information on gun violence prevention
19	programs/strategies like GVROs; and therefore be it
20	RESOLVED, That the San Francisco Youth Commission urges the City and
21	County of San Francisco to improve and expand public awareness of Gun Violence

13	Office of the City Attorney and Police Department to create a team dedicated to
14	processing and pursuing Gun Violence Restraining Order requests from members of the

16	FURTHER RESOLVED, That San Francisco Youth Commission staff are
17	directed to transmit copies of this resolution to the Office of the Mayor, Board of
18	Supervisors, San Francisco Unified School District Board of Education, Office of the
19	City Attorney, and Police Commission.
