China Basin Ballpark Company

Third Party Subtenants at AT&T Park granted by China Basin Ballpark Company are public information and not confidential trade secrets.

Revenue and Tax Code 480.5 & 480.6 requires China Basin Ballpark Company to report annually all Subtenant Usages on public land via the Board of Equalization form 502-P. The required public disclosure includes each subtenant: Name of subtenant, address, location, date of transaction interest acquired, type of transaction, amount of consideration, term of possession, agency paid expenses, assignment or sublease, remaining term, consideration paid for master lease or underlying lease.

Protest is made; this information is public and taxable. As the Stadium structure depreciates in value the subtenant interest increases in taxable value until full value is achieved. In other words, lost depreciated taxable value in the stadium is offset by increased taxable values from third party subtenants until full value is maintained.
