Chart 1: San Francisco's Probation Revocations Sent to State Prison, 2009-2012

The number of probation revocations sent to state prison is based on the count of "REVSN" (revoked and sentenced) dispositions with a "Case Dispo Date" within that quarter, as recorded in the Superior Court's Court Management System and the Adult Probation Department's Case Management System. The "Case Dispo Date" represents the date on which the Defendant's case was dispositioned. This count does not include those probationers with revoked and sentenced dispositions and resulting 1170(h) straight jail or split sentences. The Adult Probation Department reports the number of revoked and sentenced dispositions with state prison sentences quarterly to the Community Corrections Program of the Judicial Council of California – Administrative Office of the Courts.

Chart 2: Individuals Newly Processed Under AB109 Countywide

The number of new 1170(h) sentences is based on the count of cases with 1170(h)(5)(a) and 1170(h)(5)(b) sentences and "Case Dispo Date" entries recorded in the Court Management System by month — the "Case Dispo Date" represents the date on which the Defendant's case was dispositioned and sentenced as an 1170(h). The number of new Post Release Community Supervision (PRCS) clients is based on the count of "Release Date" entries recorded in the Adult Probation Department's (APD) case management database (spreadsheets) by month—PRCS counts include those released to PRCS after being Returned to Custody (RTC) for a parole violation and clients that are released to PRCS but have holds and/or did not report to APD. The number of new State Parole Violators is based on the count of the "Parole Only Date" entries recorded into the Sheriff's (SFSD) databases (spreadsheets) by month—the "Parole Only Date" represents the date that local charges were adjudicated and any local sentences were sentenced. State projections for AB109 are based on the California Department of Finance (DOF) 1170(h) Estimates and on the California Department of Corrections and Rehabilitation (CDCR) PRCS estimates. The State made no projections regarding the number of parole violators serving time in local custody due to AB109.

Chart 3: Most Common Need Factors of PRCs and PC § 1170(h) Clients Supervised by APD

Need factors are identified by the Correctional Offender Management and Profiling Alternative Sanction (COMPAS) assessment tool and include need factors associated with all PRCs and Mandatory Supervision clients' assessments completed through September 2012. Assessments are administered by APD Deputy Probation Officers or by CDCR while the individual is in state prison. COMPAS assessment results are compiled by APD.

Chart 4: PC § 1170(h) Straight and Split Sentences by Month Oct 2011 – Sept 2012

The number of 1170(h) straight and split sentences per month is based on the count of cases with 1170(h)(5)(a) and 1170(h)(5)(b) sentences and "Case Dispo Date" entries recorded in the Court Management System by month — the "Case Dispo Date" represents the date on which the Defendant's case was dispositioned and sentenced as an 1170(h).

Table 2: PC § 1170(h) Sentence Lengths Oct 2011 – Sept 2012

Sentence length information is compiled by the Adult Probation Department from the "Court Event Text" field in the Court Management System (CMS) for every court number with an associated disposition of an 1170(h)(5)(a) or 1170(h)(5)(b) sentence. Average sentence length is the average of the jail sentence and Mandatory Supervision sentence given for 1170(h)(5)(a) or 1170(h)(5)(b) sentences. Average Time Served with Credits is the average of the jail sentence given, less Credits for Time Served, as reported in the "Court Event Text" field in CMS, then halved to account for PC § 4019 credits. Those cases in which the jail sentence given less the Credit for Time Served is less than or equal to zero, indicating the individual was released from custody at sentencing, are not counted in the Average Time Served with Credits calculation.

Table 3: APD's AB109 Service Partnerships, Referrals, and Enrollment Oct 2011 – Sept 2012

Service referral and enrollment data is compiled by the Reentry Division of the Adult Probation Department. Referral information is recorded and tracked by APD's Reentry Division. Service enrollment and completion information is reported to APD's Reentry Division by the service providers on a monthly basis.

Chart 5: Post Release Community Supervision Compliance

Data is recorded in the Adult Probation Department's (APD) case management database and spreadsheets. Includes all individuals who were active Post Release Community Supervision (PRCS) clients between October 1, 2011 and September 30, 2012. Those individuals released to PRCS with a hold from another jurisdiction are not considered active clients. PRCS clients who received one or more flash incarceration or PC § 3455 violation are counted in the "non-compliance" group. Those who received no formal sanctions during the period from October 1, 2011 through September 30, 2012 are counted as the "compliance" group.

Chart 6: Post Release Community Supervision Sanctions: Reasons for Flash Incarcerations

Data is recorded in the Adult Probation Department's (APD) case management database and spreadsheets. Flash incarceration dates, reasons, custody time imposed, and custody time served are recorded in this database. The primary reason for every flash incarceration imposed between October 1, 2011 and September 30, 2012 is included in this extract. Totals shown are of flash incarcerations imposed, not of individuals receiving flash incarceration sanctions.

Chart 7: Post Release Community Supervision Sanctions: Reasons for PC § 3455a Violations

Data is recorded in the Adult Probation Department's (APD) case management database and spreadsheets. PC § 3455a violation reasons, dates, sentences imposed, sentences served, requests for hearings and attorney consults, and new case information, if applicable, are recorded in this database. The primary reason for every violation which was imposed between October 1, 2011 and September 30, 2012 was included in this extract. Totals shown are of violations imposed, not of individuals receiving violations.

Table 4: PC § 3455a Violations Resulting from New Arrests: Reason for Arrest

Data is recorded in the Adult Probation Department's (APD) case management database and spreadsheets. Every violation which was imposed between October 1, 2011 and September 30, 2012 with "new arrest" as the primary reason is included in this extract. Totals shown are of violations imposed, not of individuals receiving violations.

Chart 8: Individuals Newly Processed Under AB109 Countywide

The number of new 1170(h) sentences is based on the count of cases with 1170(h)(5)(a) and 1170(h)(5)(b) sentences and "Case Dispo Date" entries recorded in the Court Management System by month — the "Case Dispo Date" represents the date on which the Defendant's case was dispositioned and sentenced as an 1170(h). The number of new Post Release Community Supervision (PRCS) clients is based on the count of "Release Date" entries recorded in the Adult Probation Department's (APD) case management database (spreadsheets) by month—PRCS counts include those released to PRCS after being Returned to Custody (RTC) for a parole violation and clients that are released to PRCS but have holds and/or did not report to APD. The number of new State Parole Violators is based on the count of the "Parole Only Date" entries recorded into the Sheriff's (SFSD) databases (spreadsheets) by month—the "Parole Only Date" represents the date that local charges were adjudicated and any local sentences were sentenced. State projections for AB109 are based on the California Department of Finance (DOF) 1170(h) Estimates and on the California Department of Corrections and Rehabilitation (CDCR) PRCS estimates. The State made no projections regarding the number of parole violators serving time in local custody due to AB109.

Chart 9: Average Daily AB109 Population (Oct 2011 – Sept 2012)

For the Adult Probation Department (APD), the Average Daily Population (ADP) of AB109 clients is based on the total number of supervision days from October 1, 2011 through September 30, 2012, divided by 366. If there is no termination or completion date available for an APD client, it is assumed that s/he was under supervision through September 30, 2012. For APD 1170(h) clients, the total amount of supervision days by individual is the number of days between an 1170(h) client's "Jail Release Date" and their "Mandatory Supervision Termination Date" or September 30, 2012, whichever date is sooner. For APD PRCS clients, the total amount of supervision days by individual is the number of days between a PRCS client's "Release Date" and their "Completion Date" or September 30, 2012, whichever date is sooner. APD does not supervise State Parole Violators. All APD data is recorded in APD's case management database and spreadsheets. For the Sheriff's Department (SFSD), the ADP of AB109 inmates is based on the total number of custody days from October 1, 2011 through September 30, 2012, divided by 366. If there is no release date available for the inmate, it is assumed that s/he was in custody through September 30, 2012. For SFSD 1170(h) inmates, the total amount of custody days by individual is the number of days between their "Date of Commitment" and their "Release Date" or September 30, 2012, whichever date is sooner. If there is no release date available, the individual is assumed to be in custody through September 30, 2012. For SFSD PRCS inmates, the total amount of custody days by individual is the number of days between their "Pending 3454 Matters Only Date" (3454 PRCS Violators), and "PRCS Only Date" (3455 PRCS Violators)" and their "Release Date" or September 30, 2012, whichever date is sooner. For SFSD State Parole Violator inmates, the total amount of custody days by individual is the number of days between their "Parole Only Date" and their "Release Date" or September 30, 2012, whichever date is sooner. The "Parole Only Date", "Pending 3454 Matters Only Date", and "PRCS Only Date" represent the date that local charges were adjudicated and any local sentences were sentenced. All SFSD data is recorded in the SFSDs Jail Management System and spreadsheets.

Chart 10: Average Daily AB109 Population by Month

For the Adult Probation Department (APD) and Sheriff's Department (SFSD), the monthly ADP of AB109 clients or inmates is based on the total number of supervision or custody days across AB109 clients for that month, divided by the number of days in that month. If there is no termination, completion, or release date available for an APD client or SFSD inmate, it is assumed that s/he was under supervision through September 30, 2012. For APD 1170(h) clients, the total monthly amount of supervision days by individual is the number of days that falls in that month between an 1170(h) client's "Jail Release Date" and their "Mandatory Supervision Termination Date" or September 30, 2012, whichever date is sooner. For APD PRCS clients, the total monthly amount of supervision days by individual is the number of days that falls in that month between a PRCS client's "Release Date" and their "Completion Date" or September 30, 2012, whichever date is sooner. APD does not supervise State Parole Violators. All APD data is recorded in APD's case management database and spreadsheets.

For the SFSD 1170(h) inmates, the total monthly amount of custody days by individual is the number of days that falls in that month between their "Date of Commitment" and their "Release Date" or September 30, 2012, whichever date is sooner. For SFSD PRCS inmates, the total monthly amount of custody days by individual is the number of days that falls in that month between their "Pending 3454 Matters Only Date" (3454 PRCS Violators), and "PRCS Only Date" (3455 PRCS Violators) and their "Release Date" or September 30, 2012, whichever date is sooner. For SFSD State Parole Violator inmates, the total monthly amount of custody days by individual is the number of days that falls in that month between their "Parole Only Date" and their "Release Date" or September 30, 2012, whichever date is sooner. The "Parole Only Date", "Pending 3454 Matters Only Date", and "PRCS Only Date" represent the date that local charges were adjudicated and any local sentences were sentenced. All SFSD data is recorded in the SFSD's Jail Management System and spreadsheets.

Chart 11: AB109 Population by Department

For each department, the AB109 Population by month is the cumulative total for each of the AB109 population types under that department's supervision (i.e., 1170(h), PRCS, and State Parole Violators). The Non-AB109 Population is the average monthly client population for the department, less the AB109 population. An exception to this is the Department of Public Health (DPH), which includes department totals for only the Behavioral Health Access Center (BHAC) and Jail Health Services (JHS) and not for the entire health department. For the Adult Probation Department (APD), the rolling count of the 1170(h) sentences is based on the count of the "Jail Release Date" entries by month, less any Mandatory Supervision completions in that month. The APD rolling count of PRCS clients is based on the count of the "Release Date" entries for the time period, less any entries for PRCS completions. For the Sheriff's Department (SFSD), the rolling count of the 1170(h), PRCS, and State Parole Violator populations is based on the count of the "Date of Commitment" (1170(h)), "Parole Only Date" (State Parole Violators), "Pending 3454 Matters Only Date" (3454 PRCS Violators), and "PRCS Only Date" (3455 PRCS Violators) entries by month, less any entries for "Release Date" recorded in the Jail Management System for that month. The "Parole Only Date", "Pending 3454 Matters Only Date", and "PRCS Only Date" represent the date that local charges were adjudicated and any local sentences were sentenced. For DPH - BHAC/JHS the rolling count of the 1170(h) and PRCS client population is based on the count of "Screening Date" entries for that month for the "Referral Source" of "1170(h)" or "PRCS" recorded in BHAC's case management system. 1170(h) and PRCS clients are seen on an on-going basis by BHAC providers, so the number of releases/completions of clients by month is considered to be zero. The DPH rolling count of State Parole Violators is based on the Sheriff's rolling count for this population as all State Parole Violators in county jail receive health services from JHS.

Chart 12: Individuals Processed under AB109 as Part of Jail Population:

Data is recorded in the Sheriff's Department (SFSD) Jail Management System or manually tracked by the SFSD for the purposes of AB109 data tracking. For the SFSD 1170(h) inmates, the total monthly amount of custody days by individual is the number of days that falls in that month between their "Date of Commitment" and their "Release Date" or September 30, 2012, whichever date is sooner. For SFSD PRCS inmates, the total monthly amount of custody days by individual is the number of days that falls in that month between their "Pending 3454 Matters Only Date" (3454 PRCS Violators), and "PRCS Only Date" (3455 PRCS Violators)" and their "Release Date" or September 30, 2012, whichever date is sooner. For SFSD State Parole Violator inmates, the total monthly amount of custody days by individual is the number of days that falls in that month between their "Parole Only Date" and their "Release Date" or September 30, 2012, whichever date is sooner. If there is no release date available, the individual is assumed to be in custody through September 30, 2012. The "Parole Only Date", "Pending 3454 Matters Only Date", and "PRCS Only Date" represent the date that local charges were adjudicated and any local sentences were sentenced. The Non-AB109 Population count is calculated by subtracting the monthly AB109 ADP counts from the ADP for the entire County Jail, as tracked and provided by the Sheriff's Department.

Chart 13: Actual vs State-Projected PC § 1170(h) Sentences

"Actual" data is recorded in the Court Management System. The number and type of 1170(h) sentences is based on the count of "Case Dispo Date" entries by month and the "Dispo Type" (a "189" dispo type is a 1170(h)(5)(a) straight sentence disposition and "188" dispo type is a 1170(h)(5)(b) split sentence disposition). State Projections are provided by the California Department of Finance (DOF) and include all 1170(h) sentences. The State made no projections regarding the proportion of 1170(h) sentences that would be straight or split sentences.

Chart 14: Length of PC § 1170(h) Straight Sentences Ordered vs Actual Length of PC § 1170(h) Straight Sentences to be Served

Data is recorded in the Court Management System. The average monthly jail sentence ordered is based on the average of the "Jail (months)" or jail term for those "Case Dispo Date" entries for that month. All jail sentence lengths were calculated into days. The average monthly credit is based on the average of "CTS - 4019 eligible (days)" for those "Case Dispo Date" entries for that month. All values for "CTS-4019 eligible (days)" were doubled to account for PC § 4019 credit. The average jail sentence to be served is based on the average of the remaining jail sentence ordered (months) less the 4019/CTS credits earned (months), for those "Case Dispo Date" entries for that month. This difference is divided by half to account for PC § 4019 credits. If there are more credits than jail sentence time, the jail sentence becomes zero.

Chart 15: Length of PC § 1170(h) Split Sentences Ordered vs Actual Length of PC § 1170(h) Split Sentences to be Served

Data is recorded in the Court Management System. The average monthly jail sentence ordered is based on the average of the "Jail (months)" or jail term for those "Case Dispo Date" entries for that month. All jail terms were calculated into days. The average monthly Mandatory Supervision term ordered is based on the average of the "MS (months)" or Mandatory Supervision term ordered for those "Case Dispo Date" entries for that month. All Mandatory Supervision terms were calculated into days. The average monthly credits for time served (CTS) account for 4019 credits and is based on the average of "CTS - 4019 eligible (days)" for those "Case Dispo Date" entries for that month. All values for "CTS-4019 eligible (days)" were doubled to account for PC § 4019 credit. The average jail time to be served is based on the average of the remaining jail sentence ordered less the 4019/CTS credits earned, for those "Case Dispo Date" entries for that month. This difference is divided by half to account for PC § 4019 credits. If there are more 4019/CTS credits than jail sentence time ordered, the jail sentence served becomes zero and the remaining CTS is deducted from the Mandatory Supervision term ordered on a day-for-day basis. If there are less 4019/CTS credits than jail sentence time ordered, the Mandatory Supervision term served remains the same as the ordered term.

Chart 16: State Parole Violators Average Daily Population in County Jail pre- and post-AB109 Implementation

The monthly ADP of State Parole Violator inmates is based on the total number of custody days for all State Parole Violator inmates for that month, divided by the number of days in that month. If there is no release date available for a Sheriff's Department (SFSD) inmate, it is assumed that s/he was in custody through September 30, 2012. The total monthly amount of State Parole Violator custody days by individual is the number of days that falls in that month between their "Parole Only Date" and their "Release Date" or September 30, 2012, whichever date is sooner. The "Parole Only Date" represents the date that local charges were adjudicated and any local sentences were sentenced. All SFSD data is recorded in the SFSD's Jail Management System and spreadsheets.

Chart 17: State Parole Violators in Local Custody

Data is recorded in the Sheriff's Department (SFSD) Jail Management System or manually tracked by the SFSD for the purposes of AB109 data tracking. The rolling count of the State Parole Violators who are pre-sentence is based on the count of individuals with a "Parole Only Date" that falls between October 1, 2011 and September 30, 2012 and a "Booking Date" that month or earlier that also have a "Hearing Date" and "Release Date" in the future. The rolling count of the State Parole Violators who are post-sentence is based on the count of individuals with a "Parole Only Date" that falls between October 1, 2011 and September 30, 2012 and a "Booking Date" that month or earlier that also have a "Hearing Date" in the past and a "Release Date" in the future.

Chart 18: Length of State Parole Violator Sentences Ordered vs Actual Length of State Parole Sentences to be Served

Data is recorded in the Sheriff's Department (SFSD) Jail Management System or manually tracked by the SFSD for the purposes of AB109 data-tracking. The average monthly jail sentence ordered (without credit) is based on the average of the "Sentence" for those "Hearing Date" entries for that month. Data without any "Hearing Date" was excluded. If the "Sentence" value was "CTS", the sentence served amount is assumed to be zero days. The average jail sentence served is based on the average of the difference between the "Parole TX Date" and the "Hearing Date" for those "Hearing Date" entries for that month. If there was no "Parole TX Date" available in the data set, the "TX Date" was used instead. If both the "Parole TX Date" and the "TX Date" were not available, the "Release Date" was used instead. In almost all instances, the "Parole TX Date", "TX Date", and "Release Date" are the same date. The "Parole TX Date" includes all available credits.

Chart 19: AB109 Men in County Jail – Participation in In-Custody Programs

Data is collected from a survey of the Sheriff's Department (SFSD) Jail Management System. The survey included males sentenced to county jail per PC § 1170(h), PC § 3455a (PRCS violation), or PC § 3056 (parole violation) between October 1, 2011 and September 30, 2012. Parole and PRCS counts are instances of incarceration, not individuals. Program participation includes instances of participation greater than three days.

Chart 20: In-Custody Program Participants by Type of AB109 Sentence

Data is collected from a survey of the Sheriff's Department (SFSD) Jail Management System. The survey included males sentenced to county jail per PC § 1170(h), PC § 3455a (PRCS violation), or PC § 3056 (parole violation) between October 1, 2011 and September 30, 2012. Parole and PRCS counts are instances of incarceration, not individuals. Program participation includes instances of participation greater than three days.

Chart 21: Post Release Community Supervision Active Clients vs Successful & Returned to Custody Completions

Data is recorded in the Adult Probation Department (APD) case management database and spreadsheets. The APD PRCS monthly rolling count of Active Clients is based on the count of "Release Date" entries for that month or earlier, less any clients with a "Date Completed" that month or earlier. The "Six Month Discharge Completions" monthly rolling count is based on the count of "6 Month Discharge" values in the "Reason" for the "Date Completed" that month or earlier. The "Returned to Custody Completions" monthly rolling count is based on the count of "RTC" values in the "Reason" for the "Date Completed" that month or earlier. The "Deaths" monthly rolling count is based on the count of "Death" values in the "Reason" for the "Date Completed" that month or earlier.

Chart 22: Post Release Community Supervision Compliance by Month

Data is recorded in the Adult Probation Department's (APD) case management database and spreadsheets. The monthly rolling count of the No Sanctions PRCS population is based on the count of clients released from the California Department of Corrections and Rehabilitation (CDCR) that month or earlier who have yet to complete PRCS and who have not received a 3454 and/or 3455 sanction that month or earlier. The monthly rolling count of the 3454 Sanction(s) PRCS population is based on the count of clients released from CDCR that month or earlier who have yet to complete PRCS and who have received one or more 3454 sanctions(s) that month or earlier. The monthly rolling count of the 3455 Sanction(s) PRCS population is based on the count of clients released from CDCR that month or earlier who have yet to complete PRCS and who have received one or more 3455 sanction(s) that month or earlier. The monthly rolling count of the 3454 AND 3455 Sanction(s) PRCS population is based on the count of clients released from CDCR that month or earlier who have yet to complete PRCS and who have received one or more 3454 sanction(s) AND one or more 3455 sanction(s) that month or earlier. Therefore, individuals that receive a sanction in one month are counted in the appropriate sanction category for all subsequent months even if s/he does not incur any more sanctions.

Chart 23: Post Release Community Supervision Compliance (Oct 2011 – Sept 2012)

Data is recorded in the Adult Probation Department's (APD) case management database and spreadsheets. The average length of time before a PRCS client's first sanction (3454 or 3455 sanction) was based on the average of the difference in the number of days between their first sanction ("Date of Violation") and their date of release to PRCS ("Date of Release to PRCS"). All PRCS clients who have received a sanction between October 1, 2011 and September 30, 2012 were categorized in one of the following violator categories depending on the number and type of sanction(s) s/he received: Received One 3454 Sanction, Received One 3455 Sanction, Received More Than One 3454 Sanction, Received More Than One 3455 Sanction, or Received Both 3454 and 3455 Sanctions.

Data is recorded in the Adult Probation Department's (APD) case management database and spreadsheets. Flash incarceration dates, reasons, custody time imposed, and custody time served are recorded in this database. The primary reason for every flash incarceration imposed between October 1, 2011 and September 30, 2012 is included in this extract. Totals shown are of flash incarcerations imposed, not of individuals receiving flash incarceration sanctions.

Totals shown are of violations imposed, not of individuals receiving violations.

Every violation which was imposed between October 1, 2011 and September 30, 2012 with "new arrest" as the primary reason is included in this extract. Totals shown are of violations imposed, not of individuals receiving violations.

Table 5: Characteristics of AB109 Individuals October 2011 through September 2012

Adult Probation Department (APD) data on PRCS individuals includes all those released to PRCS from CDCR between October 1, 2011 and September 30, 2012, including those that completed PRCS during this time period and those released to PRCS with federal, state, INS, or other county holds. All APD data is recorded in APD's case management database and spreadsheets. Data on individuals sentenced under 1170(h) is recorded in the Court Management System and includes all 1170(h)(5)(a) and 1170(h)(5)(b) sentences with a "Case Dispo Date" between October 1, 2011 and September 30, 2012. Parole violator count is a count of unique individuals booked per month on PC § 3056 charges. An individual booked more than once in the same month is counted once that month and an individual booked separately in more than one month is counted in each month in which a PC § 3056 booking occurred. Data on state parole violators is recorded in the Sheriff's Department's Jail Management System and spreadsheets.

Table 6: Characteristics of 1170(h)-Sentenced Individuals

Data is recorded in the Court Management System. Active PRCS clients include those with a "Release Date" from CDCR to PRCS between October 1, 2011 and September 30, 2012, with no federal, state, INS, or other county holds, and who did not complete PRCS prior to September 30, 2012.
