1. Agenda item 1: Call to Order and Introductions.

Chief Fletcher called the meeting to order at 2:04pm. She invited the other members to introduce themselves.

2. Agenda Item 2: Public Comment on Items listed as for "Discussion Only"

Chief Fletcher called for any Public Comment, and there was none.

3. Agenda Item 3: Review and Adoption of Meeting Minutes of August 15, 2019

Chief Fletcher called for a motion to adopt the Draft Minutes from the August 15, 2019 meeting. Tara Anderson from the District Attorney's Office made a motion to adopt the Minutes and Joseph Engler, the Assistant Sheriff seconded the Motion. No public comment.

Motion passed. Minutes were approved

4. Agenda Item 4: Staff Report Meeting Schedule, Racial Equity Work Group, CASC Virtual Services, Pretrial Housing Funded by Adult Probation and the CCPEC

Chief Fletcher called upon Interim Director of the Reentry Division, Steve Adami for a quick update on the Reentry Division's work since the last meeting.

Steve Adami informed the committee that the Reentry Division at Adult Probation has 48 Reentry Programs in San Francisco. He further explained that all of Adult Probation's Programs are engrained in the community, and the Reentry Division works closely with the community to address services for those involved in the Justice System. Since shelter in place began, all of the services at the CASC have transitioned to a virtual platform. Tablets have also been placed in all of our Housing Programs to keep our clients connected to services and case management.

Destiny Pletsch, a member of the Reentry Division informed the committee about new housing programs. Adult Probation launched 4 new housing programs recently. The CCP/CW Program which has 7 rooms, 14 beds at the CW Hotel launched in April. Additionally, 23 co-located beds at the CW Hotel for Adult Probation use was established with Recovery Survival Network. In May, the Department established a 51 Unit Emergency Stabilization Housing Program for clients of the San Francisco Pre Trail Diversion Project. Last but not least, a Rental Subsidy Program called Step Up to Freedom was implemented in partnership with Episcopal Community Services and Tipping Point. Step Up to Freedom serves Justice involved individuals on Parole or PRCS.

Tara Anderson provided an update on the Criminal Justice Racial Equity Work Group. Tara explained that the next meeting for the Criminal Justice Racial Equity Work Group is scheduled for September 24th at 10am. Geoffrea and Tara have being working closely to realize a collective across Departments, developing a compressive training conference where racial and ethnic disparities within the Criminal Justice System would be addressed, but then Covid derailed efforts. Tara informed everyone that they are all welcome to attend next week's meeting.

Chief Fletcher thanked everyone for the updates.

There were no questions or comments from the Committee or the Public.

5. Agenda Item 5: Update from the CCPEC regarding the Realignment Evaluation Project discussion

Chief Fletcher explained that two options were discussed in the CCPEC meeting. Either an evaluation of some of the AB-109 Funded Programs or complete a Realignment Report similar to the report presented in 2015.

Tara Agnese provided provided clarification on the two possible projects. There was a lively discussion in the CCPEC meeting. Sheriff Miyamoto discussed the importance of leading these projects with race and equity. The Committee also touched on the potential implications for departments with regard to resources and staff time. Ultimately, the CCPEC decided to move forward with an updated 10 year Realignment Report similar to the 2015 Report.

6. Agenda Item 6: LEAD, PRSPR, and STARR Updates

Theresa Ick provided an update on the STARR and PRSPR programs that DPH launched as a result of their renewed Prop 47 funding.

Theresa Ick informed the Committee that the PRSPR Program has 32 Residential Substance Use Disorder beds and includes 5 social detox slots. She explained that during Covid, they worked closely with Jail and Pre Trial Diversion to use these beds for individuals exiting custody. There have been improvements in maximizing beds and having a higher occupancy rate. There are still a number of individuals who leave the program while in detox. STARR Services provide 5 social detox beds and 70 Case Management slots for low threshold case management at Felton. They have hired a Behavioral Health Clinician to assess individuals in jail for detox and case management services. The LEAD grant ends on September 30th. The program was successful for engaging individuals and less successful in diverting individuals from jail.

Chief Fletcher explained the Adult Probation Department will keep the CASC open later to engage folks in the afterhours beginning in October, depending upon COVID restrictions.

No questions or comments from the Committee or the Public.

7. Agenda Item 7: Roundtable Updates on the Implementation of Public Safety Realignment (AB109) and other comments, questions, and requests for future agenda items

Chief Fletcher asked for any comments or requests from the members.

Tara Anderson informed the committee that the District Attorney's Office uses their AB 109 funding for their Sentencing Planner Program. She further explained that in the early years of this program they worked with UC Berkley and they did a preliminary analysis which the District Attorney's office is now revisiting to understand the impact of that intervention relative to case and individual outcomes. Tara said once this analysis is complete, the information will be shared at a CCP/CCPEC meeting.

Beverly Upton Domestic Violence Consortium encouraged that we use a gender lens in addition to our current analysis of AB 109.

No comments or questions from the public.
