1. Agenda Item 1: Call to Order and Introductions.

Chief Karen Fletcher called the meeting to order at 10:05am, and then called on Victoria Westbrook to call roll.

Victoria called roll and the meeting had quorum.

2. Agenda Item 2: Ramaytush Ohlone Land Acknowledgement (discussion only)

Chief Fletcher read the Ramaytush Ohlone Land Acknowledgement.

3. Agenda Item 3: Public Comment on Any Item Listed Below as for "Discussion Only."

Chief Fletcher called for any Public Comment, and there was none.

4. Agenda Item 4: Review and Adoption of Meeting Minutes of September 16, 2020 (discussion and possible action).

Chief Fletcher called for a motion to adopt the Draft Minutes from the September 16th, 2020 meeting. Tanzeneka Carter made a motion to adopt the minutes. Steve Good seconded the motion.

Chief Fletcher called on Victoria Westbrook for roll call vote

Motioned passed. Minutes were adopted.

5. Agenda Item 5: Staff Report (discussion only):

Chief Fletcher called on Victoria Westbrook to provide an update on the Adult Probation Department's Reentry Division work.

Victoria Westbrook, the Acting Reentry Policy Planner, provided an update on the last Criminal Justice Racial Equity Work Group meeting that happened on June 8, 2021. Westbrook informed us that the meeting consisted of continuous training by the California Racial Justice Act Training. Westbrook also stated that Bright Research Group provided an introductory training on system change and provided a tool for guiding systematic thinking. The attendees of the meeting found the trainings helpful and requested for further training. The next CJREW meeting is scheduled for Thursday September 16, 2021 at 10:00am-11:30am. If anyone would like to join or has questions please contact Westbrook at Victoria.westbrook@sfgov.org.

Steve Adami, Director, Reentry Division, provided an update on the Emergency Housing Funded by the Local Innovation Subaccount, Positive Directions TRP Academy, and Reentry Stabilization Center.

Director Adami informed us that in January of 2020 the Executive Committee of the Community Corrections partnership agreed to fund 7 SRO rooms at the CW Hotel per clients released from jail. In 2021, 23 pretrial clients were house which reduced homelessness by a little over 2,100 days. A parallel project launched in May 2020, in response of Covid-19, Adult Probation funded 52 rooms at the St. Moritz Hotel. The funding for the program ended in October 2020, but Adult Probation continued to fund the program at a limited capacity of 22 rooms. APD housed 83 pretrial clients, reducing homelessness by a little over 10,000 bed days. In a broader housing portfolio, Adult Probation was able to fund 18 housing programs, 7 of which were master lease hotels, and was able to house 604 justice involved people (probation clients and non-probation clients). In that timeframe homelessness was reduced by over 80,000 nights.

Director Adami was happy to announce that the Mayor funded a new program, the Positive Directions TRP Academy. TRP can house up to 84 people and serves any justice involved male. The program is designed to help people overcome the challenges when coming out of jail, prison and while fighting cases in custody. The 6 - 30 month housing program is also designed to be an alternative sentencing program to help advance racial equity and to reduce the over reliance on incarceration. Director Adami informed us that, in 14 days, the program already had 26 students. The formal launch will be September 9, 2021. Another update that Director Adami announced was the Our City Our Home Funds from Prop C to launch the Navigation Center. Westside Community Services will run the Billy Holiday Stabilization Center which will support any justice involved person struggling with addiction, homelessness and metal heath challenges. It will start out with 20 beds for both men and women. The program is projected to launch by September 15, 2021.

Director Adami welcomed Cedric Akbar, Expect in Substance Abuse Treatment to speak to everyone regarding the programs he is launching. Akbar thanked everyone for their support and welcomed everyone to continue to support and give input on the programs being launched.

Chief Fletcher asked if there are were questions or comments from the Committee or the Public. There were none.

6. Agenda Item 6: Update regarding the Realignment Report (discussion only).

Chief Fletcher called on Tara Agnese, the Director of the Adult Probation Department, to provide an update regarding the 2021 Realignment Report.

Agnese informed the committee that the Realignment Report will cover the years 2015 through 2020. The reports primary objectives are to satisfy new state requirements outlined in the Budget Act 2020 and to provide an update on implementation Realignment more broadly. The report will be able to capture information on legislative and policy updates, relevant data points, outcomes, and information on the allocation of Realignment funds. The deadline is mid-December. The outline for the report continues to be refined. Tara will be doing outreach to other departments to help produce data for the report. The outline will cover 4 main areas; racial equity, aggregate data (arrests, booking, jail population, charging, and sentencing information), program services information and financial information on allocation. Agnese stated she will continue to outreach for the data collection, Steve Adami, will take the lead on program service information and Veronica Martinez, Acting Director of Finance, will take the lead on outreach as it relates to financial information.

Chief Fletcher added that it is really important that all agencies' information is reflected in the report. Chief Fletcher stated that as a city, everyone has done a great job at putting the resources to use to make sure that we are serving a broader justice involved population. Fletcher stresses that it is really important that everyone contributes with data when contacted.

Chief Fletcher ask if there are any questions or comments from the Committee or the Public. There were none.

7. Agenda Item 7: PRSPR and STARR Updates (discussion only).

Chief Fletcher introduced Robbin Chandler from the Department of Public Health to provide an update on the STARR and PRSPR programs that the Department of Public Health launched as a result of their Prop 47 Funding.

Robin Chandler informed the committee that the PRSPR grant came to a close and has transitioned to the STARR grant. Robin Chandler stated that DPH is excited about the results of PRSPR and now STARR thus far. Through PRSPR and STARR, they have been making referrals and getting people into treatment, and with the CASC slowly opening they have been able to see clients and connect clients to case management and residential treatment. Chandler also shared that they have a clinician that can also do assessments at the CASC, in the community and in the jail (to get clients directly from custody into treatment). They have been working on shortening the number of days it takes to get clients into treatment by doing covid tests before getting out of jail.

Adami provided an update on the reopening of the Community Assessment and Service Center. The center will open Wednesday September 7th by appointment only. Health screenings at the door will be done and then providers will pick up their clients from the first level. September 15th, 2021 will be the first day of drug testing. Adami will do the testing the first day. Testing will only be limited to Tuesday's 1pm-4pm, and the hours will eventually expand. Classes are going to momentarily be conducted virtually and reassess in October.

Chief Fletcher ask if there are any further questions or comments from the Committee or the Public. There were none.

8. Agenda Item 8: Roundtable Updates on the Implementation of Public Safety Realignment (AB109) and other comments, questions, and requests for future agenda items (discussion only).

Chief Fletcher called for any comments and questions from members.

Assistant Sheriff Tanzanika Carter provided an update about the Women's Resource Center that is officially open. They are doing acupuncture amongst other wonderful services. Assistant Sheriff Carter also spoke about the successful Women's Equity Day Event hosted by the Women's 1st Subcommittee at the Resource Center. She also thanked the Adult Probation Department for their collaboration on the event. Assistant Sheriff Carter reported that the women who attended spoke powerfully, and the WRC plans to continue to have additional events. In October, the WRC will have a Faith and Blue Event where law enforcement can have community dialogue. She will send out fliers.

Chief Fletcher ask if there are any further questions or comments from the Committee. There were none.

9. Agenda Item 9: Public comment on any item listed above, as well as items not listed on the Agenda.

Chief Fletcher asked if there are any questions or comments from the Committee or the Public. There were none.

Chief Fletcher thanked everyone for a good meeting, and stated that today was her last CCP meeting due to retiring. Several members wished her a farewell.

Chief Fletcher announced that the next tentative CCP meeting will be in 2022.

10. Agenda Item 10: Adjournment.

Chief Fletcher called for a motion to Adjourn.
Assistant Sheriff Carter made a motion to adjourn.

RESOLUTION MAKING FINDINGS TO ALLOW TELECONFERENCED MEETINGS UNDER CALIFORNIA GOVERNMENT CODE SECTION 54953(e)

WHEREAS, California Government Code Section 54953(e) empowers local policy bodies to convene by teleconferencing technology during a proclaimed state of emergency under the State Emergency Services Act so long as certain conditions are met; and

WHEREAS, In March, 2020, the Governor of the State of California proclaimed a state of emergency in California in connection with the Coronavirus Disease 2019 ("COVID-19") pandemic, and that state of emergency remains in effect; and

WHEREAS, In February 25, 2020, the Mayor of the City and County of San Francisco (the "City") declared a local emergency, and on March 6, 2020 the City's Health Officer declared a local health emergency, and both those declarations also remain in effect; and

WHEREAS, On March 11 and March 23, 2020, the Mayor issued emergency orders suspending select provisions of local law, including sections of the City Charter, that restrict teleconferencing by members of policy bodies; those orders remain in effect, so City law currently allows policy bodies to meet remotely if they comply with restrictions in State law regarding teleconference meetings; and

WHEREAS, On September 16, 2021, the Governor signed AB 361, a bill that amends the Brown Act to allow local policy bodies to continue to meet by teleconferencing during a state of emergency without complying with restrictions in State law that would otherwise apply, provided that the policy bodies make certain findings at least once every 30 days; and

WHEREAS, While federal, State, and local health officials emphasize the critical importance of vaccination and consistent mask-wearing to prevent the spread of COVID-19, the City's Health Officer has issued at least one order (Health Officer Order No. C19-07y, available online at www.sfdph.org/healthorders) and one directive (Health Officer Directive No. 2020-33i, available online at www.sfdph.org/directives) that continue to recommend measures to promote physical distancing and other social distancing measures, such as masking, in certain contexts; and

WHEREAS, The California Department of Industrial Relations Division of Occupational Safety and Health ("Cal/OSHA") has promulgated Section 3205 of Title 8 of the California Code of Regulations, which requires most employers in California, including in the City, to train and instruct employees about measures that can decrease the spread of COVID-19, including physical distancing and other social distancing measures; and

WHEREAS, Without limiting any requirements under applicable federal, state, or local pandemic-related rules, orders, or directives, the City's Department of Public Health, in coordination with the City's Health Officer, has advised that for group gatherings indoors, such as meetings of boards and commissions, people can increase safety and greatly reduce risks to the health and safety of attendees from COVID-19 by maximizing ventilation, wearing well-fitting masks (as required by Health Officer Order No. C19-07), using physical distancing where the vaccination status of attendees is not known, and considering holding the meeting remotely if feasible, especially for long meetings, with any attendees with unknown vaccination status and where ventilation may not be optimal; and

WHEREAS, On July 31, 2020, the Mayor issued an emergency order that, with limited exceptions, prohibited policy bodies other than the Board of Supervisors and its committees from meeting in person under any circumstances, so as to ensure the safety of policy body members, City staff, and the public; and

WHEREAS, the Council has met remotely during the COVID-19 pandemic and can continue to do so in a manner that allows public participation and transparency while minimizing health risks to members, staff, and the public that would be present with in-person meetings while this emergency continues; now, therefore, be it

RESOLVED, That the Renetry Council finds as follows:

- 1. As described above, the State of California and the City remain in a state of emergency due to the COVID-19 pandemic. At this meeting, the Reentry Council has considered the circumstances of the state of emergency.
- 2. As described above, State and City officials continue to recommend measures to promote physical distancing and other social distancing measures, in some settings.

3. As described above, because of the COVID-19 pandemic, conducting meetings of this body and its committees in person would present imminent risks to the safety of attendees, and the state of emergency continues to directly impact the ability of members to meet safely in person; and, be it

FURTHER RESOLVED, That for at least the next 30 days meetings of the Reentry Council and its committees will continue to occur exclusively by teleconferencing technology (and not by any in-person meetings or any other meetings with public access to the places where any policy body member is present for the meeting). Such meetings of the Reentry Council and its committees that occur by teleconferencing technology will provide an opportunity for members of the public to address this body and its committees and will otherwise occur in a manner that protects the statutory and constitutional rights of parties and the members of the public attending the meeting via teleconferencing; and, be it

FURTHER RESOLVED, That the secretary of the Reentry Council is directed to place a resolution substantially similar to this resolution on the agenda of a future meeting of the Reentry Council within the next 30 days. If the Reentry Council does not meet within the next 30 days, the secretary is directed to place a such resolution on the agenda of the next meeting of the Reentry Council.
