- The first speaker spoke for 45 minutes and Lazar interrupted several times with irrelevant information.
- \* The second speaker spoke for 10 minutes and Lazar interrupted.
- \* I pointed out the that motion under consideration was written so badly-I could not meaningful public comment. Lazar interrupted and my public comment was abridged.
