THE PROBLEM: THREE OR MORE ARTISTS IN A FAMILY UNIT.

IT DOES NOT TAKE MORE THAN TWO ARTISTS TO MAKE ANY ART OR CRAFT IN THE STREET ARTISTS PROGRAM, THE "MULTI-FAMILY UNIT" (THREE OR MORE **ARTISTS) IS REALLY A STATEGY TO** MAXIMIZE A GROUP'S SUCCESS IN THE LOTTERIES: TO CONTROL THE BEST SPACES IN THE VARIOUS MARKETPLACES AROUND THE CITY OR TO HAVE MULTIPLE BOOTHS IN ONE MARKETPLACE. **FUTHERMORE, SOME MEMBERS OF THE** "MULTI-FAMILY UNIT" ARE REALLY "EMPLOYEES" AND NOT "CO-CREATORS" OF THE CRAFT. THIS PLACES "SINGLE" ARTISTS AT A GREAT AND UNDESERVED DISADVANTAGE.

THE SOLUTION: A PROPOSAL TO LIMIT ALL FUTURE FAMILY UNITS TO NO MORE THAN TWO ARTISTS.
