Lucinda Page – following up with her telephone complaint message, I asked her for the details of what she had said was harassment and interference of business by Jeff Potter. She told me that on Saturday, July 18<sup>th</sup>, at about 1 p.m., Lucinda was helping a customer try on a necklace and had several other customers at her display, when Jeff started photographing her about 3 feet away; her customers looked at him and then at her suspiciously, and this had the effect of interfering with her business. She told him "Jeff,"

get out of here."

Then, last Saturday, (July 25), while they were both setting up for business, Jeff called her "funny face" and chided her with "Did you wash your hair?". Lucinda said these events were a continuation of Jeff's "targeting" her, "singling" her "out", and "bullying" her, which she said has been going on for 3 years.

I told her that since Jeff had already received a written warning, he could be subject to receiving a "Notice of Intent to Withhold Issuance of Certification" whereupon he would either request a hearing with me as hearing officer, or, if not, go to a hearing of the Street Artists Committee. In either case, I told Lucinda she would be requested to attend and testify.
