ESTIMATED SCHEDULE (start and completion dates)	September 2018 to November 2018
1. Proposal (describe proposed design, site and theme. Attach a separate document if needed).	The proposal is to have a mosaic mural installed on the exterior walls of Longfellow Elementary along Morse and Lowell Street. The proposed design is one of a meandering path of what we can do to promote peace in among ourselves, in our families, in our schools, in our community and in the larger world. Student ideas and images of activities that promote peace will be part of the artists design.
2. Materials and processes to be used for wall preparation, mural creation and anti-graffiti treatment.	The Mural will be made of tiles and mosaic pieces adhered to the wall by thickset mortar. It will be designed on adhesive mesh which will be attached to walls with wet mortar. While mosaics are usually not tagged by graffiti especially when the community is involved in its creation, a clear protective coat will be applied when the mosaic is completed and dry. For this mural we will be using a variety of materials including : ceramic tile, porcelain tile, glass, mirror, stone and marble

Ross Holzman (Executive Director of <u>www.createpeaceproject.org</u>) will lead the project. Ross is an experienced arts educator with more than 10 years of experience working with tens of thousands of youth. He is duly qualified to lead the execution of the mural as he has created more than 15 large-scale murals in schools across the San Francisco Bay Area, and the world, in the past 5 years.

In the past 3 years, the Artist has led 12 large community mural projects in San Francisco Bay Area schools. More than 3,000 students have participated in these painting projects covering more than 14,000 square feet of wall space. In addition to these mural projects, Ross has led four (4) community mosaic projects, including at the entrance to a new cafe in Oakland, CA, a project at Lovonya DeJean Middle School in Richmond, CA with 250 students, staff and parents, and a school-wide mosaic with more than 500 students at Grattan Elementary School in San Francisco. The Artist's projects include:

2015 - Glen Park Elementary Mural - This was a 10-week, 1,500 sq. ft. mural painting project, involving the entire school of 360+ students and staff members, plus parents.

2015 - Chinese Immersion School Mural Project – A 10-week mural, covering 1,800 sq. ft. of wall space, including more than 450 students and staff in a school-wide collaboration.

2016 - Bret Harte Middle School Hayward – a 650 student school-wide collaboration. Every student painted at least three times on a 2,500 sq. ft. mural over 3 months.

2016/2017 – Create Peace Project was honored to partner with the Malala Fund, and be a recipient of a grant from Global Giving for \$13,500 to complete a project with more than 9,000 students from 150 schools in the United States, Kenya and India. This project was an international exchange of art and messages of peace, done in partnership with Participant Media, The Malala Fund, Students Stand #withMalala, Kenya Girls Guides in Nairobi, Kenya and Victor Tango in Mumbai, India.

2016 and 2017 – Monroe Elementary School Mural Projects – Create Peace Project let two large-scale mural projects, including the entire 550+ student body in painting 1,500 and 1,200 sq. ft. murals during each spring of 2016 and 2017.

2018 Richmond Arts and Culture Commission Grant – Middle School Mosaic Project -Create Peace Project was awarded its second Arts and Culture Commission grant to lead a large-scale mosaic project at Lovonya DeJean Middle School March 2018 with 250 students.

Artist Biography:

Ross Holzman (lead artist) is the founder and executive director of the Create Peace Project. A passionate and prolific artist himself, Ross loves facilitating collaborative arts experiences and empowering positive feelings through the creative process. Ross is a published author, accomplished public speaker, and arts facilitator; having led more than 150 Peace Exchange workshops, 30 Banners for Peace and more than 20 community murals. Ross has personally worked with more than 25,000 children in schools across the U.S., Uganda, India, Nepal and Ghana since 2009.

Jael Lafemina, Lead Consultant and Mosaic Artist: (assistant to the artist) Jael is a master stonemason and mosaic artist with more than 25 years of experience creating beautiful mosaics and doing stone masonry work in homes around the United States. Since 1992 he has been designing and building landscapes, mosaics and stone masonry work on high-end homes. Jael has a Bachelor of Arts from the University of Vermont and currently has clients in Colorado, Utah, Idaho, Oregon, California, Massachusetts and Hawaii.

Laurie Marshall, (assistant to the artist) Arts Facilitator, is an international leader in empowering young people to have a positive impact on negative settings. A certified art and social studies teacher with 35 years in mostly underserved communities, she has inspired students through project-based learning and arts integration in the US, Bosnia-Herzegovina, Ghana, Uganda and Brazil.

Izabella Tschig, (assistant to the artist) Arts Facilitator, is passionate about our capacity as humans to use our hearts, bodies and minds to create, to heal and to play. Iza studied art and design at Chelsea College of Art, London College of Communication, and Parsons School of Design, NYC as well as enjoying an enriching personal and professional career in theater, film and music making.

Longfellow Elementary serves over 550 students, whose families live in the surrounding Cayuga Terrace and Outer Mission Neighborhoods. As a parent, advocate, and Supervisor for a district where access to public art is limited, I fully support Longfellow Elementary's application. The mural installation will allow the children and their families to become the artists. The design process will involve the PTA, afterschool programs, local neighborhood groups and school families, building community in the process.

This Longfellow Community Mural is a full wall mosaic mural that will be located along the exterior walls of Longfellow elementary along the corner of Morse (150' x 8') and Lowell (120' x 8' x 13").

5-year Maintenance Plan

Mosaics require little to no maintenance, and rarely get tagged. However, **Create Peace Project** will train staff at Longfellow Elementary throughout the project to handle small repairs when a small piece of the mosaic fails. In instances where more significant support is needed, a **Create Peace Project** staff member will be available and will work together with the school to address any issues. SFUSD Building & Grounds staff indicated they will contribute to its maintenance. **Create Peace Project** will take responsibility for maintaining the artwork for a period of 5 years from the mural's completion.

10-year Maintenance Plan

Create Peace Project will maintain the artwork for a period of 10 years from the mural's completion. In addition, **Create Peace Project** will ensure Longfellow staff are equipped to handle small issues, and have a staff person available for more significant repairs.
