**RE: Goettingen Steps Project** 

Dear Ms. Henriquez:

This letter is written in support of the Goettingen Neighbors Group (GNG) application for a Community Challenge Grant. The group's project would focus on the ongoing development of the Goettingen Steps. Specifically, the installation of tiles on the steps of the stairway.

Since 2018, the group has hosted monthly cleanup events around the steps. This includes litter pickup, gardening, and graffiti abatement efforts. The GNG's commitment does not just start there. In 2017, they secured nearly \$60,000 in ad-back funding from the Supervisors office to install benches and retaining walls. To sustain these projects, they have held plant and garage sales, raised funds at Neighborfest block parties, and even hosted a Drag themed Bingo Night.

The group has a track record of successfully project managing developments. In the past, they have collaborated with Public Works to improve the stairway handrail and install a gate to create a public space on the hillside.

In terms of representing their community, this group is made up of about thirteen core residents. They include San Francisco natives and recent additions to the neighborhood, people of multi-racial backgrounds, and multi-generational age groups. They worked together to create a public space where one did not exist before. Once the tile is in place, the end project will be highly visible and be an instant landmark to the Portola neighborhood.

In preparation for their CCG grant, Public Works pledges to repair the exposed rebar and other safety hazards on the concrete stairs. We would also provide no parking and street space use permits / signage for the group to construct the projects. We anticipate these are the only permits required for this project.






