Artist Biography

Neil Ballard is an artist based in the Ingleside neighborhood of San Francisco. Ballard has lived and worked in Ingleside since 2013. For five years, Ballard worked for the Ocean Avenue Association where he managed public art projects and events from grant proposals to project execution. As a freelance artist and arts administrator, Ballard has worked on illustration projects for web and print marketing campaigns, product labels, awnings, websites and posters. Ballard completed his first mural in December 2020, transforming a graffiti-prone utility box with several stylized varieties of California native flowers. Ballard is currently managing a project to install a custom gateway at Ingleside Library, which has involved extensive interfacing with several city departments as well as community outreach.

Ballard's art practice to date has been centered almost entirely on the Ingleside neighborhood, and he intends to remain committed to neighborhood-centered projects. Ballard views his art practice as a means to promote Ingleside as the home to so many unique independent businesses, the likes of which make a full and vibrant urban life possible. Ballard is also currently working on comics that will tell unique stories of the Bay Area and he has been displaying those comics at Ingleside businesses since March of 2021.





Every year, our organization budgets for artwork upkeep & maintenance contingency costs so we can adequately maintain the artworks in the public realm of Ocean Avenue.


The mural that is planned for Faxon Garage is no exception, and we will see to its maintenance as needed in the future.
