
As owners of the building we are extremely excited to see this mural project come to fruition.

As a condition of the Property Owner's approval and authorization to create the Artwork on the Property, Artist agrees to waive and does hereby waive voluntarily all rights to attribution and integrity with respect to the Artwork and any and all claims as may arise under the Visual Artists Rights Act of 1990, 17 U.S.C. §§106A and 113(d) ("VARA"), the California Art Preservation Act (Cal. Civ. Code §§987 and 989 )("CAPA"), or any other local, state, foreign or international law, as currently drafted or as may be hereafter amended, that conveys the same or similar rights (collectively "Moral Rights Laws"), with respect to the Artwork, its display, removal from display, exhibition, installation, conservation, storage, study, alteration and any other activities conducted by the Property Owner or any future owner of the Property. If the Artwork is incorporated into a building such that the Artwork cannot be removed from the building without physical defacement, mutilation, alternation, distortion, destruction, or other modification (collectively, "Modification") of the Artwork, Artist waives any and all such claims under any Moral Rights Laws arising out of or against any current or future owners of the Property, and its agents, officers and employees, for Modification of the Artwork.

The Property Owner, or any future owner of the Property, has the absolute right to change, modify, destroy, remove, relocate, move, replace, transport, repair or restore the Artwork, in whole or in part without prior notice to the Artist. However, if the Property Owner, or any future owner of the Property, modifies the Artwork without the Artist's consent in a manner that is prejudicial to Artist's reputation, Artist retains the right to disclaim authorship of the Artwork in accordance with 17 U.S.C. § 106A (a) (2).

The Property Owner has no obligation to pursue claims against third parties for modifications or damage to the Artwork done without the Property Owner's authorization. However, the Property Owner may pursue claims against third parties for modifications or damage or to restore the Artwork if the Artwork has been modified without the Property Owner's or Artist's authorization. In the event that the Property Owner pursues such a claim, Property Owner shall notify the Artist, and Artist shall cooperate with the Property Owner's efforts to prosecute such claims.

Artist bears the sole responsibility for providing the San Francisco Arts Commission and Property Owner with any changes to the Artist's Address for Notice. ## Project Summary

Four artists were selected as a result of a call for submissions and jury process. The artists will paint murals on the pedestrian sides of two k-rails each. The murals will be active for a two year period, then painted over. The artists will be responsible for regular conservation of their murals during that time. Each artist will receive \$4000 (artist fee + materials).

Vanessa Lim (she/her) is an independent illustrator and designer based in Singapore and San Francisco. Lim has a relationship with the TL through a previous temporary art project on utility boxes.



Seibot (they/them) is a San Francisco-based artist whose work includes ink and digital drawing, murals, private commissioned and tattoo designs. Their subjects are most often "flowers and queer folk, or some flourishing amalgamation of the two. Seibot is a Tenderloin resident.



Crystal Vielula is a San Francisco-based artist and arts educator. In 2019, she was selected as a MUNI artist and created 8 collages that traveled were depicted on buses and trains. She designed public art pieces for the Lower Polk, Tenderloin, SOMA West and Yerba Buena districts highlighting the queer history of the area. Vielula has been involved as a muralist with Clarion Alley Mural Project for over 10 years and her current LGBTQ Pride mural is one of the most photographed in the city. Recently her work has been profiled in the San Francisco Chronicle and KQED Arts.





Elizabeth McConaughy-Oliver is a Bay Area artist, who uses exaggerated shape and color to communicate her personal experiences as a POC.

Calle 24, the community benefit organization for the Latino Cultural District proposes to initiate a program whereby artists will be commissioned to create original projects that highlight the experience of immigrant communities. In addition, they also wish to commission projects that highlight the stories of small businesses located in the Latino Cultural Corrdor. The projects will be short term temporary installations that may be installed on storefronts, parklets and other private properties in the Mission District. Arts Commission approval is required because these projects are funded by a grant from the Arts Commission's Community Investment Program.

After releasing a public call for proposals, Calle 24 has decided to proceed with the proposals submitted by Mabel Jimenez and Paola De La Calle which are attached below. The installations will be installed in early March for a duration of approximately two months. Calle 24 will commission additional artists on an ongoing basis. All artists will be paid for their work.

The first two proposals are provided as attachments. Please note that the dates indicated by Paola De la Calle in her proposal have changed as reflected in the following motion.

Motion to approved the temporary installation of artwork proposals by Mabel Jimenez and Paola De La sponsored by Calle 24, a community benefit organization, to be installed in the Mission District within the Latino Cultural Corridor for a duration of approximately two months commencing March 1, 2021 through May, 2021. The exhibition may be extended at the discretion of the project sponsor and private property owner.

Being a photographer, my installation as I'm picturing it now is very simple, consisting of a simple, large scale print 40x60, of the photo below with accompanying information.

Because of the size, the ideal location would be the window at Accion Latina, publisher of El Tecolote, at 2958 24th Street.

The photo will be glued on the inside of the window, facing towards the street. An anti-graffiti film will cover the outside of the window to prevent permanent damage



I chose this photograph because I feel it embodies the desperation, but also the hope of refugees who seek asylum in the U.S. The photo was taken during a trip to deliver aid to asylum seekers in Tijuana in 2019. The man, Jose Manuel Barragan Corona, was somewhat intoxicated and in an emotional state dealing with his status as a deportee. He told me he wanted his name in print, so that maybe, if his sons in the U.S. see it, they will realize "how hard it truly is".

#### About me:

Mabel Jiménez is an independent photographer and reporter based in San Francisco. Being raised in Tijuana, 15 minutes from the Mexico/U.S. border, themes of biculturalism and immigration have influenced her photographic and journalistic work. She has documented San Francisco's Latino community since 2008 and is the former Photo Editor for El Tecolote bilingual newspaper. During her seven year tenure in the position, she created, produced and curated a yearly group photography exhibit showcasing the newspaper's best photojournalism. The exhibit has run for six consecutive years, making it the only ongoing photography exhibit in the San Francisco Bay Area showcasing the Latino experience.

## **Description**

### "In Search of Refuge: Testimonies of Resilience and Hope"

As COVID-19 disproportionately impacts Black, Indigenous, immigrant, and low-income communities this site-specific installation seeks to highlight the stories of immigrants and offer respite for the community. The site-specific installation urges us to explore, engage, and expose our colonial history which shapes our present-day experience. Through the artwork proposed in this installation viewers will be asked to consider:

- 1. How do you define refuge and sanctuary?
- 2. How can we reimagine the narrative we've been taught about migration?
- 3. How do we rewrite history to put marginalized voices at the forefront?

This site-specific installation is a continuation of an ongoing exploration that has informed my artistic practice over the past several years as I work to examine the effects of borders, colonialism, and US imperialism on our collective understanding of migration, identity, and culture. Through the use of reimagined archival materials, photographs of Calle 24, migration narratives, and culturally symbolic objects inside the small businesses the installation acts as an opportunity for reflection and a representation of resilience, hope, and joy.

## **Specific Project Proposal**

For this project, I am proposing to make a series of two (and no more than three) digital collages to be installed on the windows of the selected small business. The collages will be composed of photographs taken on 24th Street, the selected small business, and personal archival images. This site-specific installation will create a visual narrative of the social, historical, and political reasons for migration. The collages will be individually printed on perforated vinyl which is applied to the interior of the windows of the selected small business.

The images will be cut out using digital editing tools and put together to not only provide an opportunity for reflection for people walking by but to interrogate and provide alternate understandings of migration and resist the stereotypical images we are often bombarded with by the media. Using bright colors and Calle 24 as inspiration the images will use joy as resistance and propose new narratives. The dimensions of the perforated vinyl can be adjusted to fit the storefront windows and can be printed as large as 8x10 ft. vertically or horizontally. Since the perforated vinyl is installed through the interior of the store the artwork is waterproof and protected against vandalism.

#### **Production and Timeline**

The site-specific installation is designed to be flexible to accommodate individual measurements for each window dependent on the business selected. To accommodate any odd window sizes the perforated vinyl collages can be adjusted into smaller dimensions and to be visible as die-cuts rather than occupying the entire window space.

Measuring the windows of the selected small business, photographing the objects inside the store, and collaborating with the small business owners are the main components of this proposal that should be prioritized - without these pieces, the project cannot move forward. This first part of the project will be completed between January 24th and January 26th. The remainder of the week, up to January 31st, will be spent putting together the collages using digital editing tools. On February 1st the files will be sent to print and dropped off (or shipped) to the small business location. The perforated vinyl will be installed by February 7, 2021. Artwork will be de-installed between April 3rd and 4th.

#### La Rose des Vents

Installation completed December 2020

Fence and signage completed February 2021

Motion to approve as installed and accept into the Civic art Collection the sculpture *La Rose des Vents*, 2015 by Jean-Michel Othoniel. The sculpture is formed of two parts, a quatrefoil shaped base of painted steel, and a wind activated kinetic structure on the top formed of 24 karat gold gilded aluminum beads and plates with a steel armature. It is supported with a painted steel footing and the complete artwork measures 131-7/8 by 96-1/2 by 78-3/4 inches and weighs 1323lbs. The artwork is a gift to the City form Julie Lepinard and JSLH Foundation; located in front lawn of the Conservatory at Golden Gate Park.
