



### Waiver of Proprietary Rights

#### for Artwork Placed Upon PRIVATE PROPERTY under VARA and CAPA

The artist, Kseniya Makarova, has designed a work of visual art ("the Artwork") as described below. The Artwork will be located at the address below, with consent from Sean Mitchell (hereinafter referred to as the "Property Owner").

### ADDRESS/LOCATION: 2600 San Bruno Avenue (south facing wall into parking lot)

As a condition of the Property Owner's approval and authorization to create the Artwork on the Property, Artist agrees to waive and does hereby waive voluntarily all rights to attribution and integrity with respect to the Artwork and any and all claims as may arise under the Visual Artists Rights Act of 1990, 17 U.S.C. §§106A and 113(d) ("VARA"), the California Art Preservation Act (Cal. Civ. Code §§987 and 989 )("CAPA"), or any other local, state, foreign or international law, as currently drafted or as may be hereafter amended, that conveys the same or similar rights (collectively "Moral Rights Laws"), with respect to the Artwork, its display, removal from display, exhibition, installation, conservation, storage, study, alteration and any other activities conducted by the Property Owner or any future owner of the Property. If the Artwork is incorporated into a building such that the Artwork cannot be removed from the building without physical defacement, mutilation, alternation, distortion, destruction, or other modification (collectively, "Modification") of the Artwork, Artist waives any and all such claims under any Moral Rights Laws arising out of or against any current or future owners of the Property, and its agents, officers and employees, for Modification of the Artwork.

The Property Owner, or any future owner of the Property, has the absolute right to change, modify, destroy, remove, relocate, move, replace, transport, repair or restore the Artwork, in whole or in part without prior notice to the Artist. However, if the Property Owner, or any future owner of the Property, modifies the Artwork without the Artist's consent in a manner that is prejudicial to Artist's reputation, Artist retains the right to disclaim authorship of the Artwork in accordance with 17 U.S.C. § 106A (a) (2).

The Property Owner has no obligation to pursue claims against third parties for modifications or damage to the Artwork done without the Property Owner's authorization. However, the Property Owner may pursue claims against third parties for modifications or damage or to restore the Artwork if the Artwork has been modified without the Property Owner's or Artist's authorization. In the event that the Property Owner pursues such a claim, Property Owner shall notify the Artist, and Artist shall cooperate with the Property Owner's efforts to prosecute such claims.

Artist bears the sole responsibility for providing the San Francisco Arts Commission and Property Owner with any changes to the Artist's Address for Notice. # Mural Site Agreement

This agreement is made and entered into on 2/24/20, by and between the Portola Neighborhood Association (PNA), a non-profit organization organized under the laws of the State of California, and Sean Mitchell, (hereinafter referred to as "owner") owner of property located at 2600 San Bruno Avenue, in the City of San Francisco, State of California.

1. The owner hereby agrees to allow the Portola Neighborhood Association to have a mural painted on the South wall on the building located at 2600 San Bruno Avenue,

- 2. The mural shall be allowed to remain on the wall for a period of ten (10) years. This agreement may be extended for successive ten (10) year periods upon the written extension between the owner and the Portola Neighborhood Association prior to the end of the initial ten-year period. During the term, or any extension thereof, at such time as property is being offered for sale or lease, or the building on such property is being demolished or expanded where the mural is located, or the mural otherwise interferes with the owner suse, occupancy, or control of the property, then at the owner's sole discretion the owner has the right to cancel this agreement upon six (6) months written notice to the Portola Neighborhood Association.
- 3. The Portola Neighborhood Association agrees that it shall provide for the execution of the mural artwork and will be responsible for any and all associated costs, including payment of fees to the artist and any necessary scaffolding, paint, and equipment necessary for the maintenance and/or removal or restoration of the mural during the term of this agreement or any extension thereof.
- 4. The owner agrees to provide the Portola Neighborhood Association with reasonable access to the site for such work so as not to interfere with the owner's business operations. The owner agrees that any refurbishment, repairs, maintenance or "touch-up" of the mural shall be undertaken only with the approval and under the supervision of the Portola Neighborhood Association or its designated representative from date of completion plus five years. The mural will be maintained by the Portola Neighborhood Association at its cost.
- 5. The Portola Neighborhood Association agrees to keep owner's property lien-free in connection with such work or project.
- 6. Placement of the copyrighted artwork (mural) on the site in no way entitles the owner to use the

artwork for advertising/profit making purposes, or any other publicity, except under conditions in which the artwork has been released by both the Portola Neighborhood Association and the artist.

7. This agreement represents the complete understanding between the parties with respect to the matters set forth herein. No amendment or modification of the agreement shall be valid unless evidenced in writing and executed by the parties thereto. In witness whereof, the Portola Neighborhood Association and the owner have executed this agreement on the date and year first hereinabove set forth.



#### **Maintenance Plan:**

The PNA will provide materials and time at an hourly wage of \$50 per hour, with insurance, for the original artist to remove any graffiti and/or make necessary repairs to the mural due to vandalism, or other unforeseen damage, for a period of five years. If the original artist is unavailable, the PNA will hire an artist to do the graffiti removal and/or make necessary repairs.
