**RE:** Far Out West Garden Mural and Garden Improvements:

I am writing in support of Far Out West's request for a Community Challenge Grant to fund a mural and garden improvements in the community garden at 1399 43rd Avenue. I have lived in the Outer Sunset since 1986 and in that time have seen so many positive changes that contribute to the livability and quality of life out here on San Francisco's west side. Far Out West is certainly an outstanding example.

For the last three years, I managed Playland at 43<sup>rd</sup> Avenue, a parking lot-turned-playground and community park, right around the corner from Far Out West. Through my work at Playland, I had the honor and pleasure of collaborating with Georgia Hodges and Doug Jacuzzi, the Far Out West stewards. As across the street neighbors, both have been involved and supportive. I also worked with Georgia on an art show she curated in Playland's Art Container. The show, called VOTE, coincided with the 2018 mid-term elections and included work by 12 Outer Sunset artists which was intended to spark, motivate, and inspire people to take action. Georgia was creative, efficient, reliable, and inspiring in her curation and implementation of this show.

It has been exciting to see the growth and improvements in the Far Out West Garden over time. I hadn't yet met Georgia and Doug when the garden first opened, but remember walking by on Judah and curiously noticing the community garden taking shape on that formerly blighted space by the church. Since then it's been great to watch the raised beds greening and the spaces for community gathering take shape. The installation of the water catchment tank and distribution system has been remarkable, not only as a functioning system, but also as a demonstration and educational opportunity about how this kind of environmental intervention can work and is necessary. The educational panels are awesome.

The mural will be an exciting way to add further beautification to this space and our neighborhood as well as a great way to re-engage neighbors in the FOW community garden. I have absolutely no doubt that Georgia can design and execute an amazing mural that will complement and enhance our neighborhood. I also have the utmost confidence that she can manage the logistics of the project, including scaling a design to fit the dimensions of the wall and the conceptual requirements of a public art piece.

I fully support the project at Far Out West and can't wait to the new beautification to this well-traveled stretch of Judah.

As a condition of the Property Owner's approval and authorization to create the Artwork on the Property, Artist agrees to waive and does hereby waive voluntarily all rights to attribution and integrity with respect to the Artwork and any and all claims as may arise under the Visual Artists Rights Act of 1990, 17 U.S.C. §§106A and 113(d) ("VARA"), the California Art Preservation Act (Cal. Civ. Code §§987 and 989 )("CAPA"), or any other local, state, foreign or international law, as currently drafted or as may be hereafter amended, that conveys the same or similar rights (collectively "Moral Rights Laws"), with respect to the Artwork, its display, removal from display, exhibition, installation, conservation, storage, study, alteration and any other activities conducted by the Property Owner or any future owner of the Property. If the Artwork is incorporated into a building such that the Artwork cannot be removed from the building without physical defacement, mutilation, alternation, distortion, destruction, or other modification (collectively, "Modification") of the Artwork, Artist waives any and all such claims under any Moral Rights Laws arising out of or against any current or future owners of the Property, and its agents, officers and employees, for Modification of the Artwork.

The Property Owner, or any future owner of the Property, has the absolute right to change, modify, destroy, remove, relocate, move, replace, transport, repair or restore the Artwork, in whole or in part without prior notice to the Artist. However, if the Property Owner, or any future owner of the Property, modifies the Artwork without the Artist's consent in a manner that is prejudicial to Artist's reputation, Artist retains the right to disclaim authorship of the Artwork in accordance with 17 U.S.C. § 106A (a) (2).

The Property Owner has no obligation to pursue claims against third parties for modifications or damage to the Artwork done without the Property Owner's authorization. However, the Property Owner may pursue claims against third parties for modifications or damage or to restore the Artwork if the Artwork has been modified without the Property Owner's or Artist's authorization. In the event that the Property Owner pursues such a claim, Property Owner shall notify the Artist, and Artist shall cooperate with the Property Owner's efforts to prosecute such claims. Artist bears the sole responsibility for providing the San Francisco Arts Commission and Property Owner with any changes to the Artist's Address for Notice. 
### MURAL:

The wall slated for the mural will be properly prepared with a power wash and 1-2 coats of primer paint and 1-2 coats of exterior grade, high quality undercoat paint. The upper two thirds of the mural (2<sup>nd</sup> and 3<sup>rd</sup> stories) will be painted with high quality mural paint and final spray coated with an acrylic varnish. The lower level (1<sup>st</sup> story) will be coated with a graffiti protection varnish. The nature of the design of the lower portion of the mural will allow for easy touch up painting as needed. Artist Georgia Hodges will be responsible for maintaining the mural, and repainting/restoring as necessary.

The "plaque" created at eyelevel will have a scan code to access a complete document of the GREEN NEW DEAL Resolution. There will be opportunity to add new scan codes to new, relevant information to GREEN NEW DEAL developments and related materials, such as voter registration, etc.

### FOW GARDEN Beautification:

For the next 5 years, FOW will conduct monthly workdays to cultivate new members and maintain the gardens, plots etc.
