Please accept these 3 items purchased during my most recent visit to San Francisco Justin Herman Plaza on August 11, 2018. These items were purchased from a street vendor named Jeff Potter who also called himself "The Peace Guy". I was very surprised to see that many many pieces of the jewelry displayed and being sold by him, were pieces exactly, I mean exactly, of your unique design. They are the exact dimension, shape, curvature, metal, patina, and construction of the jewelry I know you to have created. He was representing them as his own creation. This vendor did not seem to have an affinity to what he was selling as he told me he liked to change what he sold having sometime in the past been a t-shirt vendor among other things.

The items purchased were gift wrapped in small cloth bags exactly the shape and size of your gift wrapping as well. Attached to this email are a copy of the receipt for the 3 items (he discounted each item \$10 from the price marked on the items, and several photographs of the vendor Jeff Potter aka The Peace Guy with his license and partial view of the jewelry items on his table. The photos were taken with his permission.

Please let me know if there is anything I can do help you protect you creative product. It is wrong that in the community of vendors at San Francisco Justin Herman Plaza, where you have been selling for so many many years, that blatant plagiarism (not sure what it is for stealing an artists designs) is allowed.


