Artist Garbarino showed photos of her sewing machine and studio. She is a returning artist.

Committee noted that artist Garbarino's single fabric scarf was approved due to edging work performed.

Not approved - dyed commercially manufactured cotton bucket hats

Artist Garbarino needs to do more work since she does not make the hats herself.
