Issue: On September 24, 2019, Catherine came to the office to report that Xiuping "Ping" Li, License #7935 and Zhenjie Feng, License #7936 had engaged in behavior prohibited by the program's Code of Conduct on Monday, September 9, 2019 in the following manor:

Xiuping "Ping" Li, verbally abusing Catherine during the morning lottery.

Zhenjie Feng, physically assaulting Catherine with a metal hat form after she had set up her booth.

Recommendation: Based on the investigation of this report and Catherine's history with the program, staff are recommending that the Committee suspend this artist's certificate for six months.

Supporting Evidence: Arts Commission staff interviewed Catherine Zhang, Zhenjie Feng, Chinglan Sun, Brian Hopper, Officer Lovell who took the police report, and City Attorney Jonah Ross who provided information on the case regarding these incidents. Additionally, staff received written reports from Weijun Chen - another witness named by Catherine, as well as reviewed the history of Catherine Zhang's relationship with the program and the other parties involved.

Catherine's file showed a history of disagreements with other artists at the wharf, including interfering with other artists' business and possible deception regarding information shared with the Arts Commission and other vendors. There was a series of minor violations regarding setting up her booth and conducting business in designated spaces.

# **Artist Code of Conduct**

The Art Vendor program (also known as the Street Artist program) is a program of the San Francisco Arts Commission. As a participant in this program, the Arts Commission expects each artist to uphold and embody the mission, vision, and values of the Arts Commission. As a licensed artist, you are a cultural ambassador of the Arts Commission and as such, are expected to adhere to standards of behavior appropriate for this role. The market is a community of artists and all artists are responsible for its care and upkeep. Please respect the market and your role as one of the public representatives of the San Francisco arts community.

The Arts Commission has adopted as part of its strategic plan the following Mission, Vision and Values:

# Mission

The San Francisco Arts Commission is the City agency that champions the arts as essential to daily life by investing in a vibrant arts community, enlivening the urban environment and shaping innovative cultural policy.

# Vision

The San Francisco Arts Commission envisions a San Francisco where the transformative power of art is critical to strengthening neighborhoods, building infrastructure and fostering positive social change. We believe the arts create inspiring personal experiences, illuminate the human condition and offer meaningful ways to engage with each other and the world around us. We imagine a vibrant San Francisco where creativity, prosperity and progress go hand in hand. We advance artists' ideas to improve the quality of life for everyone through a united cultural sector whose contributions are vital and valued.

- Artists as integral to making San Francisco a city where people want to live, work and play

# Code of Conduct

By signing your name to this document or checking the box online you confirm that you have read and reviewed this material. The Program Officer will keep a receipt of your acknowledgement on file. A violation of these rules may result in the denial, suspension, or revocation of your license. See San Francisco Police Code Section 2408(a).

- 1. It is the City's policy to prohibit discrimination or harassment on the basis of: Race, color, ancestry, national origin, ethnicity, place of birth, sex, age, religion, creed, disability or medical condition, HIV/AIDS status, sexual orientation, marital or domestic partner status, gender identity, parental status, pregnancy, weight or height or any other characteristic protected by state or federal employment discrimination laws or by the San Francisco Charter or local ordinance. The Arts Commission expects all licensees and program participants to keep derogatory and discriminatory language out of the market and this program.
- 2. Always be respectful, courteous and considerate to fellow artists, Arts Commission Staff, Advisory Committee members and the public. A major factor in the existence of the program is its continued good relations with the public and the business community.
- 3. Do not physically or verbally threaten or assault another artist, an Arts Commission staff member, an Advisory Committee member or other departmental personnel, a store merchant, or any member of the public, or engage in any other serious mistreatment of persons, or acts that present an immediate danger to the public health and safety.
- 4. Present a neat and clean display that follows market location specifications. Make sure you have your signs and labels visible so that the public knows that your items are handmade.
- 5. All artists must ensure that their displays are secured. Winds are unpredictable and therefore every physical display shall be held down by weights or in another manner to prevent movement by the wind. The City and County of San Francisco is not responsible for any damage caused by any display.

- 6. Keep your space clean while you are in it, and remove everything when you leave. There should be no evidence of your craft or display once you leave a location.
- 7. Do not display items that appear to be for sale that you have not made, even if you are not selling the items.
- 8. Display for sale only handmade items that are listed on your license.
- 9. Set up in designated locations only.
- 10. Keep your display within space allowance. None of your equipment, display or other belongings should intrude into any walkways or into another space.
- 11. You must personally sell your items. Only you as the licensed artist may take money from a customer in exchange for anything from your display. You may have another person watch your display for short periods, but that person cannot make sales on your behalf.
- 12. Do not attach anything to any piece of public property or private property that is not yours. For example, do not hang your merchandise, signage, or part of your display on trees, lampposts, railings, fences, fireplugs, or other objects that do not belong to you.
- 13. Arrange any umbrella used as part of a display such that it does not interfere with visual access between storefronts and public walkways. Please arrange any merchandise in a manner that maintains this visual access.
- 14. If you set up prior to the day's lottery, you must vacate if the space is allocated through the lottery.
- 15. Do not interfere with or hinder any City employee, Advisory Committee member or contractor who is engaged in the discharge of such person's duties. This includes both physical and verbal abuse of any employee.
- 16. Do not make false reports or use deception to gain an advantage over other artists.

- 17. The approved selling locations are drug and alcohol free zones. Do not drink, smoke, or use illegal drugs at the market.
- 18. Artists shall vacate the areas used for loading and unloading of displays and equipment as soon as possible. No artist shall use these areas for parking except while loading or unloading.
- 19. Respect the business of your fellow artists. Do not enter their spaces without permission, interfere, or hinder the interaction between customers and other artists. Please ensure that your customers do not block or interfere with the displays of neighboring artists.
- 20. Loud or constant music or noise (radios, drums, instruments, filing, hammering, cutting, etc.) can greatly disturb the artists who spend many hours a day in close proximity to each other. Please be considerate of the neighboring artists and merchants, and work with them to address concerns about music and noise.
- 21. Do not "hawk" your merchandise by shouting to people who pass your table.
- 22. Artists shall not replicate another artist's work.
- 23. You must comply with all applicable ordinances and rules. As a reminder, artists are prohibited from selling or setting up between 12 a.m. and 6 a.m. and selling, offering or soliciting offers to purchase from any vehicle.

# **Program Violations**

Article 24 of the San Francisco Police Code (online link) sets forth the procedures for addressing violations of the ordinances and the Commission's rules and regulations applicable to the artists, and any appeal from a decision by the Arts Commission to suspend, revoke or deny a license. Any staff member, artist or member of the public may initiate a complaint against an artist for violation of the ordinances or rules and regulations, including the code of conduct included herein.

- 27. 請遵循市場攤位規範,進行乾淨整潔的陳列展示。請確保您的招牌和標籤清晰可見,以便公眾知道您的作品是手工製作。
- 28. 所有藝術家都必須確保所有展示品牢固。由於風向難以預測,所有實物展示均需採取增重或其他方式以避免風力移動。三藩市縣對由任何展示造成的損害概不負責。
- 29. 請保持所在空間乾淨整潔,並在離開時移除所有物品。當您離開一處地點時,請勿留下作品或展示的任何痕跡。
- 30. 請勿展售您尚未製作的作品,即使您並未打算售賣。
- 31. 僅可展售執照上列明的手工製品。
- 32. 僅可在指定地點布展。
- 33. 請在空間範圍內進行展示。不得將您的任何器材、展品或其他物品置於通道或其他 造成阻礙的空間內。
- 34. 您必須親自售賣您的作品。只有您本人作為獲得執照的藝術家,才可以就攤位的任何作品與客戶進行錢物交易。您可以請別人暫時照看攤位,但是照看者不得代表您進行交易。
- 35. 請勿將任何物品附著在任何公共財產或是不屬於您的私人財產上。例如,不得將您的商品、標牌或攤位的一部分掛在樹木、路燈柱、圍欄、圍牆、消防栓或其他不屬於您的物品上。
- 36. 用於攤位的保護傘需確保不阻擋店面與公共通道之間的可視範圍。商品佈置也請遵循不阻擋視線的原則。
- 37. 如果您在當日抽籤之前布展,如果抽籤時將該處指定給別人,您必須空出攤位。
- 38. 請勿干擾或妨礙任何城市雇員、諮詢委員會成員或承包商履行其職責。這包括對任何員工進行肢體及語言的淩虐。
- 39. 不得為獲得針對其他藝術家的競爭優勢而進行虛假報告或欺騙。

- 43. 喧鬧或持續的音樂或噪音(收音機、鼓、樂器、銼削、錘擊、切割等)會極大干擾 到一天中與您長時間處在附近的其他藝術家。請體諒鄰近的藝術家及商家,並協商 解決音樂及噪音問題。
- 44. 請勿向路過您攤位的人群大聲「兜售」您的商品。
- 45. 藝術家不得複製其他藝術家的作品。
- 46. 您必須遵守所有適用的條例和規則。在此提醒,藝術家不得在淩晨12點至6點之間 進行售賣或布展,也不得招攬客戶從任何交通工具上購買商品。

- 72. No amenace ni agreda física o verbalmente a otro artista, miembro del personal de la Comisión de las Artes, miembro del Comité Consultivo u otro miembro del personal del departamento, comerciante de una tienda, ni a cualquier miembro del público, ni participe en ningún otro tipo de maltrato grave de personas, o actos que presenten un peligro inmediato para la salud y seguridad del público.
- 73. Presente una exhibición ordenada y limpia que se adhiera a las especificaciones del lugar del mercado. Asegúrese de tener sus rótulos y etiquetas visibles para que el público sepa que sus artículos son hechos a mano.
- 74. Todos los artistas deben asegurarse de que sus exhibiciones estén protegidas. Los vientos son impredecibles y, por lo tanto, todos los exhibidores deberán ser sujetados con pesas o de alguna otra manera para evitar el movimiento por el viento. La Ciudad y Condado de San Francisco no se hace responsable de ningún daño causado por ningún exhibidor.
- 75. Mantenga su espacio limpio mientras se encuentra en él, y retire todo cuando se vaya. No debe quedar evidencia de sus artesanías ni de su exhibición una vez que abandone el lugar.
- 76. No exhiba artículos que parecen estar a la venta que usted no haya fabricado, aún si no está vendiendo los artículos.
- 77. Solo exhiba para la venta artículos hechos a mano que figuran en su licencia.
- 78. Monte su exhibición en lugares designados solamente.
- 79. Mantenga su exhibición dentro del espacio designado. Ninguno de sus equipos, exhibidores u otras pertenencias debe invadir ningún pasillo u otro espacio.

- 80. Usted debe vender sus artículos personalmente. Solo usted como artista autorizado puede recibir dinero de un cliente a cambio de algo de su exhibición. Se permite que otra persona cuide su exhibición durante períodos cortos, pero esa persona no puede realizar ventas en su nombre.
- 81. No fije nada a ningún elemento de propiedad pública o privada que no sea suya. Por ejemplo, no cuelgue su mercancía, sus señales o parte de su exhibición en árboles, postes de luz, barandas, cercas, hidrantes u otros objetos que no le pertenezcan.
- 82. Si usa un paraguas como parte de una exhibición, colóquelo de tal manera que no obstruya el acceso visual entre las fachadas de las tiendas y los pasillos públicos. Por favor arregle toda su mercancía de manera que se mantenga dicho acceso visual.
- 83. Si monta su exhibición antes de la lotería del día, debe desocupar el espacio si se asigna a otra persona en la lotería.
- 84. No interfiera ni obstaculice a ningún empleado de la Ciudad, miembro del Comité Consultivo o contratista que esté desempeñando sus funciones. Esto incluye el abuso físico y verbal de cualquier empleado.
- 85. No hagas denuncias falsas ni uses engaños para obtener una ventaja sobre otros artistas.
- 86. Los lugares de venta aprobados son zonas libres de drogas y alcohol. No beba, fume ni use drogas ilegales en el mercado.
- 87. Los artistas deberán desocupar las áreas utilizadas para cargar y descargar exhibiciones y equipos tan pronto como sea posible. Ningún artista deberá usar estas áreas para estacionarse, excepto durante la carga o descarga.
- 88. Respete el negocio de sus compañeros artistas. No ingrese a sus espacios sin permiso, no interfiera ni obstaculice la interacción entre los clientes y otros artistas. Asegúrese de que sus clientes no bloqueen ni interfieran con las exhibiciones de los artistas vecinos.
- 89. La música o el ruido fuerte o constante (radios, tambores, instrumentos, raspado, martilleo, serruchado, etc.) pueden molestar en gran medida a los artistas que pasan muchas horas del día muy cerca el uno del otro. 92. Deben cumplir con todas las ordenanzas y reglas aplicables. Como recordatorio, a los artistas se les prohíbe vender o montar su exhibición entre las 12 a.m. y las 6 a.m. o vender, ofrecer o solicitar ofertas para comprar desde cualquier vehículo.

# Notice to Artists



### Notice to Street Artists

Section 5 of the Street Artists Ordinance allows the Director of Cultural Affairs to refuse to issue a street artists certificate or renewal if charges have been filed alleging deception or violation of the Street Artists Ordinance. The Art Commission has adopted the following procedures to implement Section 5. These procedures may be used to address violations in addition to, and may be taken with, the existing suspension-revocation procedures.

# CHARGES OF MINOR VIOLATIONS OF THE STREET ARTISTS ORDINANCE:

--includes most violations of a non-violent/ non-threatening nature.

 $\textbf{First Violation: "NOTICE OF WARNING"} \ \text{from Program Director}.$ 

# Second Violation: "NOTICE OF INTENT TO RECOMMEND DENIAL OF CERTIFICATE OR RENEWAL" from Program Director.

Notice will offer artist an opportunity to have a public hearing with Program Director to discuss the charge. If artist agrees in writing to comply with Street Artists Ordinance, Program Director will recommend issuance of certificate or renewal. If artist does not agree in writing to comply with the ordinance, Program Director will recommend denial of certificate or renewal.

**Third Violation:** (when at least 1 of 3 of the incidents has been witnessed by Police or Program staff): "NOTICE OF WITHHOLDING OF CERTIFICATE OR RENEWAL PENDING HEARING" from Director of Cultural Affairs.\*

# CHARGES OF SERIOUS VIOLATIONS OF THE STREET ARTIST ORDINANCE

-includes violations of a violent or threatening nature and violations that significantly threaten integrity of Street Artists Program.

First Verifiable Violation: "NOTICE OF WITHHOLDING OF CERTIFICATE OR RENEWAL PENDING HEARING" from Director of Cultural Affairs.\*

\*Denials of certificates or renewals are governed by section 2408 of the Street Artists Ordinance. The Street Artists Program Committee will hold a public hearing on the certificate or renewal in accordance with Section 2408. A decision by the Committee and Program Director to deny certificate or renewal may be appealed to the Board of Appeals within 15 days, in accordance with section 2409 of the Street Artists Ordinance.





According to my memory, for this incident between Catherine (Xiaoying Zhang) and Ping's family members(Xiuping Li and Zhenjie Feng), I summarize the following four points as below.

- 1. On the morning of 9/9/2019, when the street artist were making the lottery for the places to sell their stuff on beech street, Catherine told Ping not to touch all the lottery slip in case she does cheating, she need give the lottery slip to the lottery helper to handle. Ping became unhappy and angry.
- 2. At first Ping was constantly accused of Catherine, her voice grew louder and louder, and the word from her mouth became more and more ugly. As one of lottery committee members, though I am not on duty that day, I tried to persuade her not to be yelling at street, but she didn't listen, even though Cosmo (Zhenjie Feng) who is on duty on that day let her stop yelling, she and her husband(Zhenjie Feng) became more and more arrogant, their temper was not controlled that time.
- 3. In this situation, Catherine felt attacked and helpless, she said she want to call the police or report this situation to SFAC program manager(Anne trickey) for ping and her husband, but Catherine didn't do it at that time. with driven by arrogance, Ping said even if police came, it would be useless. and even if Anne trickey doesn't care about it. she can do whatever she want, even though break any regulations and rules.
- 4. After lottery when we saw Catherine again, that was half an hour later, she told me that Ping and ping's husband were intimidating her, and ping's husband hit her with something. But we did not see the whole process and what was happened on jefferson street.

401 VAN NESS AVENUE ON November 12th and 13th by setting up a major production with

Police barricades were set up, and 17 street artists were

displaced from their prime selling locations at the Plaza.

While The Gap received a permit from your department for usage of the Plaza for the event, I learned from the Film and Video Arts Commission that The Gap did not take out a permit for filming.

As you know, the Board of Supervisors twenty years ago, through Resolution No. 572-77, designated Hallidie Plaza as a sales area for the street artists. The Board acted on behalf of the voters who, through the street artist ordinance passed in 1975, mandated the Board to designate locations for the artists to sell their handmade wares in keeping with fire and safety regulations adopted by the Board.

For this reason, in 1996 the Art Commission signed an agreement with the Film and Video Arts Commission (see enclosed) whereby "The Executive Director of the Film Commission shall require that film companies who have entered into a use agreement with the Film Commission shall compensate the Arts Commission's Street Artist Program in the amount of two hundred (200) dollars per day per designated street artist space used or adversely affected by filming or photographing activity between the hours of 10:00 a.m. and 10:00 p.m."

I am respectfully requesting that the Art Commission and the Department of Public Works enter into a similar use agreement and that your department compensate the Street Artists Program retroactively on behalf of the 17 artists who were displaced by The Gap event.

### The street is her gallery

forms a blank sheet of paper with her charcoal pencil and pastel chalk.

Stray lines form a face. A few more strokes, and the face looks as real as a photograph.

The onlookers murmur and shake their heads.

Wow.

Catherine Zhang, 55, does portraits of people on the street. But to those who stop to watch her work, she is no street artisan. She's an artist.

They can't imagine why she hasn't been discovered yet.

"Market Street is not the place for her," said Jamela Carter, 19, stopping with her stepmother to admire Zhang's portraits of movie stars that hang on the walls of her makeshift cardboard gallery. "She ought to be in New York. Somebody ought to sponsor her.

"If somebody showed these actors these pictures of them, she'd be rich and famous."

The women stop to talk to Zhang. They gush about how she has captured the twinkle in Sean Connery's eyes, the impishness in Leonardo DiCaprio's smirk, the rounded edges of the teeth in Oprah Winfrey's trademark smile.

"Girl, don't that look like Julia Roberts?" said Raquel Carter, 24, Jamele's stepmether

Jamela's stepmother.

"Uh-huh," said Jamela Carter.

"Look at Oprah. It looks just like her. That's the picture in Essence."

She studied Oprah's portrait.

"Somebody needs to show Oprah," Jamela Carter said finally. She turned to Zhang.
"We will help you," Jamela told

"We will help you," Jamela told her. "You don't need to be on Market Street. You should be in a gallery. We'll call the Oprah show. We'll tell them: 'We have an artist that needs to be discovered.'"

Zhang doesn't mind being on the street. She is there seven days a week, from about 11 a.m. to dusk. Her spot is next to the elevator to the Powell Street BART station, on the north side of Market. Her studio is her cardboard gallery, a shopping cart of art supplies, a milk crate to sit on and a folding chair for her sidewalk client.

"My office is The City and the sky," she said. "The floor is the BART station. No telephone, but you can find me easy. Everyone knows me here, by the elevator."

She wants neither fame nor fortune. Success would be having the money for tuition at UC-Berkeley for a master's in fine arts, and to be able to draw whatever enters her imagination rather than whomever sits in her chair.

"Do I want to be famous?" Zhang said, repeating an onlooker's question in halting English. "I no think about that. I just want to paint what I want to paint. . . . I enjoy my painting. I don't care if I sell it. Even if nobody buy it, I enjoy it."

Zhang has been doing street portraits for three years, soon after arriving from Beijing. For a decade she had been an art teacher in middle school, and later, for 14 years, was art director of a magazine about Western culture. She also illustrated children's books.

Zhang's magazine experience made her hunger to see the works of the master artists of the United States and Europe, she said. But she had never been outside Asia.

Until coming to America, she said, "I never see an original famous oil painting. I only see in book. I want to see in real life, see really close, what it do on the canvas."

Her husband, who is from Iowa and teaches American literature at a Beijing university, encouraged her to move to the United States to try to make it as an artist.

Go, he told her. See the great art in America. And let America see your great art.

After a trip to America's heartland to visit in-laws, and a nightmare three-day stay in New York City where she had hoped to settle — "I escaped from New York!" she said, relaying her adventures at a flophouse — she arrived in San Francisco in July 1996.

She didn't know anyone. But at Fisherman's Wharf she saw other artists, from portraitists to caricaturists, making a living on the street from tourists. She didn't want to invade their turf, so she joined the artisans at the foot of Powell, within walking distance of her Tenderloin apartment.

Soon after, her daughter, Tina Zhu, flew in from China to be with her. Now 27, Zhu attends the Academy of Art. Zhang pays her tuition.

After Christmas, Zhang goes back to China for the winter, to get out of the cold and rain and to be with her husband. But the rest of the year is outdoor weather in San Francisco and time to work.

She has no trouble getting business. Some passers-by sit down for a portrait on the spot. Others come with photographs from their youth or of friends and relatives.

Zhang charges \$10 for a 10-minute charcoal sketch in black & white. The price goes up depending on the size of the portrait, the amount of detail, and whether it will be in color. The most popular request — a 16-by-20-inch portrait in pastel chalk — goes for \$85. Zhang also does oil portraits, starting at \$300. She is especially proud of her oil paintings.

Zhang is so popular that she often has commissions to do when she gets home after a day on the street. She usually works until 2 or 3 in the morning.

3 in the morning.

She is grateful to be making a living finally as an artist. But it's not what she had in mind when she came to America. Being so busy means she has no free time to visit museums, meet other artists and do her own work.

"Always I have duty," she said.
"Too much duty for me."

The other day, Zhang got requests for several portraits that needed to be done overnight so that they could be given as last-second, but special, gifts. The holiday season is especially busy.

Rosie Salacup brought a snapshot of herself that she wanted turned into art. She is 37 in the photo, slender and happy as she kicks back in the ocean off the coast of her native Philippines.

"I want to remember," said Salacup, 51, who had walked past Zhang countless times before deciding to trust her with such an important task. "If I see that picture, I think I'm in the Philippines."

Besides, she added with a grin, "I was skinny before. When I'm old, I want my grandson to see that his grandmother looked like that."

Most of Zhang's customers are like Salacup, coming by several times before committing themselves, as if they can't believe she's really that good.

"I bet she can make us look better," Megan Ballard, 16, whispered to Lizette Estrada, 17, her best friend and fellow classmate at Leadership High School.

The girls walk past Zhang almost every day on their way from school. They never fail to stop.

"She's so good, she shouldn't be out here," said Lizette, repeating the common refrain, watching Zhang put the finishing touches on a portrait of sisters.

"You shouldn't be out here," Lizette told Zhang.

Inspired by the sisters' portrait, the girls decide to save up to have a picture done of them together.

"Can you make me look pretty?" Megan asked Zhang.

Zhang looked at her carefully and didn't say anything for a while.

"You look really lovely," Zhang told her. And she meant it.

Although few take the plunge and sit down immediately, for Amanda Haynes there was no doubt. A tourist from Boston, Haynes

A tourist from Boston, Haynes believes that her frequent travels have given her a sophisticated eye. She knows talent when she sees it.

"This is like the best I've ever seen," said Haynes, 21.

She decides to get a \$35 portrait to give to her mother, who she'll be visiting the next day in Houston.

She sits down and tries to give a serious pose.

"I see her so soft, her skin soft, I make her soft," Zhang murmurs, adding a pale lavender to Haynes' shirt. Meanwhile, Haynes tries to avoid the googly-eyed faces of onlookers trying to make her smile.

Forty-five minutes later, the portrait is done. The resemblance to Haynes is uncanny. There is a wariness to her gray hazel eyes, a maturity to her slightly parted lips, pride in her uplifted chin.

The portrait is not so much flattering as revealing. Unlike a photograph, which freezes a person's image at the split second the camera shutter is pressed, Zhang's portraits — by paying special attention to telling facial features and expressions — capture something of the person's essence.

"Oh," said Haynes, "It's me."

Before handing it to her, Zhang
signs and dates the sketch, and
adds "San Francisco."

It was, in most ways, a typical day.

### Street artists succeed

Thank you for your front-page showcasing of one of the highly talented street artists in the San Francisco Arts Commission's street artist licensing program ("Street gallery, Dec. 8).

Your feature about Catherine Zhang's brilliant portraits and her "American dream" also attests to the greatness of a city whose voters, over 20 years ago, approved a law which encourages pursuit of the "American dream" by providing public selling locations for people who want to earn a living by selling what they make.

Zhang and the other licensed street artists enjoy the opportunity of selling their art at Powell and Market streets — or at other key locations downtown and at Fisherman's Wharf — thanks to the voters, the Board of Supervisors and mayor, who designated the locations, and the founding street artists who had the inspiration to pursue legitimacy

of their activity. While your article describes the popularity of Zhang's work with such quotes from the public as, "Market Street is not the place for her," and, "She ought to be in New York. Somebody should sponsor her," it may surprise you to learn that among the 7,000 whom the Arts Commission licensed over the years, many successful artists either got their start in San Francisco's Street Artists Program or used the opportunity as a stepping stone to further their careers.

This, too, is one of the primary purposes of a licensing program developed by a city with a vision.

Mr. McLean -

I have not been able to approach the City Attorney with your matter until now due to having to spend more than a week writing the minutes of the February 13th meeting, as well as handling various priority violation-enforcement and budget matters.

Today I am forwarding a copy of the minutes to the City Attorney's office, which detail the part of the meeting in which you and Catherine Zhang voiced your request. This will give an opportunity for the Deputy City Attorney to become familiar with the issue before she and I can discuss it. (The minutes will soon be posted on the Arts Commission's website; I refer you to the section entitled "PUBLIC COMMENT.")

Two points I wish to tell you:

- The City Attorney's office does not always issue advice to a department in a short timely fashion; it's been our experience that advice can be received anywhere from a few days to several months - or even a year.
- 2) It's my understanding from the meeting you attended that the Arts Commissioners were encouraging you to first do your part in approaching the EPA and the Department of Public Health with your issue; and if either of those agencies support your claim, such information might be useful to the City Attorney's office in its consideration of whether or not the Arts Commission has the authority to request a street artist to stop burning incense and - should the activity continue - to suspend or revoke the artist's certificate.

The police know. And I also can imagine doing something about this situation is very dificult because of the legal requirements in getting a shoplifting conviction.

(I seen something on TV about having to get video of someone taking an item and then actually leaving the store to get a conviction.)

Commissioner Stermer asked that the Program Director send a letter-request for such assistance to Union Square Association.

Director of Cultural Affairs Newirth recommended that the Union Square Business Improvement District also be approached with the request.

### DISCUSSION

## IX. PUBLIC COMMENT/OPEN FORUM FOR POSSIBLE PRESENTATION OF PROPOSALS FOR NEW SELLING SPACES

Mr. Emmett McLean spoke on behalf of Street Artist Catherine Zhang, a portrait artist who works at Hallidie Plaza. Ms. Zhang, he said, was suffering from the smell of the incense being burned by another street artist, Roy Parker - it makes her so sick, he said, that she cannot work. Ms. Zhang spoke to the Program Director about it, and Mr. Parker reluctantly stopped burning the incense the day the Program Director asked him to do so but would not refrain from burning it at a later time.

Mr. McLean stressed that "what Catherine does here is her livelihood ... we need to take some kind of action; we're not exactly sure what that action ought to be. In a way, we're asking for your help and asking what our options are."

Program Director Lazar stated that when he spoke with both Ms. Zhang and Mr. Parker, he had observed that their displays were about sixty feet apart; Mr. Parker did stop burning the stick of incense at the Program Director's request but would not guarantee that he would continue to refrain from burning it; he was not displaying incense for sale which, had he done so, would have jeopardized his street artist certificate.

In response to a question by Commissioner Stermer, the Program Director stated that he did not know whether the burning of incense in a street artist location - which is a public location - is illegal. If Ms. Zhang had been set up next to Mr. Parker, there might have been the possibility that the Program could levy a charge of conducting business in a disorderly, hazardous, and improper manner against Mr. Parker - but City Attorney clarification might be required as to whether the Arts Commission had the authority to impose such a charge in this particular matter.

The Program Director posed a similar question which would require City Attorney clarification: While smoking a cigarette in an outdoor public place is not illegal, would the Commission have the authority to suspend or revoke a street artist's certificate if the artist's smoking was complained about, for health reasons, by an adjacent street artist?

Ms. Zhang stated that one day she set up 150 feet away from Street Artist Al Gamarra who was set up in space "HP-1"; after she used a fixative spray on one of her pastel portraits, Mr. Gamarra approached her and told her to refrain from continuing to do so because the spray is carried by the wind.

The Program Director stated that Ms. Zhang's complaint was reminiscent of an ongoing problem the street artists on Jefferson Street were having with unlicensed spraypaint artists

who do their work across the street from the street artists; when the artists and the Program staff complained, both the Environmental Protection Agency and the Health Department refrained from curbing the spraypainters because it was noted that the spraypainters were a good distance away from the street artists which mitigated the potential harm of the spraypaint fumes, regardless of the wind blowing the fumes across the street. The potent smell of the spraypaint had to be borne every day of summer by the street artists, some of whom stated repeatedly that it made them sick. Mr. Lazar recommended that Ms. Zhang and Mr. McLean contact the EPA and the Public Health Department: if either or both agencies determine that the odor of the incense is harmful, that would give the Arts Commission subject to the clarification of the City Attorney - the authority to suspend or revoke Mr. Parker's certificate for continued burning of the incense.

Mr. McLean asked whether the staff and commissioners were "missing out on your own mission to kind of support the arts" by not making Mr. Parker cease his activity. He went on to describe the photos of babies and children brought to Ms. Zhang from which to make portraits, as well as the on-spot portraits she makes of tourists. "By not being able to take an action, you're saying, okay, from the point of view of our management it's more important that we let this guy ... burn the incense than it is to add this resource ... that you can be proud of having ..."

Street Artist Abby Ellis stated that she has had life-threatening migraines, almost causing her death, "and incense is one of the things that triggers it." She suggested that a committee be established to arbitrate the situation between Ms. Zhang and Mr. Parker.

Commissioner Stermer stated that there is redress for this issue at the EPA. He went on to say that while the Commission was hearing one side of the argument, Mr. Parker could possibly say that he was just as good an artist as Ms. Zhang, "'I'm just as important to the Program as she is', ... and we get into this quality debate which I don't think we're allowed to do." The Commissioner also noted that street artists have the ability to move to other spaces.

Ms. Zhang stated that she has to sell at Hallidie Plaza, that if she were to move, she would lose "a lot of business." She asked Mr. Parker to please not burn the incense so that she could make money and pay her rent.

Commissioner Stermer suggested that Mr. McLean, advocating for Ms. Zhang, obtain a medical report to show the EPA as an issue of the burning of incense endangering the health of a particular person, to assist the EPA (or other similar agency) in determining whether the incense is hazardous.


Commissioner Stermer adjourned the meeting at 5:20 p.m.



This letter is to acknowledge the documents you dropped off regarding your warning issued on April 12, 2012.

On page 5 of the packet you submitted, you showed a photo of the pedestrian walkway between your booth and The Cannery. This photo also showed that there is a recess of the building next to where your display was located thus showing an 8 foot width between your display and the building. However, the Street Artists Ordinance states, "Street artists shall engage in their activities on the public sidewalks of the City and County of San Francisco in such a manner that at all times there shall remain open for the passage of pedestrians a space of at least 8 feet in width, as measured on a line perpendicular to the curb line, between the edge of the sidewalk farthest from the curb and the edge of the street artists' activities."

In our interpretation of the Ordinance, the sidewalk ends where the building line begins no matter if there is an entrance or recess of the building. The pedestrian thoroughfare or "the passage of pedestrians" is where the flow of pedestrian traffic occurs on the sidewalk, and we interpret this to mean a pedestrian flow parallel with the curb line. Therefore it would not include the recessed portion of the building. Thus your point is not justified.

Your warning issued on April 12, 2012 still stands. Please call the office if you would like to appeal your warning by requesting Program Director hearing. Please note that the Program Director hearing would be a public meeting and the Street Artists Program staff would invite Mr. Herbert Li along with any other witnesses. Please be aware that the Program Director decision can be appealed to the Street Artists Program Committee if you wish to do so.

Notice will offer artist an opportunity to have a public hearing with Program Director to discuss the charge. If artist agrees in writing to comply with Street Artists Ordinance, Program Director will recommend issuance of certificate or renewal. If artist does not agree in writing to comply with the ordinance, Program Director will recommend denial of certificate or renewal.

**Third Violation:** (when at least 1 of 3 of the incidents has been witnessed by Police or Program staff): "NOTICE OF WITHHOLDING OF CERTIFICATE OR RENEWAL PENDING HEARING" from Director of Cultural Affairs.\*

CHARGES OF SERIOUS VIOLATIONS OF THE STREET ARTIST ORDINANCE --includes violations of a violent or threatening nature and violations that significantly threaten integrity of Street Artists Program.

First Verifiable Violation: "NOTICE OF WITHHOLDING OF CERTIFICATE OR RENEWAL PENDING HEARING" from Director of Cultural Affairs.\*

\*Denials of certificates or renewals are governed by section 2408 of the Street Artists Ordinance. The Street Artists Program Committee will hold a public hearing on the certificate or renewal in accordance with Section 2408. A decision by the Committee and Program Director to deny certificate or renewal may be appealed to the Board of Appeals within 15 days, in accordance with section 2409 of the Street Artists Ordinance.

After I told Robert Chan about Gung arguing with his customers, Robert Chan went over there to see what happened. In about 5 to 10 minutes, Tang (945) went over there as well. They both were aware of the arguement between Gung and his customers.

Here is another fact I have to overturn Gung's fault statement. On Sat, Feb 11, I walked to Gung's booth only once. Gung's customers were already gone by the time I walked there. There were only three street artists, Chao Ju(3180), Yuan Gung (7330) himself, and me. If anyone witness what happened while I was at Gung's booth, there should be only one street artist Chao Ju(3180). I don't understand why here are other people signed the letter, no matter for what reason, or purpose, that person should provide enough evidence such as tape recording, video recording, or pictures to prove I disrupted Gung's business. Plus, when I was at Gung's booth, Gung was not conducting any business, it was my customer who followed me from my booth standing behind me.
