NARRATIVE

While working at Southern Station on 6/13/18, (R/V1) Lucinda Page came in to report suspicious activity.

Page stated that she had been selling hand made jewelry at Justin Herman Plaza located near the intersection of Market Street and Stuart Street since 2005. Page stated that in 2007, (S1) Jeffery Potter started selling T-shirts in the same plaza. Page noticed that in 2013, Potter started selling jewelry that was similar to Page's design. Page stated that around 2013, Potter also started taking pictures of her. Page was insistent that Potter was taking pictures of her, especially of her back side, while she is working at her table. Potter had never made any direct threats to Page, yet Page stated that she feels unsafe. Page was able to write a (E1) statement about these incidents, which I booked at evidence at Southern Station.
