PROCESS

Round One:

Arts Commission staff presented the qualifications of 39 artists from the 2018 Bayview Artist Registry and other prequalified pools for two Southeast Community Center Outdoor Sculpture Public art opportunities. "Yes/No" majority votes based on the criteria of Artistic Excellence, Appropriate to Project Goals, and Meaningful Connection to the Bayview yielded 18 artists to move to Round Two.

Round Two:

The Artist Selection Panel reviewed the qualifications of 18 artists selected from the previous round. "Yes/No" majority votes based on the criteria of Artistic Excellence, Appropriateness to the Site, and Meaningful Connection to the Bayview yielded 8 artists to be considered for the Southeast Community Center Plaza Sculpture Public Art opportunity and move to Round Three.

Round Three:

The Artist Selection Panel discussed the qualifications of 8 semi-finalists and scored each artist on the following criteria (1= low score):

- Artistic Excellence (1-10)
- Appropriate to Project Goals (1-5)
- Meaningful connection to Bayview (1-5)

Round Three voting yielded four finalists to recommend to the Arts Commission.

Round Four:

The Artist Selection Panel reviewed the qualifications of 13 artists from the two previous rounds. "Yes/No" majority votes based on the criteria of Artistic Excellence, Appropriateness to the Site, and Meaningful Connection to the Bayview yielded 7 artists to be considered for the Southeast Community Center Gardens Sculpture Public Art opportunity and move to Round Five.

Round Five:

The Artist Selection Panel discussed the qualifications of 7 semi-finalists and scored each artist on the following criteria (1= low score):

- Artistic Excellence (1-10)
- Appropriate to Project Goals (1-5)
- Meaningful connection to Bayview (1-5)

Round Five voting yielded four finalists to recommend to the Arts Commission.
