The proposed Public Restroom facility will serve the Waterfront Plaza and intermodal transportation hub and will be located south of the Ferry Shelter and Bus/Shuttle Shelters. The building will include two group Restrooms (Men's and Women's facilities), an All-Gender Restroom, and a janitor's support space and utility closet to serve the Waterfront Plaza and facility electrical needs. The design strategy is a direct response to the Waterfront Plaza landscape architecture, and Ferry Shelter aesthetic and material palette.

The proposed Public Restroom structures acknowledge the primary importance of the Ferry Shelter in the overall composition at the water's edge, and adopt a related, though distinctly different design approach by positioning themselves as sculptural forms in the landscape of the waterfront, rather than participants in the Waterfront Plaza's symmetrical civic composition. Therefore, they are abstract and minimal in their articulation. Anodized aluminum monolithic panels wrap the volumes in a smooth surface that reflects the daylight, and the images of the surrounding landscape forms, the bay and sky above. The design intent is to capture the environment in its many atmospheric conditions over the course of the day through reflections on the surface of the panels and to dematerialize the buildings in deference to the landscape character of the site and the hierarchy of the Ferry Shelter.

As one passes between the two structures, the space opens up to views of Yerba Buena Island looking south or the Ferry Shelter looking north. The interior faces of the structures incline inward toward the restroom entrances, and the cladding material transitions to channel glass to give a preview of the interior space. This strategy both helps lead visitors into those spaces and additionally, retains a completely opaque exterior condition in consideration of the nighttime view from the causeway as one enters the island (and LEED ND requirements).

At night, the zone between the structures will glow softly through the channel glass surfaces, providing a safe and secure atmosphere for visitors and island residents. The restrooms are naturally ventilated through louvers on the exterior walls and entrance doors to create cross ventilation, which will exit through passive roof ventilation units, hidden from view by the building parapets. Solar panel-assisted roof skylights provide additional daylighting and ventilation when open to the restroom interiors. Full height white ceramic tile at all interior wall surfaces will help maximize the effects of daylighting, reducing the need for artificial lighting during the day.
